#### Article 1

In the Law on the Transfer of Cases from the ICTY to the Prosecutor's Office Of Bosnia and Herzegovina and the Use of Evidence Collected by ICTY in Proceedings Before the Courts in Bosnia and Herzegovina ("Official Gazette of Bosnia and Herzegovina" No. 61/04), Article 8 shall be amended to read:

#### "Article 8

#### **Documents and Forensic Evidence Collected by ICTY**

(1) Original documents, certified copies, certified electronic copies as well as copies confirmed to be unaltered from the original and forensic evidence collected by the ICTY shall be used by the courts and shall be treated as if they were obtained by national authorities.

(2) Confirming, i.e. certifying the electronic copies, for the purpose of the paragraph (1) of this Article, can be done together for several documents or for several pages of one document and it can be done in electronic form.

(3) Certifying and confirming for the purpose of paragraphs (1) and (2) of this Article shall be done by the ICTY."

#### Article 2

This Law shall enter into force one day after its promulgation in the "Official Gazette of Bosnia and Herzegovina".
