CORRIGENDA OF THE LAW ON AMENDMENTS TO THE LAW ON TRAVEL DOCUMENTS OF BOSNIA AND HERZEGOVINA

NOTE: The Law on Travel Documents of Bosnia and Herzegovina was published in the "Official Gazette of Bosnia and Herzegovina", 4/97.

NOTE: The Law on Changes and Amendments of the Law on Travel Documents of Bosnia and Herzegovina ("Official Gazette of Bosnia and Herzegovina", 33/08).

After comparison was made with the original text, it is noted that the Law on Amendments to the Law on Travel Documents of Bosnia and Herzegovina, published in the "Official Gazette of Bosnia and Herzegovina", no. 33/08 of 22 April 2008, contained the following formerly unnoticed printing errors in the Bosnian, Croat and Serb languages, so in accordance with Article 136, paragraph (2) of the Rules of Procedure of the House of Representatives of the Parliamentary Assembly of Bosnia and Herzegovina ("Official Gazette of Bosnia and Herzegovina", no. 33/06, 41/06, 81/06 and 91/07) and Article 130, paragraph (2) of the Rules of Procedure of the House of the Parliamentary Assembly of Bosnia and Herzegovina ("Official Gazette of Bosnia and Herzegovina", no. 33/06, 41/06, 81/06 and 91/07) and Article 130, paragraph (2) of the Rules of Procedure of the House of Peoples of the Parliamentary Assembly of Bosnia and Herzegovina ("Official Gazette of Bosnia and Herzegovina", no. 33/06, 41/06, 81/06 and 91/07) in regard of which we now accordingly provide the following

CORRIGENDA

OF THE LAW ON AMENDMENTS TO THE LAW ON TRAVEL DOCUMENTS OF BOSNIA AND HERZEGOVINA

In Article 22, second sentence that reads: "The Law shall start to be applied upon acquirement of technical conditions, which shall be defined by a separate act of the Ministry of Civil Affairs of BiH.", shall be deleted.

In the same Article, new paragraph 2 shall be added to read as follows: "Provisions of Article 7 all start to be applied upon acquirement of technical conditions, which shall be defined by a separate act of the Ministry of Civil Affairs of BiH."
