CHANGES AND AMENDMENTS TO THE RULES OF PROCEDURE OF THE HOUSE OF PEOPLES OF THE PARLIAMENTARY ASSEMBLY OF BOSNIA AND HERZEGOVINA

“Official Gazette of Bosnia and Herzegovina”, 96/15

Pursuant to Article IV/3b) of the Constitution of Bosnia and Herzegovina, at the 12th session held on 10 December 2015, the House of Peoples of the Parliamentary Assembly of Bosnia and Herzegovina adopted the following

CHANGES AND AMENDMENTS TO THE RULES OF PROCEDURE OF THE HOUSE OF PEOPLES OF THE PARLIAMENTARY ASSEMBLY OF BOSNIA AND HERZEGOVINA

Article 1

In the Rules of Procedure of the House of Peoples of the Parliamentary Assembly of Bosnia and Herzegovina (“Official Gazette of BiH”, Nos 58/14 and 88/15), in Article 21, in paragraph (5), after item c), a new item d) shall be added to read as follows:

“d) in accordance with Article 25, paragraph (2) of the Code of Conduct, considering the appeals filed by the delegates against the decisions of the Joint Committee for Human Rights, by way of which a measure has been imposed concerning a violation of the Code of Conduct;”

The current items d), e), f) and g) shall now become the items e), f), g) and h).

Article 2

In Article 53 (Joint Committee on Administrative Affairs), in paragraph (1), item l) shall be deleted.

Article 3

In Article 54 (Joint Committee for Human Rights), in paragraph (1), item v) shall be amended to read as follows:

“v) preparation and determination of the proposed Code of Conduct, and at least once a year the delivery to the Parliamentary Assembly of Bosnia and Herzegovina for consideration and evaluation of the report of the Joint Committee concerning the matters of implementation of the Code of Conduct.”

After item v), a new item z) shall be added to read as follows:

“z) conducting the procedure for establishment of a violation of the Code of Conduct, and taking of the relevant decision as provided by the Code of Conduct.”

Article 4
(Entry into force)

These changes and amendments to the Rules of Procedure of the House of Peoples of the Parliamentary Assembly of Bosnia and Herzegovina shall enter into force one day after the date of its publication in “the Official Gazette of Bosnia and Herzegovina”.
