LAW ON AMENDMENTS TO THE LAW ON CIVIL SERVICE IN THE FEDERATION OF BOSNIA AND HERZEGOVINA

Article 1

In the Law on Civil Service in the Federation of Bosnia and Herzegovina (“Official Gazette of the Federation of Bosnia and Herzegovina”, 29/03, 23/04, 39/04, 54/04, 67/05 and 8/06), in Article 1, paragraph 1, the words: “cantons, cities and municipalities” shall be deleted.

Article 2

In Article 2, paragraph 1, words: “cantons, cities and municipalities” shall be deleted.
In Article 2, paragraph 2, in the third line, the words: “with the exception of civil service authorities of those municipalities certain parts of which were, according the Dayton Agreement and the decisions of the High Representative, awarded to the other entity or other municipality” shall be deleted.

Article 3

In Article 6, paragraph 1, subparagraph a), line 5), the words: “Federation and Main Cantonal” shall be deleted.

Article 4

In Article 7, paragraph 2, the words: “or cantonal government” shall be deleted.

Article 5

In Article 9, paragraph 2, the words: “or minister and cantonal government” shall be deleted.

Article 6

In Article 11, paragraph 1, the words: “and Main Cantonal” and the words: “cantonal laws” shall be deleted.

Article 7

In Article 25, paragraph 1, item c) in the end of text, after the word: “qualifications” the words: “i.e. high education of the first, second or third cycle of the Bologna system of studying, which shall be established by a regulation regulating the jobs of basic activities and support and technical jobs and the requirement for their carrying out in the bodies of the civil service in the Federation of Bosnia and Herzegovina” shall be added.

Article 8

In Article 31, paragraph 2 shall be deleted.

Article 9

The title of the Chapter Salaries and Allowances shall be deleted.
Articles 38 through 46 shall be deleted.

Article 10

In Article 52, paragraphs 2 and 3 shall be deleted.
Current paragraph 4 shall become paragraph 2.

Article 11

After the Article 66, new Article 66a shall be added to read:

“Article 66a

A technical or administrative staff member of a body of civil service who has acquired the VII degree of professional qualifications or high education of the first, second or third cycle of the Bologna system of studying, and who has at least five years of working experience in the bodies of civil service after passing the professional exam for the technical or administrative staff member in bodies of civil service, may apply for a vacancy of a specialist without obligation to complete a traineeship.”

Article 12

In Article 72, paragraph 1, the words: “or the cantonal governments” shall be deleted.

Article 13

In Article 74, the words: “cantons, cities and municipalities” shall be deleted.

Article 14

Regulations that are contrary to the provisions of this Law shall be harmonized to this law within 30 days from the day this law enters into force.

Article 15

After the Article 74, new Article 74a shall be added to read:

“Article 74a

The provisions of this Law may be applied in the cantons in accordance with the cantonal laws.”

Article 16

This Law shall enter into force on the day following the day of its promulgation in the “Official Gazette of the Federation of Bosnia and Herzegovina”
