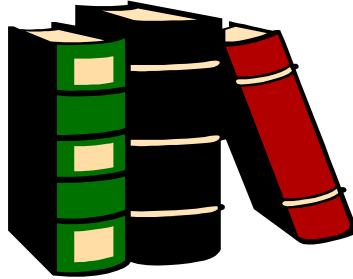

Pursuant to Article IV.B.7. a)(IV) of the Constitution of the Federation of Bosnia and Herzegovina, I hereby enact the following

**DECREE  
TO PROMULGATE THE LAW ON AMENDMENTS TO THE LAW ON THE  
BUDGETS IN THE FEDERATION OF BOSNIA AND HERZEGOVINA**

This is to promulgate the Law on Amendments to the Law on the Budgets in the Federation of Bosnia and Herzegovina, adopted by the Parliament of the Federation of BiH at the session of the House of Representatives of 28 January 2014, and at the session of the House of Peoples of 06 February 2014.

**LAW ON THE AMENDMENTS TO THE LAW ON THE  
BUDGETS IN THE FEDERATION OF BOSNIA AND  
HERZEGOVINA**

**Article 1**

After Article 35 of the Law on the Budgets in the Federation of Bosnia and Herzegovina (“Official Gazette of the Federation of BiH” nos. 102/13 and 9/14), new Article 35a shall be added to read:

**“Article 35a**

Exceptionally and exclusively for securing the financing of the City of Mostar for year 2014, the Decision on Temporary Financing of the City of Mostar for the period from 1 January to 31 march 2014 shall be made by the Mayor of the City of Mostar with consent of the Head for Finances of the City of Mostar.”.

**Article 2**

After Article 105 of the Law on the Budgets in the Federation of Bosnia and Herzegovina (“Official Gazette of the Federation of BiH” nos. 102/13 and 9/14), new

Article 105a shall be added to read:

**“Article 105a**

Exceptionally and exclusively for securing the financing of the City of Mostar for year 2014, the Mayor of the City of Mostar, with consent of the Head for Finances of the City of Mostar, shall make the Budget of the City of Mostar and Decision on Execution of the Budget for the Year 2014 and shall be responsible for its implementation.”.

**Article 3**

This Law shall come into force the day after it is published in the “Official Gazette of the Federation of BiH”.
