DECREE AMENDING THE DECREE ON THE PROCEDURE OF VERIFICATION OF CLAIMS AND CASH PAYMENTS ARISING FROM FROZEN FOREIGN CURRENCY ACCOUNTS IN REPUBLIKA SRPSKA

On the basis of Article 15, paragraph g), Article 43, paragraph 2 of the Law on Government of Republika Srpska (“Official Gazette of Republika Srpska”, 118/08) and Article 26 of the Law on Settlement of Liabilities for Frozen Foreign Currency Account (“Official Gazette of Bosnia and Herzegovina”, 28/06, 76/06, 72/07 and 97/11), the Government of Republika Srpska, on its session held on 22 November 2012, passed the

DECREE
AMENDING THE DECREE ON THE PROCEDURE OF
VERIFICATION OF CLAIMS AND CASH PAYMENTS

ACCOUNTS IN REPUBLIKA SRPSKA

Article 1

In the Decree on the Procedure of Verification of Claims and Cash Payments Arising from Frozen Foreign Currency Accounts in the Republika Srpska (“RS Official Gazette” nos. 102/06, 124/06, 17/07, 62/07, 105/07, 18/08, 20/09, 21/10 and 93/11), in Article 16, after the paragraph 9, new paragraphs 10 and 11 shall be added to read:

“(10) Notwithstanding the paragraphs 1, 2, 4, 6 and 8 of this Article, claimants who did not file their requests for verification of the frozen foreign currency savings accounts may file the request from 10 December 2012 until 30 September 2013, and the Agency shall be bound to complete the processing of received requests until 31 January 2014 at the latest.

(11) Filing requests, their processing and their realization in the procedure of verification of the frozen foreign currency savings accounts, in conjunction with deadline referred to in paragraph (10) of this Article, shall be executed in the same manner and under the same procedures which the Decree prescribes.”

Article 2

In Article 19, after the paragraph 13, new paragraphs 14 and 15 shall be added to read:

“(14) Cash payments upon the requests for verification referred to in Article 16, paragraph 10 of this Decree shall be executed in the maximum amount of KM 2,000 or in total amount of KM 2,000.

(15) Cash payments referred to in Article 14 of this Article shall be executed after the completion of the verification.”

Article 3

In Article 21, words: “Paragraphs 3, 7, 8, 10 and 12” shall be replaced with words: “Paragraphs 3, 7, 8, 10, 12 and 14.”

Article 4

This Decree shall enter into force on the eight day following its publication in the “Official Gazette of Republika Srpska.”
