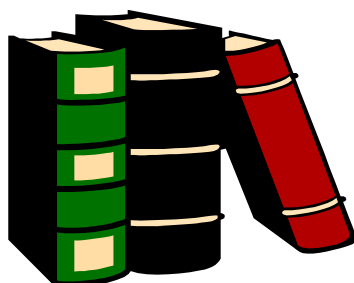

# LAW MAKING A CHANGE AND AN AMENDMENT TO THE LAW ON MINISTRIES AND OTHER BODIES OF ADMINISTRATION OF BOSNIA AND HERZEGOVINA

Pursuant to Article IV4.a) of the Constitution of Bosnia and Herzegovina, at the 24<sup>th</sup> session of the House of Representatives held on 3 February 2016, and at the 15<sup>th</sup> session of the House of Peoples held on 2 March 2016, the Parliamentary Assembly of Bosnia and Herzegovina adopted the following

**MAKING A CHANGE AND AN AMENDMENT TO THE LAW**

**OF BOSNIA AND HERZEGOVINA**

**Article 1**

In the Law on Ministries and Other Bodies of Administration of Bosnia and Herzegovina (“Official Gazette of Bosnia and Herzegovina”, Nos. 5/03, 42/03, 26/04 , 42/04 , 45/06, 88/07, 35/09, 59/09, 103/09, 87/12 & 6/13), in Article 11, in paragraph (1), following the line 15, a new line 16 shall be added to read as follows:

“- Financial planning of development in the institutions of Bosnia and Herzegovina including the public investment management and medium-term planning, monitoring and reporting.“

**Article 2**

Article 23 shall be amended to read as follows:

“The Council of Ministers of Bosnia and Herzegovina shall adopt the Medium-Term Activity Programme, which shall be the basis for preparation of the Framework Budget Document for a three-year period and the medium-term activity plans for the institutions of Bosnia and Herzegovina.

The bodies of administration of Bosnia and Herzegovina shall be obligated to adopt their Medium-Term Activity Plans and their Annual Activity Programmes based on the Medium-Term Activity Programme adopted by the Council of Ministers of Bosnia and Herzegovina.

The Medium-Term Activity Plans of the institutions of Bosnia and Herzegovina shall be adopted by the Heads of the relevant bodies of administration. Should the plans contain the financial obligations or requirements, a prior opinion shall be required to be obtained from the Ministry of Finance and Treasury of Bosnia and Herzegovina.

The procedure of medium-term planning, monitoring and reporting in the institutions of Bosnia and Herzegovina shall be prescribed by the Council of Ministers of Bosnia and Herzegovina at the proposal of the Ministry of Finance and Treasury of Bosnia and Herzegovina.”

### Article 3

This Law shall enter into force on the eight day following the date of its publication in the “Official Gazette of Bosnia and Herzegovina”.
