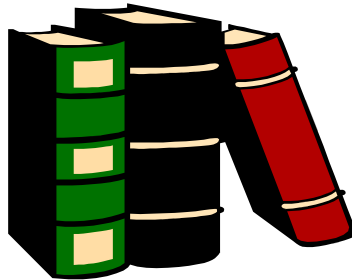

# **LAW MAKING A CHANGE AND AN AMENDMENT TO THE LAW ON MINISTRIES AND OTHER BODIES OF ADMINISTRATION OF BOSNIA AND HERZEGOVINA**

**PARLIAMENTARY ASSEMBLY OF BOSNIA AND HERZEGOVINA**

Pursuant to Article IV/4.a) of the Constitution of Bosnia and Herzegovina, at the 52<sup>nd</sup> session of the House of Representatives held on 20 September 2017, and at the 33<sup>rd</sup> session of the House of Peoples held on 8 November 2017, the Parliamentary Assembly of Bosnia and Herzegovina adopted the following

**LAW**  
**MAKING A CHANGE AND AN AMENDMENT TO THE LAW ON**  
**MINISTRIES AND OTHER BODIES OF ADMINISTRATION OF BOSNIA**  
**AND HERZEGOVINA**

**Article 1**

In the Law on Ministries and Other Bodies of Administration of Bosnia and Herzegovina ("Official Gazette of Bosnia and Herzegovina", Nos. 5/03, 42/03, 26/04, 42/04, 45/06, 88/07, 35/09, 59/09, 103/09, 87/12, 6/13 & 19/16), in Article 13, under paragraph (1), after Indent 4, a new Indent 5 shall be added to read as follows:

*"- providing free legal aid in accordance with the provisions of the Law on Providing Free Legal Aid ("Official Gazette of Bosnia and Herzegovina", No. 83/16)."*

Under Indent 9, at the end of the text, instead the semi-colon punctuation mark (;), a comma punctuation mark (,) and the following wording shall be added to read as follows;

*"including also the tasks of inspection supervision over the implementation of a Law relating to the work of citizens' associations and foundations registered on the level of Bosnia and Herzegovina with regard to the following matters: reporting of the changes and amendments of the statute, objectives and activities, names, addresses of seats, persons authorized as representatives and dissolution of associations or foundations, the use in legal transactions of the data not entered into the Register of Associations and Foundations, the use of the name under which an association or foundation is registered in the Register, holding of the assembly sessions of an association or of the governing board sessions of a foundation, delivery of financial reports in accordance with law, keeping of the membership list of an association and the dissolution or termination of operations of an association or foundation."*

The current indents 5 through 11 shall now become the new indents 6 through 12.

**Article 2**

In Article 17, under paragraph (1), the current sub-paragraph 9 shall be deleted.

In Article 17, under paragraph (1), the current indents 10 through 26 shall now become the new indents 9 through 25.

### **Article 3**

This Law shall enter into force on the eighth day following the date of its publication in the “Official Gazette of Bosnia and Herzegovina”.
