Meeting results in an agreement on formation of Investigation Commission, joint patrols and instruction on cooperation from local authorities.

RS President Plavsic releases statement agreeing to accept pre-war Bosniac residents wishing to resettle in the Gajevi area Federation Partners sign Military Accord appointing Commander and Joint Command of the BiH Federal Army. Head of Joint Command is Bosniac General Rasim Delic. Croat General Budimir is Joint Command Deputy and Chief of Staff

1. Violent clashes between about 500 Bosniacs attempting to visit graves on second day of Bairam and some 700 Croats in Mostar. Rash of evictions (at least 26) occur in west Mostar during the night. Urgent high level meetings initiated by HR, Carl Bildt and Principal Deputy HR, Michael Steiner, result in agreement on a package of measures including imposition of a curfew, patrolling by IPTF and SFOR, arrangement on immediate investigation by IPTF and removal from office and trial of anyone found

to involved.

2. Carl Bildt releases a statement condemning in the strongest possible terms the indiscriminate killing in Mostar

1. Extraordinary Joint Military Commission in view of forthcoming Brcko decision and Mostar situation agrees on measures to deal with potential military threats including a ban on military training and exercises.
2. Media Projects Coordination meeting at OHR, Sarajevo

### **12 February**

Meeting of senior Bosnian and Croat politicians in Sarajevo to discuss the 10 February incident in Mostar. Principal Deputy HR, Michael Steiner chairs the meeting which condemns violence in Mostar. Participants agree twelve measure package to stabilise the situation

### **14 February**

Roberts Owen, Chief Arbitrator, announces conclusions of Arbitral Tribunal for the dispute over the Inter-Entity Boundary in the Brcko area. Announces interim international supervision of the Dayton implementation in the Brcko area for not less than one year. OHR to establish office in Brcko under leadership of Supervisor and Deputy High Representative for Brcko. Minister of Interior for the Federation, Mehmed Zilic, announces abolition of 11p.m. to 5 a.m. curfew in Federation territory, except in Mostar where the 9 p.m. to 6 a.m. curfew remains in force until tensions calm down.

About 150 Serb civilians set fire to prefabricated houses built for returning Bosniac refugees in Gajevi. The incident is preceded by a number of tit-for-tat events

## **3 March**

Principal Deputy HR, Michael Steiner, SRSG, Kai Eide, and Acting IPTF Commissioner, Robert Wasserman, meet with RS President Plavsic to discuss the 2 March incident in Gajevi

## **4 March**

1. 2nd session of the Federation Forum on a working level, Sarajevo
2. SFOR lifts training ban imposed on 11 February for the period leading up to the Brcko arbitration decision
3. St. Joseph's Catholic church in Sarajevo damaged by explosive device
4. Chairman of the Presidency, Alija Izetbegovic, demands increase in protection of all Catholic facilities in the country
5. New IPTF Commissioner, Manfred Seitner, formally takes up his duties

## **5 March**

1. HR Carl Bildt, sends letter to FRY Foreign Minister Milutinovic seeking assurances that FRY will not submit the Special Agreement for ratification by the FRY Federal Assembly before ratification by the BiH Parliament
2. Ministry of Internal Affairs of the Herzegovina-Neretva Canton announces there were well founded suspicions concerning the responsibility of the commanding officers of the Mostar police department with regard to the 10 February incident. Based on this, the Cantonal Interior Minister, Valentin Coric, suspends the the police station Commander, Marko Radic, his deputy, Ivan Hrkac and two other police officers, Zeljko Planinic and Bozo Peric, until completion of the investigation

1. Chairman-in-Office of the OSCE, Danish Foreign Minister Niels Helveg Petersen announces postponement of the BiH municipal elections until 13-14 September 1997
2. HR Carl Bildt welcomes the postponement of the municipal elections stressing the importance of preparations to ensure quality elections

2. US diplomat Bill Farrand is named Deputy High Representative and Supervisor for Brcko

## **10 March**

1. 16th session of the BiH Presidency, Sarajevo
2. Trial of three indicted war criminals, Bosniacs (Hazim Delic, Esad Landzo and Zejnil Delalic) and a Bosnian Croat (Zdravko Mucic) begins in the Hague

World Bank delegation, led by Country Director for BiH, Christine Wallich, visits BiH to begin discussions on the "Country Assistance Strategy"

## **11 March**

1. Council of Ministers hold extraordinary session to continue work on QSP laws Media Projects Donor Coordination Group, Sarajevo
2. About 30 Bosnian Serbs burn down the remaining prefabricated houses in Gajevi
3. Media Experts Commission express deep concern with regard to recent attacks on journalists – urge support and respect for journalists country-wide

1. Principal Deputy HR, Michael Steiner visits Slavonski Brod and Bosanska Posavina refugee community
2. SRSK Kai Eide meets with RS President Plasic in Banja Luka. UN considers making its own investigation into the Gajevi arson attacks

2. HR Carl Bildt writes to Council of Ministers warning that further postponements of the Donor's Conference could have severe financial repercussions for the country

4. UN IPTF Commissioner Manfred Seitner informs RS that IPTF will launch its own investigation into the recent arson attacks in Gajevi

1. Head of OHR in Mostar, Sir Martin Garrod, and Head of the OSCE Mostar Regional Centre, Edward Joseph, walk out of an aluminium factory opening ceremony following insulting remarks made against former EU Administrator, Hans Koschnick, by the General Director of the aluminium plant, Mijo Brajkovic
2. Principal Deputy HR, Michael Steiner, writes to Franjo Tudjman expressing grave concern over Brajkovic's insults
3. An explosive device badly damages a mosque in Stipanici
4. Federation President Kresimir Zubak issues a press release deploring the destruction of the mosque
5. HR Carl Bildt releases statement urging governments of Europe to deal with the instability in Albania

1. 5th session of the RS National Assembly, Jahorina – Agreement on Special Parallel Relations with FRY is ratified without Article 14 [which stipulates ratification by the BiH Parliament]

2. HR Carl Bildt calls upon the EU to support the requirement that the RS/FRY Agreement be brought into line with the constitution of BiH and to advise Belgrade accordingly

Serbian Parliament endorses the RS/FRY Agreement at their session and urges the Federal Parliament to ratify the accord.

HR Carl Bildt issues a response to the 20 March decision by the Parliamentary Assembly of FRY to ratify the RS/FRY Agreement on Special Parallel Relations making clear that the Agreement is not consistent with the Peace Agreement or the Constitution of BiH

OSCE hosts its second Inter-Entity journalist conference “Media in a Conflict Environment” in Mostar

UN Special Rapporteur for Human Rights, Elizabeth Rehn, visits BiH – joint visits with the Federation Ombudsmen to Mostar, Stolac and Capljina

ICRC announces entry into the third phase of its campaign to find missing persons

1. UN IPTF and the Human Rights Coordination Centre release a report on the events preceding and following the 10 February shooting incident in Mostar
2. Principal Deputy HR sends letter to Federation President Vladimir Soljic, and Vice President Ejup Ganic pointing out that neither the political authorities nor the police of Mostar had reacted appropriately – the letter outlines five concrete steps to be taken urgently
3. Ambassador Steiner also writes to Federation President Soljic and Vice President Ganic to express concern about seriously flawed 20 March trial of five policemen in west Mostar – three of whom were identified in the IPTF report
4. Commission for the Implementation of the Sarajevo Protocol meet – agreement of all representatives on proposed texts

2. UNHCR Sadako Ogato announces that her office will provide assistance only to those municipalities and regions which accept minority returns – and will withdraw aid from areas where such returns are refused

1. Buses carrying delegation from Social Democratic Party, led by Zlatko Lagumdžija, visiting OHR North are stoned by hostile crowd in Brčko
2. Deputy HR for Brčko, Bill Farrand, and others roundly condemn stoning

He specifically pointed out the “continual instances of deliberate misinformation , inflammatory commentary, insulting language and highly biased reportage.”
