Oric sentenced to 2 years in prison	<b>TV Hayat, TV Pink, BHT1, FTV, RTRS, Glas Srpske</b> cover pg report 'Two years of imprisonment' by <a href="#">Srna</a> , <b>Dnevni List</b> pg 2, announced on cover 'Oric set free' by <a href="#">V. Soldo</a> , <b>Oslobodjenje</b> cover pg splash and pgs 4-5 'Two years of imprisonment for Oric' by <a href="#">A. Omeragic</a> , <b>Dnevni Avaz</b> cover pg splash and pg 3 'Naser Oric at large as of yesterday' by <a href="#">A. Hadzic</a> , <b>Nezavisne novine</b> cover pg splash and pg 3 'Naser Oric at large' by <a href="#">Beta</a> - Wartime commander in Srebrenica, <b>Naser Oric</b> , has been sentenced to 2 years of prison by ICTY because he failed to prevent the murders and tortures of captured Serbs from December 1992 until March 1993. According to ICTY, Oric as the Commander had mechanisms to get informed on the situation and prevent the murders. Since Oric spent 3 years in detention (he was arrested in 2003), ICTY ordered his immediate release as soon as the complete procedure is finished. <b>FTV, Oslobodjenje</b> pgs 4-5 'Naser Oric with his family in Sarajevo today' by <a href="#">A. ICTY Prosecution surprised with too mild sentence to Oric	<b>Oslobodjenje</b> cover pg splash and pgs 4-5 'Two years of imprisonment for Oric' by <a href="#">A. Omeragic</a> Inset 'Mild punishment for serious crimes' - ICTY Spokesperson <b>Antun Nikiforov</b> stated the Prosecution was surprised with such a mild verdict in <b>Naser Oric's</b> case since they have requested an imprisonment sentence in duration of 18 years. He added Chief ICTY Prosecutor <b>Carla del Ponte</b> would analyse the verdict and decide whether they would file a complaint on the verdict.

Reactions on Oric's sentence: RS Association of Families of Missing Persons says ICTY humiliated victims, Mothers of Srebrenica say Oric is a victim	<b>BHT1</b> <u>Suzana Stambol, Hatka Hamidovic</u> – <b>Naser Oric</b> is expected to arrive to Sarajevo on Saturday afternoon. Reactions to his sentence are very different. Featured dwellers of villages around Srebrenica are disappointed, claiming that Oric's troops have destroyed all houses in the Serb villages. <b>Milijana Bojic</b> from RS Association of families of missing persons stated that ICTY has once again showed that it doesn't care for truth and justice, stressing that the Tribunal has once again humiliated the Serb victims. Commenting the sentence, former Commander of 2 <sup>nd</sup> Corps of RBiH Army <b>Sead Delic</b> stated that Oric couldn't have controlled single cases of war crimes committed against Serbs, stressing that the Bosniaks were fighting to survive. <b>BHT1, Oslobodjenje</b> pgs 4-5 'Naser Oric with his family in Sarajevo today' by <b>A. Avdic</b> – <b>Hatidza Mehmedovic</b> from Association "Mothers of Srebrenica" also feels disappointed by the sentence. <i>"I've never heard of any case where a victim was sentenced before a criminal, and Oric was a victim"</i> , said Mehmedovic. <b>TV Hayat</b> – Head of the Association of Mothers from Srebrenica and Zepa <b>Sabaheta Fejzic</b> condemned the sentence stressing that in this way all victims of the genocide in Srebrenica have been sentenced.
RS Associations and officials condemn sentence, believe it is too mild and humiliating Serb people	<b>RTRS</b> – Chair of RS Veterans Organisation <b>Pantelija Curguz</b> stated that this sentence could be brought in connection with latest events directed against RS and Serb people. Deputy Chair of RS Prisoners of War Association <b>Slavko Jovicic</b> says that the sentence is yet another farce of the court. Chair of Zvornik Veteran's organisation <b>Dragan Milosevic</b> also stated that the sentence is humiliating for Serb people. RS Prime Minister <b>Milorad Dodik</b> stated that the sentence is disappointing. <i>"Oric undoubtedly has responsibility for many murders and that is why this sentence is disappointing and not in the function of what is the main intention of ICTY"</i> , says Dodik. Attorney <b>Krstan Simic</b> says that sentence is shocking and strange.
BiH Presidency Chair Tihic: yet another confirmation of truth on events in Srebrenica	<b>Dnevni Avaz</b> cover pg splash and pg 3 'Naser Oric at large as of yesterday' by <b>A. Hadzic</b> Inset 'Tihic's reaction' – BiH Presidency Chair <b>Sulejman Tihic</b> said on Friday that The Hague Tribunal's verdict in the case against <b>Naser Oric</b> is yet another confirmation of the truth about the events in Srebrenica. <i>"Now it is clear who defended the unarmed people and who committed crimes"</i> , Tihic stated.
SIPA arrested 2 war crimes suspects in Sarajevo	<b>TV Pink, BHT1, TV Hayat, FTV, RTRS, Vecernji List</b> pg 2 'SIPA: two persons arrested over genocide' by <b>vr, Oslobodjenje</b> pg 3 'Two persons suspected of having committed genocide arrested' <u>not signed</u> , <b>Dnevni Avaz</b> pg 12 'Zdravko Bozic and Goran Bencun, genocide suspects, arrested' by <b>E. Sarac, Nezavisne novine</b> pg 3 'Suspected for genocide in Srebrenica' by <b>A. Djozo</b> – BiH Prosecution stated that the US authorities have extradited two persons and handed them over to the BiH authorities. The extradited persons are <b>Zdravko B.</b> and <b>Goran B.</b> who are suspected of participating in genocide against Bosniaks in Srebrenica in 1995. According to unofficial information, the two men were deported from USA, arrested by SIPA at the Sarajevo Airport and transferred to BiH Prosecutor's Office custody.

R., Dnevni Avaz</b> pg 2 'More than a year will be needed to reveal truth' by <b>Fena, Nezavisne Novine</b> pg 4 'Sarajevo Commission started working' by <b>N. Krsman</b> – BiH Commission for investigation of suffering of Serbs, Croats, Bosniaks, Jews and Other citizens in Sarajevo during 1992-1995 held its first session on Friday. Chair of the Commission <b>Ivica Marinovic</b> stated that principles by which the Commission will work were discussed at the first session. He added that the next session will be held on the following Thursday when the Commission agenda would be adopted. He also stated that a year deadline might not be enough for the Commission to determine the truth on events that took place in Sarajevo during the war period. <b>RTRS, FTV</b> – Marinovic stressed that the Commission does not have a budget and added that this issue needs to be resolved with help of Council of Ministers. <b>RTRS</b> – Chair of Association of missing and imprisoned civilians from eastern Sarajevo <b>Mirjana Simanic</b> stated that they are disappointed that the Commission is dealing with trivial administrative issues. She also expressed her disappointment that <b>Amor Masovic</b> remained the member of the Commission.

Booklet presented explaining all legal issues regarding missing person's issues	<b>RTRS</b> Report by <u>Branka Kusmuk</u> – BiH Ministry of Human Rights and Refugees, Red Cross and ICMP made a booklet explaining all legal issues regarding missing person's issues. Booklet provides basic legal definitions from that area as well as responses to procedure and status issues. Members of Associations of missing person's families on the other hand claim that this document is unnecessary. They stress that all they want is to know the faith of their loved ones as well as the exact information on the number of missing persons in BiH. Head of Red Cross office in BiH <b>Marianne Gasser</b> stressed that according to Red Cross information 13,300 persons are still missing in BiH. Coordinator of group for implementation of law on missing persons <b>Saliha Djuderija</b> stated that according to available information there are approximately 14,000 missing persons. She explained that information from all relevant institutions is still being compiled thus explaining the lack of final data. <b>TV Pink, BHT1, Dnevni List</b> pg 8 'Search for approximately 14.000 persons still ongoing' by <u>D. McElhaney visits Srebrenica	<b>BHT1, RTRS</b> – US Ambassador to BiH <b>Douglas McElhaney</b> visited Srebrenica and Potocari Memorial Centre on Friday. He said that a complete truth about Srebrenica needs to be revealed. <b>FTV</b> – Ambassador McElhaney met with women of Srebrenica. McElhaney stated that people need fast changes and chances of a better future. He stressed that the US Government is determined to continue providing help and assistance to BiH citizens in the future. McElhaney opened that new centre for assistance to citizens in Srebrenica Municipality building and the reconstructed kindergarten in Srebrenica. <b>Oslobodjenje</b> pg 6 'Clerk-window hall was opened' by <u>S. Majlovic</u> – also reported.
Preparations for Srebrenica Memorial going on as planned	<b>FTV</b> <u>Salih Brkic</u> – Organisation Board for 11 <sup>th</sup> Memorial Ceremony for Srebrenica victims held another session on Friday. According to the Board, all preparations for the ceremony are going on as planned. However, the planned plenary joint session of the two houses of BiH Parliament Assembly will not take place. Srebrenica Mayor <b>Abdurahman Malkic</b> explained that one of the parliament houses couldn't reach consensus on participation in the plenary session.

They were suspected of planning terrorist attack against US Embassy in Sarajevo. They have been imprisoned in Guantanamo military prison since</i> ]. Attorney of the Algerian group <b>Stephen Oleskey</b> stated that this might be the consequence of the decision recently reached by US Supreme Court. Oleskey also stressed that BiH authorities need to react immediately if they want Algerian group to be released.
Families of Algerian group members welcome U.S. Supreme court's decision / BiH Justice Ministry's Pilav: BiH authorities should launch negotiations on release of the group	<b>TV Hayat, BHT1</b> – Wife of one of the members of Algerian Group deported from BiH, <b>Nadja Dizdarevic</b> , welcomed the decision of U.S. Supreme Court. She has contacted BiH Council of Ministers that promised her the entire process would be restarted before U.S. Embassy to BiH. <b>BHT1</b> <u>Mirela Cosic</u> – Families of members of "Algerian Group" welcomed the decision of US Supreme Court, according to which the Guantanamo prison was found to be illegal. They believe that the BiH authorities will demand the release of "Algerian Group" members. <b>Amir Pilav</b> from BiH Ministry of Justice stated that BiH authorities should start negotiation with US Government on release of "Algerian Group".
One month detention for persons arrested in Trebinje	<b>FTV</b> – BiH Court approved a one-month detention for the persons arrested in Trebinje two days ago. According to unofficial sources, the arrested persons are <b>Miodrag Ateljevic, Drazen Radic, Nebojsa Vukoje, Slobodan Popovic</b> and <b>Nada Tasovac</b> . They are suspected of having committed acts of organised crime. <b>RTRS, BHT1</b> – also reported.

New incident in Mostar between Croats and Bosniaks	<p><b>BHT1 Seid Masnica</b> – A new incident occurred in Mostar on Friday, when a group of Croats from settlement Potoci prevented the members of Association of RBiH Army veterans to put up a memorial plate intended to mark the place where RBiH Army soldiers were killed. Despite of the large number of police officers present, approximately 50 Croats verbally attacked the members of veterans' Association. Head of the Association <b>Zijad Music</b> stated that many similar memorial plates for Croat veterans have been placed in the vicinity of the road too. The Association of veterans had informed the police about the planned ceremony. Nevertheless, Mostar City Administration stated that the Association didn't request for an official permission to put up the memorial plate. Music stated that the Association will not give up, stressing that the children of killed veterans must know where their fathers had died. <b>Dnevni List</b> pg 11 'Sesar: even if I have to get killed, I will not allow them to step on my land!' <u>not signed</u> – carries a statement of Potoci citizen <b>Marko Sesar</b> who said he would not allow a memorial plate for those who have been attacking and killing Croats to be placed in front of his house. <b>Vecernji List</b> pg 2 'Ibrahimovic: Croats are defending their land' by <u>Vesna Leto</u> – One <b>Redzo Ibrahimovic</b> says Croats are only defending their land and added: <i>'someone is bothered with good coexistence we have developed here in Bijelo Polje. No decision of BiH Presidency on AFBiH size, structure and stationing	<p><b>BHT1, TV Hayat, FTV, RTRS, Vecernji List</b> pg 3 'Without agreement on national structure of army' by <u>Edina Medunjanin</u>, <b>Oslobodjenje</b> pg 3 'Structure of army ready for BiH Presidency after all' by <u>A. Muminovic</u>– Political advisor to NATO Headquarter in Sarajevo <b>Raffi Gregorian</b> stated that this decision is extremely important. He stressed that any delay is preventing further process and causing additional damage. BiH Presidency announced passing of this decision at the next session. <b>RTRS</b> – Advisor to BiH Presidency member <b>Borislav Paravac, Dragan Kapetina</b> stated that the decision would be adopted on Monday or Tuesday.</p>
Day of FBiH Police marked	<p><b>BHT1 Sanita Lisica Biberovic</b> – The Day of FBiH Police was marked on Friday. Reporter commented that the police officers are very concerned over the fact that almost half of the police officers in FBiH will be dismissed in the police reform process. Director of FBiH Police <b>Zlatko Miletic</b> stated that BiH police agencies have approximately 26.000 employees, which is too much. According to the EU standards, there shouldn't be more than 12.000 employees in such agencies. <b>Sead Lisak</b> from Police Restructuring Directorate stated that the surplus police officers would be taken care of through compensation payments or early retirements. RS Minister of Interior <b>Stanislav Cadjo</b> is convinced that a suitable solution of surplus police officers would be found soon. <b>FTV, Dnevni List</b> pg 8 'Thousands of policemen to lose their jobs' by <u>Mensud Zorlak</u>, <b>Oslobodjenje</b> pg 8 'European standards' by <u>A. BiH Presidency member Jovic addresses HR CSS in an open letter, warns Croats are repeatedly attacked in Tuzla Canton	<b>FTV</b> - Member of BiH Presidency <b>Ivo Miro Jovic</b> addressed HR <b>Christian Schwarz-Schilling</b> in an open letter. In his letter, Jovic condemned the attacks of Bosniak citizens against Croat citizens in Tuzla Canton. According to Jovic, these attacks last for years already. Jovic stated that he expects Tuzla Canton authorities to undertake urgent actions, adding that he is surprised with poor reaction of the International Community. <b>Dnevni List</b> pg 6 'Worry over attacks on Croats' <u>not signed</u> , <b>Vecernji List</b> pg 2 'Systematic maltreating of Croats' by R. He said it is not true RS is de-stabilising BiH and, if attacks on RS continue, he could only reiterate his stances on referendum. SNSD believes the package of amendments to BiH Constitution is a solid base, uncompleted but acceptable, and no radical changes or imposing would be possible.
SDA demands from BiH CEC to prolong registration of refugees and DPs until August 18	<b>Dnevni List</b> pg 4 'Election Commission is not doing its job' by R. Dautevendic, <b>Oslobodjenje</b> pg 5 'Extend deadline for registration of refugees and DPs' by A. T., <b>Dnevni Avaz</b> pg 10 'SDA asks for extending of deadline for registration of refugees and DPs' by E. Sarac, <b>Nezavisne Novine</b> pg 8 'Prolong deadline for registration of voters' by R. Cengic - BiH SDA forwarded an official demand to BiH Central Election Commission (BiH CEC) on Friday demanding for allowing an additional month for registration of refugees and DPs for October elections, i.e. the party demands the deadline for the registration to be August 18. SDA's <b>Halid Genjac</b> said it is unacceptable voters had been allowed only one moth to register for the elections. <b>Dnevni Avaz</b> pg 10 'It is difficult to meet the demand' by E. RS NA Speaker Radojicic: elections in F BiH key for entire BiH	<b>Oslobodjenje</b> pg 5 'Elections in FBiH key to entire BiH' <u>not signed</u> , <b>Nezavisne novine</b> pg 6 'Without complications' by Fena - RS NA Speaker <b>Igor Radojicic</b> said it would be a problem for the entire BiH if those political forces in Federation BiH that support radical changes of the BiH Constitution were to win in the elections. For this reason, Radojicic deems that the key issue for BiH would be who will win the elections in Federation BiH. He is of the opinion that talks on the already agreed constitutional reforms could be continued, if the political parties that supported the defined constitutional reforms were to win in the elections.
Austrian Ambassador to BiH: progress achieved in talks on SAA, reform processes in hands of BiH politicians	<b>Dnevni List</b> pg 2 'Do not interrupt reform processes' <u>not signed</u> , <b>Oslobodjenje</b> pg 3 'Reforms, reforms, reforms' <u>not signed</u> , <b>Dnevni Avaz</b> pg 2 'I believe we have brought BiH closer to EU' by agencies - Austrian Ambassador to BiH <b>Werner Almhofer</b> said that the first half of this year was an important period in the efforts of BiH to move closer to the EU. Significant progress has been made in talks on a Stabilisation and Association Agreement, and EU foreign ministers have in their Salzburg Declaration from early March confirmed the future of this region and BiH in the EU. The Ambassador noted all further progress of BiH towards the EU will depend on the reform process, which is in the hands of BiH politicians and added restructuring of the police, education reform and reform of the public broadcasting system, as well as the creation of a single economic space all give an opportunity to BiH politicians to show that they take seriously the European road, event during the summer months and in an election year. He thinks that the last week's decision of OHR to replace OHR with the office of the EU Special Representative in one year represents an important step forward towards self-responsibility.

US Ambassador McElhaney: BiH is sovereign state and this will not be changed	<b>Oslobodjenje</b> pg 6, announced on cover 'BiH is sovereign and will not be changed' by <i>Voice of America</i> , <b>Dnevni Avaz</b> pg 8 'BiH is sovereign state and changing this is out of question' by <i>VOA</i> – Reports on the interview of US Ambassador to BiH <b>Douglas McElhaney</b> to <i>Voice of America</i> [see <i>OHR BiH Media Round-up: June 30</i> ], and also carries his comment with regard to the issue of RS referendum. McElhaney said USA does not even consider the referendum in BiH since the status of BiH had been defined ten years ago, peoples of BiH have reached an agreement on this and he added: <i>'BiH is a sovereign country and any changes with regard to this are out of question'</i> . He noted Montenegro and Kosovo are in a different situation and this has nothing to do with BiH.
VL: stances on closure of OHR differ / Croat politicians comment on the closure, some say IC will remain in BiH, others think OHR had not done enough for BiH	<b>Vecernji List</b> pgs 4-5 'Departure of OHR' by Miroslav Vasilj – Referring to the announced closure of OHR, <i>Vecernji List</i> comments Croats poorly reacted on the announcement, Bosniak politicians agree it is too early to close OHR while only Serbs welcomed the decision on closure. VL further comments there are both good and bad sides of the closure for BiH and Croats in BiH: <i>'the good side is that the colonial relation towards BiH would be abolished'</i> but, as a negative consequence, VL notes BiH still had not regulated constitutional-legal organisation of BiH and the timing for the decision was not good considering "separatist-like threats coming from RS". Some circles even interpret the closure of OHR as a penalty for non-adoption of constitutional changes. The article carries comments of HDZ's <b>Dragan Covic</b> and HDZ 1990's <b>Bozo Ljubic</b> who say the closure of OHR does not mean the international community would leave BiH and they note this means domestic politicians would have be more responsible. Hayat criticized recent FBIH laws on contributions to delegates	<b>TV Hayat</b> By <b>Nevzeta Skrijelj</b> – Reporter criticised the recently adopted FBIH Law on contributions to delegates at FBIH Parliament saying that they have adopted only laws that improve their lifestyle while laws of vital interest to the citizens are still in procedure. Head of BiH Independent Trade Union <b>Edhem Biber</b> agreed with the above statement adding that the laws in personal interests to the delegates are rapidly adopted. OHR's Spokesperson <b>Mario Brkic</b> deems that this law and in this form is not needed especially <i>"if we all know how BiH citizens live"</i> . Brkic said that delegates should be adequately paid but also BiH citizens should have adequate service in return. <i>"These assets would be better used for reconstruction of the hospitals, improvement o schooling conditions etc."</i> added Brkic. <i>Skrijelj</i> expressed hopes that better times would come for the adoption of laws important to BiH citizens, which delegates are undeservedly paid for in the first place, and that more responsible delegates would be elected.
