Incomplete offers will not be considered.

2.2. OHR, as diplomatic organization, is exempt from payment of all taxes and duties and all prices quoted should exclude such charges.

2.3. Prices must be in KM (Convertible Marks) or EURO. OHR payment terms are bank transfer within 30 days from the date of delivery.

2.4. Any Contract concluded with OHR will include conditions and deadlines stated in your offer, which will be

attached to the Contract and considered legally binding for the duration of the Contract.

2.5. Deadline for submission of offers is **Friday 11 February 2003 by 17:00 hours.**

2.6. OHR reserves the right to enter into negotiations with any bidder or to end the Tender without awarding the contract. OHR will not bear any costs of bidders in process of preparation of offer.

2.7. Award of contract will be made based on price, payment terms, delivery time or any combination of those elements.
