<b>SFOR released Milovan Bjelica</b>	<b>RHB, BHTV 1, FTV, RTRS, Oslobodjenje</b> pg 3 'SFOR released Milovan Bejllica' by FENA, <b>Dnevni Avaz</b> pg 2 'SFOR released Milovan Bjelica' by M. Dr., <b>Nezavisne Novine</b> pg 3 'Milovan Bjelica released from detention'; <b>Glas Srpske</b> cover page report 'Bjelica released' – Former Speaker of Srpsko Sarajevo Assembly <b>Milovan Bjelica</b> , who was arrested by SFOR a month ago, was released on Monday, his wife Dragana confirmed to Bijeljina Television. SFOR arrested Bjelica on 14 May in Sokolac near Sarajevo due to suspicion of assisting war criminal <b>Radovan Karadzic</b> . Bjelica was one of the closest associates of Karadzic during the war in BiH. He has also been blacklisted by the United States and European Union, and High Representative <b>Paddy Ashdown</b> dismissed Bjelica last year from his position.

<p><b>Reactions to Spiric accusations regarding war crimes in Srebrenica</b></p>	<p><b>Nezavisne Novine</b> pg 4 'I was not aware of Srebrenica developments'; <b>Glas Srpske</b> pg 3 'Spiric's untruth' – <b>Dragan Mikerevic</b>, RS Prime Minister, denied claims of <b>Nikola Spiric</b>, Co-Chairperson of the BiH HoR, who said that Mikerevic and other RS authority officials were aware of Srebrenica developments in 1995.</p> <p><b>Oslobodjenje</b> pg 7 'Spiric lunches lies' by Fena, <b>Dnevni Avaz</b> pg 4 'Nikola Spiric knew what happened in Srebrenica and it is strange that he did not publish it' by FENA – Spokesperson for RS Prime Minister, <b>Goran Radivojac</b>, in a statement to FENA news agency, Radivojac responded to the allegations laid out by Spiric at press conference held in Banja Luka on Sunday, and said that <i>"in the last couple of years Spiric has mostly been in the government which implies that he, too, knew and still knows, what happened in Srebrenica"</i>. <i>"We can also wonder why he did not publish this information any sooner,"</i> Radivojac said. As far as resignations are concerned, which in the words of Spiric, should be tendered by representatives of the RS government, if for no other reason than a moral one, the prime minister's spokesman said that Spiric was Speaker of the BiH House of Representatives, and in the top echelon of the BiH government, and that <i>"it would be more than agreeable for him to set an example and show how it looks when one of the leading RS politicians steps down"</i>.</p> <p><b>BHTV 1, Glas Srpske</b> pg 2 'Nothing behind the back' – also reported.</p> <p><b>Dnevni Avaz</b> pg 3 'Spiric's hypocrisy' op-ed by <u>Faruk Cardzic</u> – Editorial refers to the statement by <b>Nikola Spiric</b> – Editorial says that all those accusations by Spiric would be grounded if someone else presented them, as it is difficult to believe that Spiric himself was not aware of the events in Srebrenica in 1995.</p>
<p><b>SDS on crimes in Srebrenica</b></p>	<p><b>Oslobodjenje</b> pg 7 'Everybody committed crimes', mentioned on cover, by Fena, <b>Dnevni List</b>, pg 18 'SDS was never running away from crimes', by <u>De. L.</u> – Spokesperson of SDS, <b>Dusan Stojicic</b>, assessed yesterday that the report prepared by the Srebrenica Commission on the events that occurred in and around Srebrenica between July 10-19, 1995, was a reflection of capabilities of RS bodies to tackle such challenging and difficult issues such as determining of full truth about crimes in BiH. Stojicic stated that the SDS was never running away from the fact that the Serb side committed crimes, adding that such crimes happened on the Bosniak and Croat sides, <i>"in other words by all who were a part of the civil war"</i>.</p> <p><b>Nezavisne Novine</b> pg 8 'There were crimes on Serb side as well' – <i>"SDS has never run away from the fact that there were crimes committed by the Serb side as well, but those crimes were also committed by Bosniaks and Croats as well,"</i> said Stojicic.</p>
<p><b>Bogdanic on work of Srebrenica Commission</b></p>	<p><b>Nezavisne Novine</b> cover and pg 4 'Next task is to establish the number of victims' – In a brief interview to NN, <b>Milan Bogdanic</b>, the Chairperson of the Srebrenica Commission, says that a new task is ahead of Srebrenica Commission, which is not an easy one, and that is to establish the exact number of Bosniaks gone missing between 10 to 19 July 1995 in Srebrenica. He stresses that <i>"it is high time an end was put to various manipulations with the number of those, who lost their lives in Srebrenica enclave"</i>. He further says that final decision, regarding adoption of report, lays with BiH Human Rights Chamber. According to NN inset, the exhumation of human remains at one of 32 newly identified mass graves has commenced at Sandici settlement near Bratunac yesterday.</p>
<p><b>Serb Radical Party on Srebrenica Comm report</b></p>	<p><b>RTRS, Nezavisne Novine</b> pg 4 'Serb people cannot be sanctioned' – <b>Milanko Mihajlica</b>, President of the RS Serb Radical Party, yesterday stated that it is inadmissible to even think about sanctioning the Serb people, RS or its institutions on the basis of Srebrenica Commission report. He said: <i>"We are convinced the responsibility for events does not rest with institutions or the people of RS."</i></p>

<b>Hays: There are few people that are obstructing cooperation with the Hague</b>	<b>RTRS, Blic</b> , pg. RS2 'Hays: There are few people that are obstructing cooperation with the Hague' by <u>M. Zubac</u> – PDHR <b>Donald Hays</b> assessed on Monday in Trebinje that the lack of cooperation of RS with the Hague Tribunal is not the fault of Serb people, but it is the fault of few people that are abusing their positions and obstructing reconciliation processes in BiH. During his visit to Trebinje, Hays emphasized that it was <i>'time for RS to start cooperating with the Hague Tribunal because, in this case, BiH would enter PfP and would start with the process of admission to Europe and its institutions'</i> .
<b>Reactions on Srebrenica Commission report from families of victims</b>	<b>Dnevni Avaz</b> pg 8 'RS Government must begin to arrest war criminals' by <u>fena</u> – The Report of the Srebrenica Commission confirms that thousands of Bosniaks were murdered and that genocide was executed against the Bosniak population of this town, and thus, the RS Government should launch an investigation and finally start apprehending the persons responsible for these crimes. <i>"We hope that the aggression of SCG against the sovereign BiH State will be clarified and that the names of war criminals will be announced so that the public could be informed about those who are responsible for genocide"</i> , is stated in announcement of the Association <i>Mothers of Srebrenica and Zepa Enclaves</i> . <b>Oslobodjenje</b> pg 7 'Worthless without qualification 'genocide'' by <u>A. Av.</u> – The members of <i>Srebrenica Women</i> are dissatisfied with the report of the Srebrenica Commission. <i>"Even though <b>Carla Del Ponte</b> publicly stated that genocide occurred in Srebrenica, the members of the Commission in this report did not use this term in its right sense. Without a term 'genocide' for us that report is worthless,"</i> stated President of Association, <b>Munira Subasic</b> . She adds that all associations will ask from HR <b>Paddy Ashdown</b> to impose sanctions against those who kept information for 9 years, including <b>Dragan Mikerevic, Mladen Ivanic, Milorad Dodik, and Dragan Kalinic</b> .
<b>FBiH Missing Person Comm starts exhuming mass grave located by Srebrenica Commission</b>	<b>BHTV 1</b> – The exhumation on the first, out of the 32 locations of mass graves mentioned in the Srebrenica Commission report, has started on Monday. <b>Amor Masovic</b> , Chairman of FBiH Missing Persons Commission assumes that this locality of Sandici near Bratunac could hold about 20 bodies of victims executed by guns. <i>"For now we must wait for the results of exhumed objects from this grave and only then we can confirm credibility of that report,"</i> added Masovic. Exhumation will be continued tomorrow, and Masovic estimates that exhumations of all locations could take more than 2 years.
<b>Oslobodjenje on trials to find Karadzic personal files</b>	<b>Oslobodjenje</b> pg 3 'What Karadzic, where is archive?', mentioned on cover, by <u>E. Kamenica</u> – Article reads that institutions in RS currently pay attention to the question 'where is Radovan Karadzic's personal documentation?' According to <i>Oslobodjenje's</i> source, Public Security Centre in Pale has carried out interrogations of all persons believed to know the answer to this question and have knowledge on the missing documents. The same source says that one of the reasons for such a 'mess' is that Chief ICTY Prosecutor <b>Carla Del Ponte</b> has demanded these documents, and adds that everybody now is more interested to obtain this documentation than to arrest Karadzic.
<b>Nacional speculates on whether Karadzic would become protected witness</b>	<b>Nacional</b> Belgrade daily, pg. 7 'Come Radovan, I will do you no harm' by <u>A. B.</u> – The article speculates on the initiative that, allegedly, has been brought among associates of <b>Carla Del Ponte</b> to assign the status of a witness of the prosecution to <b>Radovan Karadzic</b> . According to the article, Del Ponte has been reacting in a different and more sustained manner on Karadzic case lately, which might indicate that some contacts with Karadzic's net have already been established and it is quite possible that Karadzic would appear at the Hague Tribunal.

<b>BiH Prosecutor's special department starts with new economic crime case</b>	<b>RHB, FTV, BHTV 1 - Maktouf Abduladhim</b> , native of Iraq and a resident of Travnik where he owns Palma company, was arrested by FBiH Interior Ministry on June 11, after Special Department for Organized Crime, Economic Crime and Corruption of the BiH Prosecutor's Office filed request for an order on detention in custody to the BiH Court . Maktouf was ordered to be held in pre-trial custody for 30 days by BiH Court , as he is the subject of a criminal investigation by the Prosecutor's Office concerning the activities of his company Palma as well as his association with public officials in cantonal and state governments of BiH. Maktouf was apprehended after returning to BiH from Canada , where he had been residing.
<b>Orao trial continues</b>	<b>Oslobodjenje</b> pg 9 'Nobody's guilty?!' by V. Du., <b>Nezavisne Novine</b> pg 5 'Defence claims that "Orao" did not export equipment to Iraq', <b>Blic</b> pg RS8 'Defence denies claims of the Prosecutor' by Lj. Lj. - Trial to suspects in 'Orao' case continued on Monday at the Court in Bijeljina. The Prosecution presented new evidence, presented a contract "Orao" has signed with "Jugoimport" firm from Novi Beograd, which had signed contracts with certain firms from Hong Kong and Singapore . The defence claims "Orao" firm had nothing to do with the contracts of "Jugoimport", therefore the evidence was irrelevant. The defence yesterday emphasized that most of evidence and reports were irrelevant because they had no common points with the indictment. The trial will continue today.
<b>Tihic demands constitutional changes</b>	<b>Oslobodjenje</b> cover page, pgs 4-5 'Tihic demands changes of the entities symbols' by Azhar Kalamujic - Chairman of the BiH Presidency <b>Sulejman Tihic</b> has recently demanded from the BiH Constitutional Court to reconsider the constituency of the coat of arms, hymn, flag of RS, and of coat of arms and flag of FBiH. According to the Court's sources, at the same time Tihic has also submitted to the court the special demand request for estimation on the harmonisation level between BiH Constitution and some European conventions. This particularly refers to the method of electing BiH Presidency members [apparently, Tihic objects to the provisions according to which Bosniak and Croat members can be appointed only if they are from FBiH, and Serb member only from RS]. <b>Oslobodjenje</b> also learns that, despite announcements, Tihic has still not filed a request for decision on RS name.
<b>OHR on HJPC</b>	<b>Oslobodjenje</b> pg 7 'Unacceptable elimination of Zarko Bulic', <b>Nezavisne Novine</b> pg 5 'Bar Association of FBiH should have proposed three candidates', <b>Slobodna Dalmacija</b> , pg 7, 'Bar Association's member is not appointed', by E, carries that, in response to the open letter which the FBiH Bar Association sent to the HR <b>Paddy Ashdown</b> in relation to non-appointment of <b>Zarko Bulic</b> to the High Judicial and Prosecutorial Council, the OHR Spokesperson <b>Vedran Persic</b> has stated that <i>"unfortunately the Bar Association hadn't proposed its candidates within the set deadline. The High Representative then appointed an earlier member of the Council as a means of ensuring a seamless transition to the newly established Council, and at the same time guaranteeing continuity of membership, geographical coverage, gender balance and ethnic representation based on the 1991 Census"</i> .

<p><b>Hays visits Stolac, Trebinje and Berkovici</b></p>	<p><b>RHB, Oslobodjenje</b> pg 8 'Citizens to receive more services for less money' by <u>N. Bise</u>, <b>Dnevni Avaz</b> pg 4 'Hays in Eastern Herzegovina', <b>Dnevni List</b>, pg 3, 'Hays: Stolac needs new jobs', by <u>Nermin Bise</u>, <b>Vecernji list</b>, pg 7, '1200 KM for water from other entity', by <u>Frano Matic</u>, and <b>Slobodna Dalmacija</b>, pg 19, 'Water in the interest of development of agriculture', by <u>Ivo Raguz</u>, - Principal Deputy High Representative, <b>Donald Hays</b>, visited Trebinje, Berkovici and Stolac on Monday where he talked to the Mayors about economic situation in these municipalities as well as about ways to improve the living standard of citizens. <i>"All this will help us prepare ourselves for the next set of projects aimed at improving living in a local community - this refers to Law on local self-governance in FBiH, conference on agriculture in BiH and offering better services in public corporations through definition: more services - less money"</i>, Hays is quoted as saying. Hays also visited the water pump station in Do, located in the vicinity of the inter-entity border-line, from which Stolac (in FBiH) gets supplied with water from Berkovici (RS).</p> <p><b>Oslobodjenje</b> pg 8 'Agriculture is a base for BiH development' by <u>S. Sijakovic</u>, <b>Blic</b>, pg. RS2 'Hays: There are few people that are obstructing cooperation with the Hague' by <u>M. Zubac</u> - PDHR Hays visited "Ljekobilje" and "Agros" firms in Trebinje. He explained his visit with desire to <i>'organize help of the international community to agricultural initiatives in a much better way'</i>.</p>
<p><b>Vrankic announces rebalance of FBiH budget</b></p>	<p><b>RHB, Dnevni Avaz</b> pg 4 'Spending in Federation will be decreased for 10 percent', <b>Vecernji List</b>, pg 4 'Ministry of Finances decreases expenditures', by <u>E. Dnevni List</u>, pg 3 'Re-balance of Federation budget because of poor collection of revenues!?', by <u>Miso Relota</u> - Media got an information from the FBiH Ministry of Finances that the FBiH Finance Minister, <b>Dragan Vrankic</b>, would recommend re-balancing of the FBiH budget for 2004 in order to restore balance between the incomes and expenditures. Apparently, the reason for this is poor collection of revenues in the first five months of 2004, which apparently fell short for about 105 million KMs. On top of that, the FBiH budget is financing couple of State-level institutions, namely the Customs Administration and Intelligence-Security Service.</p>
<p><b>FTV on audit reports</b></p>	<p><b>FTV</b> - According to the FTV, the Audit Office of BiH Institutions has still no information as to when BiH parliament will discuss their report, which revealed a number of irregularities in the work of BiH institutions. <i>"These reports are being submitted to BiH Prosecution, without any kind of selection and it is up to BiH Prosecution to decide what to do about them,"</i> said <b>Samir Musovic</b>, person who performs function of General Reviser. By the end of this week, the Audit Office is to complete the reports on workings of BiH Foreign Ministry, BiH Civil Service Agency, BiH Parliament, Ministry of Foreign Trade and Economic Relations, BiH Judiciary and Ministry of Treasure and Finance.</p>
<p><b>DL: Scandalous letter of PDHR Hays to Toby Robinson</b></p>	<p><b>Dnevni List</b>, pg 5 'Toby Robinson above BiH Constitution!?', mentioned on cover, by <u>Jurislav Petrovic</u> - Commenting on the announcement of a lawsuit by the Provisional Administration for Hercegovacka bank against HT Zagreb because of alleged non-compliance to the right to pre-emption related to transfer of Eronet shares from HT Zagreb onto HT Mostar, DL reminds that a similar dispute was on when 51% of Eronet shares were being transferred from Eronet onto three private companies, but at the time, the court made such ruling because the then laws said that a foreign entity could not have more than 50% of a company which is of vital interest. DL goes on to say that in the meantime, the laws have been changed, and now it is possible that a foreign entity can buy a majority stake in such companies. In this context, DL wonders why the Provisional Administrator for HB, <b>Toby Robinson</b>, is selling 4,48% of Eronet shares to the Municipality of Grude without offering the same shares to HT Zagreb because of the obligation regarding the right to pre-emption. Having written all this, DL claims to be in possession of a letter that Principal Deputy High Representative, <b>Donald Hays</b>, sent to Ms. Robinson, which exempts Robinson from such obligation, and in which PDHR Hays allegedly says to Robinson that she is above regulations and laws, which, according to DL, annuls sovereignty of BiH.</p>

<b>NN says audit concludes RS Banking Agency misused 8 mil KM</b>	<b>Nezavisne Novine</b> cover and pg 3 'RS damaged for BAM 8 million through violations of Law' – The RS Chief Audit Office established during the audit at the RS Banking Agency that during the temporary administration procedures at Prijedorska Banka and Privredna Banka Gradiska, the Agency has damaged the RS budget for BAM 8 million. The Agency in 2002 sold these two Banks to Nova Banjalucka Banka and "Telekom Srpske" at extremely low prices.
<b>ITA on customs frauds</b>	<b>Nezavisne Novine</b> pg 2 'Less possibilities for custom frauds during import' – <b>Kemal Causevic</b> , ITA Director, has passed an order according to which the number of centres where container deliveries from Asia and Africa would have to go through customs clearance will be reduced as of 1 <sup>st</sup> July. In this manner, the customs frauds would be reduced, according to Causevic. In accordance with this order, the container goods would from now on be customs' cleared exclusively in Tuzla, Banja Luka, Mostar, Bijeljina, Visegrad, Bvihad, Grude, Railway station in Sarajevo and customs offices at Post offices and airports.
<b>SD: RS Government wasted 30 million KMs on ITA building</b>	<b>Slobodna Dalmacija</b> , pg 12 'Threw away 30 million KMs', mentioned on cover, by <b>Zlatko Tulic</b> – In light of reports that the RS Government is going to spend 30 million KMs to accommodate the Indirect Tax Administration in Banja Luka, the author notes that the only reaction to the 'easily' spent money came from <b>Dzemal Faka</b> , an advisor to BiH Minister of Treasury. According to Faka, the RS Government unnecessarily spent the taxpayers' money because there are several facilities in Banja Luka that are owned by the State. SD goes on to say that the BiH Council of Ministers is now interested in solving of this and similar issues. Furthermore, according to SD's information close to BiH CoM, the only way to solve these issues is to adopt a law on state owned property, which BiH does not have at the moment, and establish an agency that would run such property.
<b>Dispute between RS and FBiH pensioners</b>	<b>Blic</b> , pg. RS5 'No man's pensioners' by <b>Rajna Radosavljevic</b> – RS Government confirmed they have signed the Memorandum on Understanding that would regulate disputable relations between Pension Funds of RS and of the Federation of BiH. The World Bank has brought the initiative in relation to the Memorandum, which, as a condition for the approval of credit lines in frame of SOSAC 2 project, should resolve problems of pensioners-returnees. The Head of RS Pension Fund, <b>Jovo Kosmajac</b> , claims that the Pension Fund of the Federation of BiH is still avoiding the fulfilment of its obligations. Kosmajac emphasizes that the true solution for this issue would be the adoption of an umbrella laws at BiH level. The Deputy Head of the Pension Fund of the Federation of BiH, <b>Nedzmija Resic</b> , claims it will be difficult to resolve the pensions issue, since many pensioners have earned their pensions in former Yugoslavia, therefore it is very difficult now to say who should be obliged to pay pensions to them.

<b>OHR on Kalinic statement</b>	<b>Dnevni Avaz</b> pg 2 'State institutions must be stronger to fulfil obligation towards the Hague', <b>Oslobodjenje</b> pg 5 'Dayton is two-way road' by <b>Fena</b> , <b>Glas Srpske</b> pg 3 'Dayton is a two-way street' – It's clear that Constitutional change is possible, but this would have to be agreed by all three BiH Constituent peoples, OHR spokesperson <b>Oleg Milisic</b> old FENA on Monday commenting on RSNA Speaker and SDS President <b>Dragan Kalinic's</b> statement given to OSM TV over the weekend [Kalinic was asked to comment initiatives to abolish RS, to which he responded that would not happen, " <i>Serbs created it, Serbs will protect it</i> "]. Milisic added that Kalinic talks of defending the RS yet he is a part of the RS leadership that is failing to uphold BiH's international obligations to ICTY. " <i>The DPA is a two way street and the RS is failing to fulfil it's international obligations. This is a very serious situation, for which the RS leadership is accountable not only for what has happened but what happens next. The RS must remain focused on meeting its responsibilities until they have detained those indicted by ICTY and handed them to The Hague. BiH will need to strengthen the institutions at the state level that will help ensure that the country is able to meet its international obligations towards the ICTY,</i> " Milisic said.

<b>VL on Kalinic</b>	<b>Vecernji List</b> pg 2 'Rattling of weapons' by <u>Ljuba Djikic</u> – Commenting on recent statements by the President of SDS, <b>Dragan Kalinic</b> , that the Serb people had formed the RS and that the Serb people would defend it, the author says such statements are reminiscent of <b>Radovan Karadzic's</b> statements from 14 years ago in the then BiH Parliament. Djikic is sending a message to Kalinic telling him that it was not the Serb people that established the RS, it was rather the IC, foremost the Americans, who stopped the offensive of the BiH Army and HVO, which in the fall of 1995 came close to capturing Banja Luka. Djikic goes on to say that the same IC should now recognize its mistake and undo it, but without threat of weapons that Kalinic and likes of him use.
<b>NN on Kalinic</b>	<b>Nezavisne Novine</b> pg 7 'Pre-election tactics or a serious threat' op-ed by <u>Josip Blazevic</u> – The author is writing about the most recent statement of <b>Dragan Kalinic</b> , who condemned the statement of <b>Sulejman Tihic</b> seeking abolishment of RS. On this, the author says: <i>"The inciting statement of <b>Dragan Kalinic</b> addressed to <b>Sulejman Tihic</b> is a more like a product of the SDS pre-election campaign and diversion from the course of questioning the responsibility of the RS top leadership in failing to fully cooperate with the ICTY"</i> .

Tihic concluded that presence of the IC is still necessary in BiH. <i>"I expect that in the next year conditions will be met to reduce its institutional presence. However, I believe this is possible only after changes to the constitutional system, as it is complicated and inefficient,"</i> said Tihic.

<b>BiH delegation meets with Rumsfeld, Powell, Rice</b>	<b>Dnevni Avaz</b> pg 3 ‘BiH admission to PfP is also in US interests’, mentioned on cover, by <u>Sead Numanovic</u> – <b>Adnan Terzic</b> , Chairperson of the BiH Council of Ministers, in the company of <b>Nikola Radovanovic</b> , BiH Defence Minister, and <b>Lidija Topic</b> , BiH Deputy Foreign Minister, on Monday in Washington met with <b>Donald Rumsfeld</b> , US Secretary of Defence, and his Deputy, <b>Paul Wolfovich</b> . <i>“We, once more, confirmed that BiH’s integration into EU and NATO have no alternative.
