<u>The Constitutional Court of Bosnia and Herzegovina Ruling on the Constitutional Court Decision on Admissibility and Merits U-23/14 ("Official Gazette of Bosnia and Herzegovina," 1/17)</u> :It is hereby established that the Parliamentary Assembly of Bosnia and Herzegovina failed to execute the Constitutional Court Decision on Admissibility and Merits U-23/14 of 1 December 2016.It is established that the provision of Sub-chapter B, Article 10.12 (2), in part stating that <i>each of the constituent peoples shall be allocated one seat in every canton</i> and the provisions of Chapter 20 – Transitional and Final Provisions of Article 20.16A (2), items a-j of the Election Law of Bosnia and Herzegovina (<i>Official Gazette of Bosnia and Herzegovina</i> , 23/01, 7/02, 9/02, 20/02, 25/02, 4/04, 20/04, 25/05, 52/05, 65/05, 77/05, 11/06, 24/06, 32/07, 33/08, 37/08, 32/10, 18/13, 7/14 and 31/16) shall cease to be valid on the day after the day of publishing this Ruling in the "Official Gazette of Bosnia and Herzegovina."
