# Front Page Headline FBiH Employers Declare War Against FBiH Government!

Are they opening another "war" front line in BiH with FBiH employers on one side and BiH Federation Government on the other?

According to Saturday's announcements of employers, this front line has been opened a long time ago, and the question was when the first battle would start. Last drop in a large glass of discontent was the last Government session where they rejected employers' proposal to resolve the issue of voluntary membership with their associations once and for all. and employers started speaking the language that everyone understands. They do not want chambers of commerce that will be the third arm of the state, they do not want chambers that serve only to employ useless staff that no one needs any longer, whose engagements bring profit to them only, and definitely no one else. Employers further ask: If, lets say, the Foreign Trade Chamber is necessary, isn't it normal that all BiH entrepreneurs should pay its fees, and not just the ones from Sarajevo Canton?

follows: Current situation is as entrepreneurs from the RS paid only 0.44% of total collected fees for this chamber, which (increasing the absurd) is not sufficient to cover two salaries of the above-mentioned institution chairman. Who, by the way, comes from the RS! Is it only us, especially if we are from Sarajevo, who must pay this and other fees, employers from FBiH ask, calling for authority representatives from the whole of BiH to think about this more. Otherwise, various announce disobedience, ready to bear consequences. Why shouldn't they? If they can pay for stupidity, why shouldn't they pay for respecting their own principles?
