- *The Constitution of the Federation of Bosnia and Herzegovina* was adopted by the Constitutional Assembly of the Federation of BiH, at the session held on June 24, 1994. It was published in the “*Official Gazette of the Federation of Bosnia and Herzegovina*”, 1/94.

As a result, there are currently two Amendments CVI published in the two different issues of the “*Official Gazette of the Federation of Bosnia and Herzegovina*. Edouard d'Aoust, Head of the Department for Legal Affairs had sent the official letter and kindly ask the President of the Constitutional Commission, Dr. Sead Dizdarevic and the Secretary of the Government of the Federation of Bosnia and Herzegovina, Mr. Ismet Trumic, to inform the Parliament of the Federation of Bosnia and Herzegovina of this unfortunate situation in order for it to adopt a Corrigendum in accordance with its Rules of Procedure and send the same to the “*Official Gazette of the Federation of Bosnia and Herzegovina*” as soon as possible. Such a Corrigendum was never been published.)
