

DECISION ON PROMULGATION OF AMENDMENTS LXXXIX-XCIV TO THE CONSTITUTION OF THE FEDERATION OF BOSNIA AND HERZEGOVINA

I

Amendments LXXXIX-XCIV to the Constitution of the Federation of Bosnia and Herzegovina are hereby promulgated, adopted by the Parliament of the Federation of Bosnia and Herzegovina, at the session of the House of Representatives held on December 1, 2003 and session of the session of the House of Peoples held on December 3.

II

Amendments LXXXIX-XCIV to the Constitution of the Federation of Bosnia and Herzegovina shall enter into force at midnight, December 3, 2003.

III

This Decision shall be published in the Official Gazette of the Federation of Bosnia and Herzegovina.

AMENDMENTS LXXXIX-XCIV TO THE CONSTITUTION OF THE FEDERATION OF BOSNIA AND HERZEGOVINA

AMENDMENT LXXXIX

Article III .1a) of the Constitution of the Federation of Bosnia and Herzegovina, amended by Amendment VIII to the Constitution of the Federation of Bosnia and Herzegovina shall be amended to read as follows:
“a) conclusion of military agreements pursuant to the Constitution of Bosnia and Herzegovina; and cooperation with Standing Committee for Military Matters and Council of Ministers of Bosnia and Herzegovina and other institutions at state level responsible for military and defence matters.”

AMENDMENT XC

Article IV.B.3.7.a) (II) of the Constitution of the Federation of Bosnia and Herzegovina, amended by Amendments XIII, LVI, LXXII, and LXXXVIII to the Constitution of the Federation of Bosnia and Herzegovina shall be deleted.

AMENDMENT XCI

Article IV.B.3.8 of the Constitution of the Federation of Bosnia and Herzegovina shall be deleted.

AMENDMENT XCII

Article VII .1 of the Constitution of the Federation of Bosnia and Herzegovina, amended by Amendment XVII to the Constitution of the Federation of Bosnia and Herzegovina shall be amended to read as follows:
“International relations of the Federation shall have to be in accordance with continuity, sovereignty, territorial integrity and international personality of Bosnia and Herzegovina, according to Article III of the Constitution of Bosnia and Herzegovina”.

AMENDMENT XCIII

Article VII .4 (1) of the Constitution of the Federation of Bosnia and Herzegovina, amended by Amendment XIX to the Constitution of the Federation of Bosnia and Herzegovina shall be amended to read as follows:
“ (1) The treaties and agreements with states and international organizations shall be signed in the name of the Federation by the Federation President. They shall only enter into force for the Federation only if ratified by the Parliament of the Federation, with the prior approval of the Parliamentary Assembly of Bosnia and Herzegovina, except to the extent that the Parliamentary Assembly of Bosnia and Herzegovina provide by law that these types of international treaties and agreements do not require such approval.”

AMENDMENT XCIV

Article IV.A.5.20. (1) e) of the Constitution of the Federation of Bosnia and Herzegovina, amended by Amendments X and LXIX to the Constitution of the Federation of Bosnia and Herzegovina shall be deleted.
