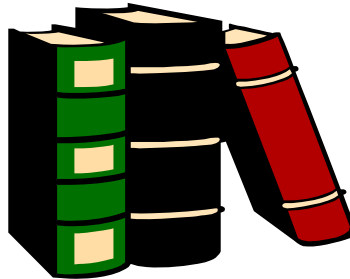

LAW ON AMENDMENTS TO THE LAW ON FEDERATION MINISTRIES AND OTHER BODIES OF THE FEDERATION ADMINISTRATION

LAW ON AMENDMENTS TO THE LAW ON FEDERATION MINISTRIES AND OTHER BODIES OF THE FEDERATION ADMINISTRATION

Article 1

In the Law on Federation Ministries and Other Bodies of the Federation Administration (“Official Gazette of the Federation of Bosnia and Herzegovina”, Nos.58/02, 19/03, 38/05 and 2/06), in Article 4, item 12 shall be amended to read:

“12. Federation Ministry of Trade”.

Item 13 shall be amended to read:

“13. Federation Ministry of Physical Planning”.

After item 15, new item 16 shall be added to read:

“16. Federation Ministry of Environment and Tourism”.

Article 2

Article 17 shall be amended to read:

“The Federation Ministry of Trade shall carry out administrative, professional and other tasks from within the competence of the Federation referring to: trade; functioning of a single market; impact of the economic system and economic policy on the market of goods and services; relations between supplies and demands, prices of goods and services; consumer protection and any other tasks stipulated by law.”

Article 3

Article 18 shall be amended to read:

“The Federation Ministry of Environment and Tourism shall carry out administrative, professional and other tasks from within the responsibility of the Federation referring to: planning and development of space and policy of use of land at the Federation level; development, implementation and application of physical plan of the Federation; harmonization of the physical plans of the canton with the physical plan of the Federation; directing long-term sustainable development of use of natural resources; geological researches; development of basic maps - geo-physical, seismological, geo-thermal, mineral-genetic, geo-chemical, geo-morphological and other maps; preparation of the geological base for physical planning; supervision of relevant sector institutions and other tasks stipulated by law.”

Article 4

After Article 20, new Article 20a shall be added to read:

“The Federation Ministry of Environment and Tourism shall carry out administrative, professional and other tasks from within the responsibility of the Federation referring to: environmental protection of air, water, and soil, formulation of environmental strategy and policy in protection of air, water and soil; quality standards for and

environmental monitoring and inspection of the air, water and soil; formulation of strategy and policy of tourism and catering development; monitoring of trends in tourism at the domestic and international markets; directing the long-term development of tourism within the entire economic system and other tasks stipulated by law.”

Article 5

In Article 30, paragraph 2, indent 1 shall be amended to read:
“Federation Ministry of Trade”.

Article 6

This Law shall enter into force on the day following the day of publication of this Law in the “Official Gazette of the Federation of Bosnia and Herzegovina”.
