

AMENDMENTS TO THE RULES OF THE PROCEDURE OF THE HOUSE OF REPRESENTATIVES OF THE PARLIAMENTARY ASSEMBLY OF BOSNIA AND HERZEGOVINA

Pursuant to Article IV. 3. b) of the Constitution of Bosnia and Herzegovina and Article 186 of the Rules of Procedure of the House of Representatives, the House of Representatives of the Parliamentary Assembly of Bosnia and Herzegovina, at its 31st session, held on 27.7. 2022, enacted the

AMENDMENTS TO THE RULES OF THE PROCEDURE OF THE HOUSE OF REPRESENTATIVES OF THE PARLIAMENTARY ASSEMBLY OF BOSNIA AND HERZEGOVINA

Article 1

In the Rules of Procedure of the House of Representatives of the Parliamentary Assembly of Bosnia and Herzegovina ("Official Gazette of Bosnia and Herzegovina" nos. 79/14, 81/15, 97/15, 78/19 and 26/20) in Article 43, paragraph (1) after item f) new item g) shall be added to read:

"g) Commission for the fight against corruption and kleptocracy;"

Current item g) shall become item h).

Article 2

After Article 49, new Article 49a shall be added to read:

"Article 49a

(Commission for the fight against corruption and kleptocracy)

- (1) The Commission for the fight against corruption and kleptocracy shall:
 - a) conduct parliamentary oversight with the aim of detecting and preventing all forms of corruption and kleptocracy, in accordance with the Law on Parliamentary Oversight;
 - b) monitor the activities of the Agency for Prevention of Corruption and Coordination of the Fight Against Corruption and consider the issues related to the Agency;
 - c) encourage activities in the Institutions of BiH aimed at the fight against corruption and kleptocracy;
 - d) cooperate with judicial institutions and law enforcement bodies at the level of Bosnia and Herzegovina in the field of fight against corruption and kleptocracy;
 - e) consider the proposed laws and other regulations from the position of the fight against corruption and kleptocracy;
 - f) consider preparations for the participation of the delegations of Bosnia and Herzegovina in international gatherings related to the implementation of international obligations of Bosnia and Herzegovina in the field of the fight against corruption and kleptocracy, conflict of interest, and other forms of corrupt activity;
 - g) consider the reports of the Institutions of BiH from the position of the fight against corruption and kleptocracy;
 - h) cooperate with similar commissions and parliamentary bodies of other countries and international organizations, as well as with foreign officials, on issues regarding the fight against corruption and kleptocracy;
 - i) perform other activities prescribed by the Law on Parliamentary Supervision in the field of fight against corruption and kleptocracy.
- (2) The Commission shall also consider other issues in the field of the fight against corruption and kleptocracy.

(3) Notwithstanding the general provisions prescribed in Article 30 of these Rules of Procedure, the chairperson of the Commission shall be from a party that does not have a minister or deputy minister in the Council of Ministers of BiH. This provision shall be applied at all times of the Commission's activities.

Article 3

These amendments to the Rules of Procedure shall enter into force on the eighth day from the day of publication in the "Official Gazette of BiH", and shall be applied from the beginning of the new composition of the House.
