DECREE ON AMENDMENTS TO THE PROCEDURE OF VERIFYING THE FROZEN FOREIGN CURRENCY SAVING CLAIMS AND CASH PAYMENTS IN REPUBLIKA SRPSKA

Pursuant to Article 15, subparagraph g), Article 43, paragraph 2 of the Law on the Government of Republika Srpska (“Official Gazette of Republika Srpska”, No. 118/08) and Article 28 of the Law on Settlement of Liabilities for Frozen Foreign Currency Accounts (“Official Gazette of Bosnia and Herzegovina”, Nos. 28/06, 76/06 and 72/07), the Government of Republika Srpska, at the session held on 7th September 2011 has hereby enacted the following

DECREE

ON AMENDMENTS TO THE PROCEDURE OF VERIFYING THE FROZEN FOREIGN CURRENCY SAVING CLAIMS AND CASH PAYMENTS IN REPUBLIKA SRPSKA

Article 1

In the Decree on the Procedure of Verifying the Frozen Foreign Currency Saving Claims and Cash Payments in Republika Srpska (“Official Gazette of Republika Srpska”, nos. 102/06, 124/06, 17/07, 62/07, 105/07, 18/08, 20/09 and 21/10), in Article 16, after the Paragraph 7, new Paragraphs 8 and 9 shall be added to read:

“(8) Notwithstanding the provisions of paragraphs 1, 2, 4 and 6 of this Article, claimants who did not file their requests for verification of the frozen foreign currency savings accounts may file the request until 1 November 2011, and the Agency shall be bound to complete the processing of received requests until 31 March 2012 at the latest.

(9) Filing requests, their processing and their realization in the procedure of verification of the frozen foreign currency savings accounts, in conjunction with deadline referred to in paragraph (8) of this Article, shall be executed in the same manner and under the same procedures which the Decree prescribes.”

Article 2

In Article 19, after the Paragraph 11, new Paragraphs 12 and 13 shall be added to read:

“(12) Cash payments upon the requests for verification referred to in Article 16, paragraph 8 of this Decree shall be executed in the maximum amount of KM 2,000 or in total amount of KM 2,000.

(13) Cash payments referred to in Article 12 of this Article shall be executed after the completion of the verification.”

Article 3

In Article 21, the words: “Paragraphs 3 and 7” shall be replaced with words: “Paragraphs 3, 7, 8, 10 and 12”.

Article 4

This Decree shall enter into force on the eighth day following its publication in the “Official Gazette of Republika Srpska.”
