Pursuant to Article IV.B.7.a) (IV) of the Constitution of the Federation of Bosnia and Herzegovina, I hereby enact the

DECREE
ON PROMULGATION OF THE LAW ON AMENDMENTS TO THE CRIMINAL CODE
OF THE FEDERATION OF BOSNIA AND HERZEGOVINA

LAW
ON AMENDMENTS TO THE CRIMINAL CODE
OF THE FEDERATION OF BOSNIA AND HERZEGOVINA

Article 1

In the Criminal Code of the Federation of Bosnia and Herzegovina (“Official Gazette of the Federation of BiH”, nos. 36/03, 37/03, 21/04, 69/04, 18/05, 42/10, 42/11, 59/14, 76/14 and 46/16), Article 78 shall be amended to read as follows:

“Article 78
Forfeiture of Objects

(1) Objects that were in any way, wholly or partially, used or destined for use in the perpetration of a criminal offence, or to those that resulted from the perpetration of a criminal offence, shall be forfeited if those objects are owned by the perpetrator.

(2) Objects referred to in paragraph 1 of this Article shall be forfeited even if not owned by the perpetrator, however, such forfeiture shall not affect the rights of third parties to obtain damage compensation from the perpetrators.”

Article 2

In Article 210, paragraphs (3), (4) and (5) shall be deleted.

Article 3

In Article 272, paragraph (1), wording: “this Code”, shall be replaced with wording: “law in the Federation”.

Article 4

This Law shall enter into force on the day after its promulgation in the “Official Gazette of the Federation of BiH”.
