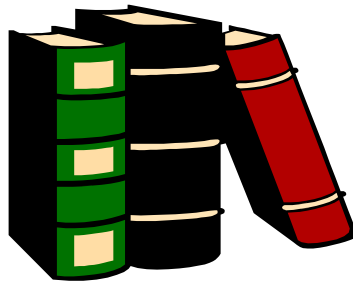

DECREE

LAW ON AMENDMENTS TO THE LAW ON BUDGETS IN THE FEDERATION OF BOSNIA AND HERZEGOVINA

Article 1

In the Law on Budgets in the Federation of Bosnia and Herzegovina (“Official Gazette of the Federation of BiH”, Nos. 102/13, 9/14, 13/14, 8/15, 91/15, 102/15, 104/16, 5/18 & 11/19), in Article 2, item 48, in the third row, the words “Pension and Disability Fund” and a comma following these words shall be deleted.

Article 2

In Article 102, item 3, the words “by March 1” shall be replaced with the words “by April 15”.

Article 3

After Article 105f, a new Article 105g shall be added to read as follows:

“Article 105g

Exceptionally and exclusively for securing the financing of the City of Mostar for year 2020, the Budget of the City of Mostar as well as the Decision on Execution of the Budget for year 2020 shall be adopted by the Mayor of the City of Mostar, who shall also be responsible for its [budget] implementation, with the consent of the Head for Finances of the City of Mostar.”

Article 4

This Law shall enter into force on the day following the date of its publication in the “Official Gazette of the Federation of Bosnia and Herzegovina”.
