20f eight satisfied CoE accession tasks <u>requiring adoption of</u> <u>legislation</u>, only three – the BiH Law on Immigration and Asylum, the BiH Revised Law on Citizenship and The [RS] Laws to Establish Independent Selection Procedures for Judges and Prosecutors and Priority to Adequate Judicial Salaries – were adopted by relevant governmental bodies. The other four were imposed. Out of the four laws imposed , only one, the State Law on Citizenship, was subsequently passed by the BiH Parliamentary Assembly.
