<b>War crimes/exhumations</b>	
230 bodies exhumed from Gljeceva mass grave in Srebrenica area	<b>FTV</b> – A total of 132 complete body remains and 99 incomplete body remains have been excavated from the secondary mass gravesite in Gljeceva, Srebrenica municipality. These are remains of Bratunac and Srebrenica war victims, which were killed between 1992 – 1995. Exhumations lasted for almost one month, and it is believed that bodies are transported to Gljeceva from two primary mass graves. Forensics says that identification of incomplete body remains will be difficult.

<p>Exhumation at the site of Sjekovac continued</p>	<p><b>FTV, RTRS, Nezavisne Novine</b> cover and pg 5</p> <p>‘It is suspected majority of victims are from Vukovar’ – Remains of one adult were exhumed on Tuesday from the mass gravesite Sjekovac near Bosanski Brod. This is 59th victim exhumed during 20 days of the exhumations. Among these 59 persons’ remains, 18 belonged to children. Doboj district judge <b>Slavko Krulj</b> said that it is suspected that those remains belong to Vukovar ( Croatia ) Serbs, whose bodies were transported after they were murdered to this area. Among victims are also civilians killed in Sjekovac in March 1992. It is assumed that there are more bodies in this area that will be exhumed.</p>

<p>Remains of 30 victims exhumed in Miljevina so far</p>	<p><b>FTV, Dnevni Avaz</b> pg 3 'Victims were being killed on the mine waste dump' – Remains of 30 victims have been exhumed during the past three days from the mass-grave site at the coalmine in Miljevina. All 30 bodies belong to males of different age. According to existing data, one group of Jelec and Miljevina residents was killed and brought to this location, and then covered with waste materials from the mine. The others are killed directly on this location, what proves cartridge cases found on the spot. It is not known does those bodies belongs to victims from Foca prison. Total number of bodies buried in the grave is still unknown, but President of State Commission for Missing Persons <b>Amor Masovic</b> says that they think there might be more than a hundred of bodies.</p> <p><b>Nezavisne Novine</b> pg 5 '21 bodies exhumed' also covered the issue.</p>

He does not show in public and he comes out from his shelter only in the night,"</i> say relatives of the victims. The list of criminals does not end with him. It also includes: <b>Vojislav Maksimovic, Petko Cancar, Leko Vukovic, Milos Krunic, Nedjo Govedarica...</b></p>

<p>Croat liaison officer with ICTY on crimes against Croats, pre-trial release for Prlic and others</p>	<p><b>Slobodna Dalmacija</b>, pg 12 'Six Croats arrive from The Hague in September', mentioned on front, by <u>Zoran Zekic</u> – carries the Croat liaison officer with the ICTY, <b>Goran Mihaljevic</b>, as saying that there will be no more indictments for the BiH Croats. He also says that at the moment, investigators of the ICTY are in Bugojno where they will be investigating into circumstances related to crimes against the Croats. Apparently, suspects include the wartime Mayor of Bugojno, <b>Dzevad Mlaco</b>, and his associates. Regarding the pre-trial release of <b>Jadranko Prlic, Bruno Stojic, Berislav Pusic, Valentin Coric, Slobodan Praljak</b> and <b>Milivoj Petkovic</b>, Mihaljevic says they will most likely be on pre-trial release as of September.</p>

<p>DL on Police cooperation, arrest of war criminals</p>	<p><b>Dnevni List</b>, pg 2 'Uniting of Police forces a mission impossible!?', by <u>Miso Relota</u> – carries an op-ed about a recent initiative of the Chairman of BiH Council of Ministers, <b>Adnan Terzic</b>, about formation of a joint Police team of BiH and Serbia and Montenegro, whose task would be to arrest war criminals. The author stresses that the reality on the ground shows that at the moment, a Police officer from the FBiH cannot operate in the RS and vice versa, let alone in Serbia and Montenegro. However, the author notes that things are moving forward, as demonstrated yesterday at Podgorica where Directors of Police forces from the region signed a joint statement on fight against crime. Still, the author fears that the fact that war criminals are still very rich can buy them the freedom they are enjoying right now because the underpaid Police can be easily corrupted.</p>

<p>RS Association of POWs announces Carla del Ponte's visit</p>	<p><b>Vecernji list</b>, pg 3, 'Del Ponte arrives to BiH again in autumn', by <u>Renata Radic</u> – <b>Slavko Jovicic</b>, the President of the RS Association of Camp Inmates, says that, in her letter of thanks for delivering the documentation on war crimes, <b>Carla del Ponte</b>, the Chief ICTY Prosecutor, says that she would like to come to the RS in autumn to talk to war victims and the families of the missing. Although the visit has not been confirmed, Jovicic says they would also like del Ponte to visit a memorial mass grave containing 450 unidentified victims. <i>"The camp inmates would like the ICTY Prosecution to keep on working until 2008 as we do not trust domestic judiciary. If a Serb were giving testimony in the notorious barracks where the BiH Court is located, he/she would surely not be protected but would be humiliated"</i>, Jovicic says.</p>

P.</u> – The BiH Farmers Association will not held protests and blockade of roads that were being prepared because of non-application of the amendments to the custom tariffs law since they are expecting positive results of a meeting with the BiH Council of Ministers Chair, <b>Adnan Terzic</b>, scheduled for August 16. Terzic guaranteed them full application of this Law as of August 17, so there is no need for planed actions. If this does not happen, protests will start on August 18.</p>

<p>EU provides 600,000 euros to support tourism development in BiH</p>	<p><b>Herceg Bosna Radio, FTV, RTRS, Oslobođenje</b> pg 3 '600,000 euros for development of tourism', <b>Dnevni List</b>, pg 6 'Foreigners do not trust domestic business people', by <u>M. Baterello, Pincom.biz</u>, <b>FENA</b> – The EU has provided a grant of 600,000 euro to support the development of tourism in BiH as part of the CARDS 2002/EU RED program aimed at supporting economic development in BiH. The Delegation of the European Commission in BiH announced a public invitation for gathering proposals of potential tourism projects to be financed. The funds are intended for the development and strengthening of the tourism sector and promotion of the cultural and natural heritage, which will help create jobs in this sector and increase the number of visits of both foreign and domestic tourists to destinations in BiH. The EU stated that the tourism sector has been identified in regional strategies as one of the priority sectors for creating a sustainable economy, and this is thanks to the significant diversity of tourism resources throughout BiH. Governmental and "semi-governmental" tourism organisations, non-governmental organisations and other associations in possession or taking care of tourism destinations are the possible users of these funds. The invitation is extended to private companies operating in the tourism sector. The final deadline for submitting project proposals is October 19.</p>

<p>OHR calls for introduction of Public Moneys Law</p>	<p><b>Herceg Bosna Radio, Oslobodjenje</b> pg 4 'Urgently protect interest of the citizens', <b>Dnevni Avaz</b> pg 8 'Draft law on public moneys should be forwarded to the FBiH Government as soon as possible', <b>Dnevni list</b>, pg 5, 'Public call to Minister Vrankic', by <u>I. Tabucic</u> – "As you know, after the revelations contained in the reports published by the Special Auditor last year on the operations of public companies in BiH, the three prime ministers committed themselves to introducing speedy and effective reforms that would stop a small number of well-placed individuals stealing or misusing money that belongs to the people of BiH. One of these reforms is dealt with in the Entity Laws on Investment of Public Monies, which will ensure that all investments at every level of the government are only made according to clear and enforceable criteria. At the State level, investment of Public Monies is to be addressed by the new State Law on Finance," said OHR Spokesman <b>Oleg Milisic</b> at a press conference in Sarajevo on Tuesday. According to Milisic, this legislation requires that investments of public money by government departments can only be made by an investment manager, who must be authorized and identifiable. "There is nothing controversial in this legislation. It safeguards the people's money and protects the people's interests. The law has already been passed by the RSNA in first reading. However, it has not yet been presented by the Federation Finance Ministry to the Government. As long as this delay continues, the door to abuse remains open and the public suffer," emphasized Milisic. "OHR calls on Federation Finance Minister <b>Dragan Vrankic</b> to supervise the formulation by Ministry officials of a draft text of this law that can be presented without further delay to the Federation Government. The sooner this is done, the sooner the Government can send the law to parliament and the sooner parliament can enact the law. Only when this is done will citizens be protected," concludes Milisic.</p>

<p>BiH beer producers accuse Terzic of destroying domestic production</p>	<p><b>Dnevni List</b>, pg 12 'Beer producers accuse Terzic that he is working for Interbrew of Belgium', by <a href="#">Pincom.biz</a> – The Association of BiH beer producers has accused the Chairman of BiH Council of Ministers, <b>Adnan Terzic</b>, that the Interbrew of Belgium lobbied with him in order not to tax the imported beer from Serbia and Montenegro. Apparently, the Association wanted the imported beer from S&amp;M to be taxed 0,30 KMs per bottle since BiH beers are taxed in S&amp;M and the Association got backing from the Director of ITA, <b>Kemal Causevic</b>. However, Terzic rejected the request. The beer producers claim there is a so-called 'import lobby' in the BiH Council of Ministers and other state institution that works at the detriment of domestic producers.</p>
<p>Update to "Buk Bijela" plant project</p>	<p><b>Nezavisne Novine</b>, pg. 2 "'Buk Bijela" will not be constructed if it would endanger Tara canyon' by <a href="#">P. Klinčov</a> – RS Government yesterday confirmed that the "Buk Bijela" project will not be implemented should it be proven that it would endanger protected areas of Tara, Pliva and Sutjeska canyons, as ecologists from Montenegro have already warned. The Associate of RS Minister for Energy, <b>Zdravko Milovanovic</b>, has stated that there is no need to speculate on possible endangering of national parks until a study on influence on environment is made. RS Ministry of Energy claims ecologists have made assumptions on base of a previous project on the construction of hydropower plants, which included only the construction of "Buk Bijela" hydropower plant. According to the Ministry, the construction of two hydropower plants – "Buk Bijela" and "Foca/Srbinje" – is planned at the moment in order to protect environment. <b>Milovanovic</b> concluded: <i>"This will surely reduce quantity of accumulations but it would be illogical to claim there would be absolutely no influence on environment."</i></p>

BiH Election Commission  
verifies candidates for  
local elections

**BH Radio 1** – The BiH Election Commission said on Tuesday in Sarajevo that it has verified the final candidate lists for October's local elections. The printing of ballot paper's has begun and for the first time this is being carried out by domestic printers. Sixty-eight political parties, 146 independent candidates, 18 coalitions and six lists of independent candidates will contest the forthcoming local elections. In total, 27,427 candidates will participate and of these there are 809 candidates for the head of municipality posts and 26,618 candidates for the councillor posts in the municipal councils, that is for councillors in the municipal assemblies. The new elections will be contested by 9,554 female candidates for the municipal councils and 33 female candidates for the head of municipality posts. The electoral commission in the process of verification implemented the total proceedings and procedures established by the BiH Election Law and 2,057 candidates were rejected from the political parties' lists as they were not able to satisfy conditions.

BHTV – Until now, commission received 75% of funds needed for successful elections process. Printing of voting forms for 13 RS municipalities for which Constitutional Court ordered to be renamed will wait until end of this week, when Constitutional Court will give its position on this matter. Election Commission is not satisfied with cooperation with other BiH institutions. *"All institutions, except BiH Parliamentary Assembly and Council of Ministers, with which we have exceptional cooperation, do not fulfil their constitutional and legal obligations regarding realisation of elections,"* stated member of Election Commission, Lidija Korac. A total of 73 municipalities did not ensure, partially or completely, funds for the elections, but Election Commission believes that this will not bring the elections into question.
