| <p>BiH HoR<br/>adopts<br/>agreement on<br/>police<br/>reform</p> | <p><b>BH Radio 1</b> <u>Mustafa Karahmet</u>, <b>RS Radio</b> – At the session today, the BiH House of Representatives has adopted the Agreement on the police reform, which was presented by the RS President <b>Dragan Cavic</b>. Even though the agreement was forwarded for vote without a possibility of amendments, the delegates launched the discussion.</p> <p>Delegate from the Radical party have strongly criticized the agreement, while the parties from FBiH mainly objected the five-year duration of the police reform. Despite all criticism, the representatives agreed that the fact the agreement endorses 3 EC principles is a reason enough to support it. As for the proposal that the destiny of the Cantonal Interior Ministries is linked with the destiny of the RS MoI, the BiH HoR concludes this is to be later discussed by the Collegium of both houses.</p> |

| <p>Croatian Summit 2005 opens in Zagreb</p> | <p><b>BH Radio 1</b> <u>Mirza Sadikovic</u> – “Croatian Summit 2005” dedicated to the discussion on the European unification process and EC economic and social models has been launched today in Zagreb. Presidents of Austria, Hungary, Poland, Italy, Moldova, Bulgarian, Albania, Slovenia, the Czech Republic, SCG, Macedonia, Slovakia and Romania, as well as numerous international representatives will take part. BiH Presidency Chair <b>Ivo Miro Jovic</b> is heading the BiH delegation. The summits at the presidential level have been held every years since 1993. Jovic is planned to speak at the plenary session on Friday, and is expected to meet a number of presidents.</p> <p><b>RHB</b> also reports on start of the Summit of Central European Countries’ Presidents in Zagreb this morning. On this occasion Croatian President <b>Stjepan Mesic</b> stated that the EU enlargement is the only way that Europe should take.</p> |

Organization</p>     | <p><b>RHB</b> – Chairman of the BiH Presidency <b>Ivo Miro Jovic</b> stated for France Press that BiH Croats demand a right on establishment of their Republic if the RS was not abolished in favour of unified BiH. President of the Striking Board, <b>Danilo Brocilo</b>, stated that all entries/exits from the facility is possible under the escort/control of workers, who control the flow through the gates. According to him, workers have decided to undertake this step over RS Government and Refinery management' failure to respond to workers demands.</p> |

| <p>17 injured at SCG/BiH football match</p> | <p><b>Oslobodjenje</b> cover splash, pgs 4-5 'Supporters from RS caused a war in audience', <b>Dnevni Avaz</b> cover splash, pgs 2-3 'Images of fascism displayed at Marakana toured the world' – Both dailies dedicated two pages to a number of articles on the football match held in Belgrade on Wednesday when SCG won BiH. They strongly criticize paroles with nationalistic messages [Thank you Ratko; Knife, wire, Srebrenica; itd], singing of nationalistic songs by the SCG supporters from the RS and the tensions throughout the game. In addition, they report that 17 in total have suffered injuries, none severe, as the result of violence between fans during and after the match. DA learns that Serbian Interior Ministry has detained 10 persons, and subsequently it has decided to file charges against four for the violence. <b>Dnevni Avaz</b> pg 2 'Nothing unseen till now' by <u>Aj. D.</u> – The Chair of BiH Council of Ministers, <b>Adnan Terzic</b>, attended the game and said that the violence and 'nationalistic' behavior was something that has already happened, and will happen in the future, expressing regret this happens. <b>Dnevni Avaz</b> pg 2 'Unlike football players, many politicians do not live for this country' by <u>Aj.D.</u> – The BiH House of Representatives Speaker, <b>Nikola Spiric</b>, also attended the match and said that the atmosphere of the game was only the reflection of the tragic conditions we lie in. <i>"BiH pays the price for internal lack of honesty. Those who love BiH will make sure this happens less and less,"</i> said Spiric also criticizing "some" of the paroles displayed. | <p>Prosecutor McNair: We still do not have official confirmation Jelavic is in Croatia</p>   | <p><b>Oslobodjenje</b> pg 2 'No confirmation Ante Jelavic is in Croatia', <b>FENA</b> – Head of the BiH Court's Special Department for Organised Crime, Economic Crime and Corruption <b>John McNair</b> told FENA on Thursday that the Prosecutor's Office still does not have confirmation that <b>Ante Jelavic</b> is in Croatia, even though Croatia has been requested through official channels to check if Jelavic is in this country. The BiH Court sentenced Jelavic to 10 years imprisonment last week for abuse of position while he served as the FBiH Defence Minister. Jelavic did not show up for the sentencing and has been on the run since then. McNair repeated that the BiH Prosecutor's Office expects Jelavic to be arrested and to serve his sentence in BiH. He added that it would be wise for Jelavic to surrender, otherwise he could spend his entire life as an international fugitive.</p>                        |

A high-ranked Croatian Government official during the 1990s, who wanted to stay anonymous, stated that only 3 persons knew through which channels money from Croatia was sent to BiH and they are late Croatian Defence Minister <b>Gojko Susak</b>, a person who was the Finance Minister at that time and Prime Ministers to certain extent. DL says that the investigation on this issue will probably be extended on Croatia.</p>  |
| <p>NATO raids a shop in Pale</p>                                       | <p><b>Nezavisne Novine</b> cover pg splash, pg 3 'Firm of Karadzic's son-in-law searched' by <u>M.Cubro</u> – <b>Danka Tesic</b>, Spokesperson of the East Sarajevop PSC, Thursday stated that NATO soldiers Thursday searched premises of company "Mobil Photo" in Pale, whose co-owner is <b>Branislav Jovicevic</b>, the son-in-law of <b>Radovan Karadzic</b>. She also said that PSC East Sarajevo took no part in this action, noting that NATO members took away several packages of unknown content from the shop. Spokesperson of NATO HQ in Sarajevo, <b>Derek Chappell</b> said that NATO's action in Pale saw confiscation of certain equipment from the company, whose co-owner is believed to be son-in-law of Karadzic. RTRS, Oslobođenje</b> pg 7 'Agreement on police reform accepted', <b>Dnevni Avaz</b> pg 9, <b>Dnevni List</b> pg 5 'Parliament: Croats support police reform' <u>not signed</u>, <b>Vecernji List</b> pg 5 'Reform adopted, none satisfied' by <u>E. Medunjanin</u>, <b>Nezavisne Novine</b> pg 3, announced on cover 'Agreement on police reform passed' by <u>R.Cengic</u> – At its special session in Sarajevo on Thursday, FBiH Parliament's House of Peoples passed the agreement on police restructuring in BiH. This agreement was already passed by FBiH House of Representatives, Council of Ministers and RSNA, while BiH Parliament's House of Representatives will discuss this agreement on its Friday's session. Deputy Head of EC Mission to BiH <b>Renzo Daviddi</b> addressed the deputies emphasizing the importance of this agreement adoption for opening of negotiations on SAA with EU till the end of this year.</p> |

SDA supports police reform based on three EC principles; Party not supporting initiatives for census, establishment of the third entity

**Oslobodjenje** pg 3 'To implement European principles in police reform', **Dnevni Avaz** 'Census possible to be carried out in 2010', **FENA** – The Party of Democratic Action (SDA) supports police reform based on the three principles of the European Commission. SDA requests the European Commission to remain consistent during the implementation phase in the interpretation of those principles which include a state police structure without police authorities in the entities and cantons, and that police regions be established based on technical criteria, which means that they cross the inter-entity line. SDA General Secretary **Amir Zukic** told a press conference in Sarajevo on Thursday that SDA supports the Wednesday's statement by US Undersecretary of State for Political Issues **Nicholas Burns** who said that it is time for constitutional changes in BiH, and that BiH should have one president, a strong prime minister and strengthen the state parliament. These are also the principles which SDA supports – a functional and efficient state with a president or presidency with a non-rotating chairman, a government with broadened authorities instead of the Council of Ministers, and an internal organization without entities. *"We do not support initiatives for forming a third entity. We think that the internal organisation of BiH should be based on economic criteria and that the country should be divided in five economic regions"*, Zukic said. SDA rejects the initiative of SNSD for pitting the census as an item in the BiH Budget for 2006. Zukic said that this initiative is mere politicisation because without a law on census, the implementation of the Law on Statistics and the establishment of a single statistics structure it is impossible to plan funds for these purposes in the budget. *"We support the position of the European Commission that the census is realistically possible in 2010. By then we need to intensively work on the implementation of Annex VII from the Dayton Agreement and the Constitutional Court's decision on equal status of constituent peoples in BiH"*, Zukic said. SDA supports activities on commemorating the anniversary of the death of **Alija Izetbegovic**. Zukic described Izetbegovic's role as irreplaceable and decisive in the fight for the independence, international recognition and defence of BiH.

Release further reads: <i>"Regardless of somebody's views on <b>Alija Izetbegovic</b>, such a decision – without assent of all three peoples – cannot be reached in BiH, ten years after the war. Still, decision on this is not to be dealt with by the international community."</i></p> <p><b>Nezavisne Novine</b> op-ed pg 7 'A public secret' by <u>Slavko Kukic</u> – Writing about developments in BiH, author also criticizes the initiative for change of name of Sarajevo Airport . He moves on further claiming that Sarajevo might get its counter-part capitals, referring to Banja Luka and Mostar. On this he claims this will happen in the future, since both Serbs and Croats have a right to have their Alija's.</p>   |
| <p>Ashdown:<br/>Agreement not<br/>perfect, but it<br/>is only way to<br/>move forward</p>                      | <p><b>Oslobodjenje</b> pg 3 'Agreement on police leads to Europe' by <u>A.O.</u> – The HR <b>Paddy Ashdown</b> told daily that while the Agreement on police reform adopted by the RSNA is not the perfect solution, he still hopes that BiH parliament will adopt it today as it is the only way to move forward. He adds that in that case, almost overnight BiH will move from Dayton to Brussels phase and will move <i>"towards the time when there will be no more of OHR and Bonn powers will not be needed anymore."</i> However, Ashdown adds that OHR will stop using its powers only when "SDS, the RS, HDZ and all other parties" stop carrying out measures which are damaging this country: <i>"When they stop doing this, than I will stop using Bonn powers. I will not use measures and sanctions and I will be happy because of it."</i></p> <p><b>Dnevni List</b>, pg 8 'Keep entity by police reform, not entities', by <u>Erna Mackic</u> – Carries an interview with High Representative, <b>Paddy Ashdown</b>, in which he explains the course of police reform in BiH. According to the HR, although there is concern in the FBiH about the agreement on the police reform, especially among the HDZ, because the agreement does not mention the cantons, the paragraph 3 of the agreement says that everything must be done in accordance to the BiH Constitution. On top of this, the HR stresses that the EC and US will keep an eye on the implementation of the agreement, which will make sure that there are no political interferences into the implementation process.</p> |

| <p>OHR: Local police to cross IEBL</p>                           | <p><b>RHB, Pink</b> – OHR has called on BiH Parliament’s House of Representatives to pass the agreement on police reconstruction at its session on Friday and open the doors for start of negotiations on SAA with EU. OHR’s Spokesperson <b>Ljiljana Radetic</b> stated at a press conference in Banja Luka that if the BiH parliamentarians seize this opportunity they will show their commitment to Europe and create new political reality in BiH.</p> <p><b>FTV, RTRS, Nezavisne Novine</b> pg 3 ‘Police regions will cross entity lines’ by <b>SRNA</b>, <b>Glas Srpske</b> pg 2 ‘Commendation to police’ by <b>M.Dz.</b> – Radetic also said that the Agreement on police reform will enable police regions to cross the Inter-Entity Boundary Line (IEBL) if necessary. He claims that on one side, SDS , SNSD and PDP interpret this Agreement in one manner, while international community, on the other hand, interprets it differently.</p>  |

Orahovac</u> carries <b>Kasim Trnka, Kresimir Zubak</b> and <b>Mato Tadic</b> who took part in drafting the DPA 10 years ago say that the time has come to change the DPA. Trnka says that the BiH Constitution should be changed and he believes that it would be easy to make it if there were the political will from the RS. Tadic believes that through changes of the Constitution a functional state should be made of BiH in which rights of all 3 constituent peoples would be well protected. Zubak stands for drafting a completely new Constitution, however, if this is not possible corrections of the current one should be made. It is also in favor of the state government with broader powers than those of the BiH CoM at the moment. On the other hand, SDS believes that Burns suggestions are "problematic" and that BiH is not ready for such changes in the current situation. SDA Vice President, <b>Momcilo Novakovic</b> said that it is still too early to discuss this. HDZ spokesperson <b>Miso Relota</b> said that constitutional changes can be agreed on only in the Parliament, adding this party is ready for them.</p> |

**Slobodna Bosna** pgs 18-21 'British Lord admitted capitulation in BiH', mentioned on cover, by Asim Metiljevic – SB obtained the copy of alleged OHR's document titled "Elections 2006", supposedly presented to the Peace Implementation Council Steering Board last week. According to the document, the OHR deems that the current ruling coalition of SDA, SDS, HDZ and two satellite parties – Party for BiH and PDP – is not ready or mature to take over responsibilities in the country concluding they have to leave the authorities. Upcoming elections in 2006 must mark a change of ruling parties, otherwise IC would allegedly have to either give up entirely from BiH or to continue with aggressive approach in the country thus delaying it's process of European integrations. The coalition has already disabled the plan of OHR's withdrawal as of 2005 as planned earlier, as the year was marked with numerous crises in all levels of authorities and obstructions. SB further claims HR **Paddy Ashdown** allegedly advocates lobbying and encouraging of the new authorities comprised of SDP and SNSD and three Croat opposition parties, HSP, NHI and HSS, whose cooperation could be in a form of coalition, union or even a joined party. The document supposedly dedicates entire chapter "*Ally or die*" to the HSP's success in the last few years. As for the Serb political scene, document allegedly proves OHR has no dilemma – SNSD and **Milorad Dodik** are the only alternatives to SDS and PDP. It has been noted "*the rightist Milorad Dodik's rhetoric could be frustrating for non-Serbs*" and make possible [strong] Coalitions with FBiH parties difficult, but the conclusion acknowledges Dodik has not even tried the later. The biggest surprise of the analysis, says SB, is "*OHR admitting*" that the reformatory coalition "*is practically impossible without SPD's participation.*" However, the "*new SDP*" [emerged after 2004 local elections] apparently has two immense problems: "*arrogant leader, Zlatko Lagumdžija*" and a support of the "*old communist intelligence*". However, SDP has been deemed by the OHR as stabile/well organized party as demonstrated in their political campaign against VAT [which, notes SB, OHR doesn't support but still appreciates as professionally carried out action]. Finally, OHR also sees the Party for BiH as a Wildcard, a reserve plan in case SPD lacks Bosniaks votes. While document notes the party has been seen by Serbs as "*light SDA*", its founder, **Haris Silajdzic**, still enjoys very strong support of Bosniak electorate body.
