<p><b>Del Ponte in B. Luka</b></p>	<p>Herceg Bosna Radio, BHTV, FTV, RTRS, Nezavisne Novine cover and pg 3 'Arrests to replace promises'; Glas Srpske cover page story 'Ready to cooperate', Blic, pg. RS1 'She expects arrests by the end of December' by <u>Marija Jandric</u> mentioned on cover 'Del Ponte set December as deadline', Vecernje novosti, pg. 2 'Start implementing what you say' by <u>M. Stevandić</u> – Following yesterday's meetings in Banja Luka with RS most senior officials, Carla del Ponte, ICTY Chief Prosecutor, said that RS is expected to make a serious step forward in cooperation with the ICTY until June Summit of NATO. She also said that RS officials told her there is a political will to cooperate with the Hague, but the Tribunal now expects to see some concrete results. She said: "If the political will, demonstrated by the RS leadership, is applied in all Government institutions, I believe we will soon see results in all aspects of cooperation with The Hague."</p> <p>Del Ponte also expressed hope that Radovan Karadzic would be arrested by the end of this year.</p> <p>Dragan Cavic, RS President, promised that RS would improve cooperation with the ICTY, stressing that they have one month more to demonstrate "operational cooperation" with the Hague Tribunal. Cavic also said that RS can no longer bear the political burden of non-cooperation with the Hague. He said: "After eight years, we must show we have got over the sensitivity of this issue, because the issue of war crimes must be transferred from the sphere of politics into the sphere of justice."</p> <p>Apart from meeting Cavic, del Ponte also yesterday had separate meetings with Mladen Ivanic, BiH Foreign Minister, Dragan Kalinic, RS Parliament Speaker, Dragan Mikerevic, RS Prime Minister, and RS Ministers of MoI, Defence and Justice respectively, Zoran Djeric, Milovan Stankovic and Saud Filipovic.</p> <p>Mikerevic stated that: "We will try to make some results in the coming period – this includes either surrender or arrest of war crime suspects."</p> <p>According to NN inset, del Ponte yesterday also met with the representatives of the RS Association of former inmates, who handed her documentation related to war crimes committed against Serbs. According to Branislav Dukic, President of the Association, the handed material contains thousands of pages of documents, including statements of witnesses, audio, photo and video material. He also said that the Association "is aware the Tribunal is engaged in investigation against some individuals from the war time Bosniak leadership."</p>

<b>BHTV interview with Del Ponte</b>	BHTV – Carla del Ponte arrived in Sarajevo late on Monday and she was interviewed by BHTV reporter <u>Mujo Delibegovic</u> . She said that she would be pleased if war criminals were to be arrested. She said that 5 of them were in RS and that she would be pleased if Radovan Karadzic was to be arrested in a month. She said that Chairman of the Hague Tribunal said that ICTY would not stop with its work until all most wanted war criminals are arrested. She said that Radovan Karadzic was probably in RS. She said that she was not bringing any new indictments adding that there were several more indictment which would be filed by the end of this year, when all further investigations would be stopped.

Vlaho, Dnevni Avaz pg 3 'Today in Mostar, tomorrow in Srebrenica' report that del Ponte is going to visit Mostar today for the first time. DL says that with regard to this visit, citizens of Mostar are expecting that the ICTY will finally process the 'Uborak' case . Slobodna Dalmacija pg 5 'Del Ponte decides on candidacy to EU' <u>not signed</u> announces the visit that del Ponte will pay to Zagreb on June 3 and 4.
<b>SDS on del Ponte's visit</b>	RTRS, Nezavisne Novine pg 3 'Parties cannot take over responsibility of institutions'; Glas Srpske pg 2 'Cooperation is indisputable', Oslobođenje pg 8 'Not only RS is responsible for cooperation with The Hague' – Dusan Stojicic, SDS Spokesperson, yesterday stressed that the cooperation with the Hague Tribunal "is more an institutional issue, rather than an issue to be addressed to political parties". He is of the view that "political parties cannot take over responsibility of institutions. However, RS institutions are not the only address, which should bear full responsibility for the failure to arrest war crime suspects." He said that international factors in BiH and some BiH institutions, such as State Border Service, are also responsible.
<b>Djeric: RS Interior Ministry does its best</b>	Dnevni Avaz pg 3 'RS Interior Ministry does its best' – According to RS Interior Minister Zoran Djeric, the Ministry will do its best and it is already doing what is in its competence to make the cooperation with the Hague Tribunal more quality and better. Djeric told the daily he was satisfied with the meeting with Chief ICTY Prosecutor Carla Del Ponte in Banja Luka on Monday.
<b>SRS on del Ponte's visit</b>	Nezavisne Novine pg 3 'Space for speculations and bargains open'; Glas Srpske pg 2 'Distorting of truth' – Milanko Mihajlica, President of RS Serb Radical Party, yesterday commented on Carla del Ponte's visit to Banja Luka by saying that: "Instead of holding separate meetings, del Ponte should have held a joint meeting with the RS delegation, led by Dragan Cavic, RS President, and in the presence of RS Prime Minister and Parliament Speaker." He is of the view that yesterday's separate meeting created space for various political speculations and various sorts of bargains.

<p><b>SNS on del Ponte's visit</b></p>	<p>Nezavisne Novine pg 2 'Agreement instead of fights' – SNS yesterday released a press statement, in which this party expressed its view that yesterday's separate meetings between the top leadership of the RS and ICTY Chief Prosecutor, Carla del Ponte, show and prove that the top leadership of the RS does not have a strategy in regard to relations with the Hague Tribunal and that such activities have led the RS into unenviable position. SNS press release stressed that the politicians without a vision are to bear responsibility for this.</p>
<p><b>Ivanic, SIPA Director Novic on PFP, cooperation with ICTY</b></p>	<p>BHTV – Mladen Ivanic, BiH Minister of Foreign Affairs said that he expected no consequences if BiH would not be admitted into Partnership for Peace. "Non-acceptance into Partnership for Peace will not bring any kind of catastrophic consequences", said Ivanic. "Our evaluation is that in next several months special department for investigation of war crimes will be established, some activities will be conducted in Department for protection of witnesses and that special squad will be established which will support the Department, "said Sredoje Novic, Director of SIPA. If everything goes by plan, SIPA would be able to start arresting war criminals, by the end of this year.</p>
<p><b>Marsicanin on Karadzic</b></p>	<p>Nacional Belgrade daily, pg. 4 'If it is so easy, why don't you arrest Karadzic' <u>not signed</u> – Presidential candidate Dragan Marsicanin walked through Belgrade streets yesterday with Serbian Prime Minister Vojislav Kostunica, Deputy President of the Government Miroljub Labus, Minister for Capital Investments Velimir Ilic and SPO leaders Vlajko Senic and Vojislav Mihajlovic. They talked to citizens and journalists during their walk. Among other things, Marsicanin stated: 'Demands of the Hague Tribunal are putting us in a position to prove something that is a negative fact. How to prove he is not here? For that matter, why doesn't the International Community prove and implement their obligation – locating and arresting Radovan Karadzic. It is not so simple'.</p>

<p><b>Oslobodjenje: Mladic crosses border by helicopter</b></p>	<p>Oslobodjenje cover page, pgs. 4-5 by <u>Azhar Kalamujic</u> – The BiH State Border Service has been informed that the most wanted war crime indictees had crossed state border with Serbia and Montenegro several time in the past two months at the locations near Srebrenica, Rudo, Cajnice and Visegrad, the daily learns. These are places poorly or not controlled at all by the SBS. The Service has also received information according to which Ratko Mladic has been using helicopter to cross the border.</p> <p>Vjesnik, pg 11 ‘Noose around Mladic tightening?’, by <u>V. F. P.</u> – according to the Belgrade-based ‘Balkan’ tabloid, which called upon a source close to the Council of Ministers of Serbia and Montenegro, former Commander of RS Army, Ratko Mladic, will be arrested and extradited to the ICTY before the country extradites any of its indicted army and police generals (Nebojsa Pavkovic, Vladimir Lazarevic, Sreten Lukic and Vlastimir Djordjevic). The source says the authorities in S&amp;M are not extraditing the four generals because the local September elections are approaching. Furthermore, ‘Balkan’ reads the Serbian authorities are searching after Mladic, but keeping it away from the public because of the forthcoming elections. Apparently, the search has already given certain results.</p>
<p><b>DL: 6 new bills of indictments against Croats</b></p>	<p>Dnevni List, pg 5 ‘Covic, Sanader and Mesic informed about new indictments from The Hague’, mentioned on cover, <u>not signed</u> – the daily learns from its anonymous associate that the ICTY Prosecution has prepared six new bills of indictments against six officers of the HVO, who were allegedly being questioned in capacity of suspects at the OHR premises in Sarajevo, which was confirmed by the security that guards the OHR Sarajevo. DL says the identity of the persons in question is known to the daily, but does not want to expose the officers. DL goes on to say that one of speculations in The Hague says the six officers will be prosecution witnesses in processes against Prlic, Petkovic, Pusic, Praljak, Stojic and Coric. DL’s source says the six officers have already informed the Croatian Prime Minister, Ivo Sanader, the office of Croatian President Stipe Mesic and the Croat member of BiH Presidency, Dragan Covic, about the situation.</p>
<p><b>Radovanovic on PfP</b></p>	<p>Oslobodjenje pg 5 ‘Istanbul’s key is in The Hague’ – BiH Defence Minister Nikola Radovanovic on Monday expressed satisfaction because the technical part of conditions for the BiH’s accession to the Partnership for Peace program had been fulfilled and because BiH in this sense represented a credible candidate for the program. He however added that the full cooperation with the ICTY was the condition yet to be fulfilled.</p>
<p><b>Ashdown: Karadzic is a dark curse</b></p>	<p>Oslobodjenje pg 8 ‘Karadzic is a dark curse’ – SENSE interview with the High Representative Paddy Ashdown. “RS undermines international-legal foundations which its existence is based on and it also prevents the country from accession to PfP, but it still cannot significantly jeopardise bringing BiH closer to European integration,” said Ashdown.</p>

### **PDHR Hays with journalists**

Dnevni Avaz pg 4 Hays: Public debts in BiH reached 27 billion KM', Oslobodjenje pg 10, mentioned on cover 'The laws will bring directors to jail' – Public debt in BiH reached 27 billion KM although the estimations at the beginning of the process to resolve this issues were that it amounts approximately 11 billion KM, said Principal Deputy High Representative Donald Hays at a meeting with journalists in Sarajevo on Monday. In order for this problem to be resolved the appropriate draft laws are already on the tables of BiH Council of Ministers, Entity's Governments and Brcko District Administration. The OHR has also planned a public campaign to explain this issue to the citizens.

Dnevni Avaz pg 4 'Vrankic and Zigic will realize their obligations', mentioned on cover 'Ministers respond to Hays' – FBiH Finance Minister Dragan Vrankic and Industry Minister Izet Zigic commented in the statements for the daily on PDHR Hays' criticism against delay in passing certain laws that were their competence. Vrankic said he was surprised with OHR position since they were fully informed about all the activities related to drafting the law on public funds investment. According to Vrankic it is in no one's interests to adopt poor or inapplicable regulation. Zigic said that the Government had already sent into the parliamentary procedure the draft law on public enterprises. BiH Justice Minister Slobodan Kovac emphasized that the draft law on registration of companies had passed through necessary procedure and it had been sent to the parliament for further consideration and adoption.

Dnevni Avaz pg 4 'Law on audit sent to the Parliament long time ago' – BiH Treasury Minister Ljerka Maric met with the PDHR Hays on Monday. She was not available for comment but Bojan Zec Filipovic, advisor in the office of BiH CoM Chair Adnan Terzic, said for the daily that the draft law on audit and accountancy had been sent to the parliament a long time ago.

Nezavisne Novine pg 5 'Laws in Parliament' – NN carries a comment following most recent statement by Donald Hays, PDHR, who was critical of some officials in BiH over the failure to adopt the Law on public companies.

Nedžad Branković, Minister of Traffic and Communication in FBiH, said that: "The draft Law on public companies was discussed at Government session and following adoption of amendments, forwarded as Law on management of economic sector with majority state capital in FBiH."

He said: "OHR falsely wrote the name of this law. This is a framework agreement on registration of juristic subjects, and not the registration of companies. This Law was adopted in April."



<p><b>Domestic experts on public companies' operations</b></p>	<p>BHTV – Sunday's report on losses of BiH Public Enterprises caused reactions by domestic experts. They claim that the aim of this report is to ruin credibility of the most important State's enterprises, in order to privatise them at lower prices. According to BiH experts, no one denies recommendation of the PDHR Donald Hays by which 5 crucial laws have to be passed in urgent parliamentary procedure, but they believe that pointing out at great losses of BiH Public Enterprises by International Community, presents ground for foreigners to become owners of, for example, Telecoms, at low prices. "Losses cannot be justified by failures in concept which had been used in the process of privatisation, which Donald Hays is responsible for as well. His main problem is the fact that for the first time the domestic intelligence opposed him" said Slavo Kukic, professor on Faculty of Economy in Mostar.</p>
<p><b>NN editorial on public companies</b></p>	<p>Nezavisne Novine op-ed pg 7 'Theft at public companies' by <u>Almedin Sisic</u> – The author is writing about the most recent presentation of Donald Hays, PDHR, who said that 92% of the interviews, the citizens of BiH, are of the view that the thieves run public companies and these officials need to be replaced. The author claims that the citizens of BiH are eager to see whether and when somebody would be held responsible for the loss of BAM 360 million, as established in audit reports for some companies in 2001. The author is also claiming that the judiciary and OHR, the ones who could put an end to these malversations of individuals, that cost BiH much, are not doing much.</p>
<p><b>'Statement of Day': PDHR Donald Hays</b></p>	<p>Dnevni List pg 2 carries in its 'Statement of Day', the Principal Deputy High Representative, Donald Hays, as saying: 'Public companies must be returned to citizens.'</p>

<p><b>FBiH Parliament postpones payment of internal debts</b></p>	<p>Dnevni List, pg 5 'Vrankic: Old foreign currency savings will not be written off', by <u>E. Mackic</u> – The House of Peoples of the FBiH Parliament adopted changes and amendments to the Law on temporary postponement of execution of claims on basis of executive decision, which would affect the FBiH budget. The MPs in the HoP adopted the changes, which were insisted on by the FBiH Government, because failure to adopt the changes would put the macroeconomic stability and fiscal sustainability of the FBiH in jeopardy. According to the FBiH Finance Minister, Dragan Vrankic, the previous moratorium on payment on internal debts that expired on May 31 had to be extended. "The moratorium will be in force until there is a law which solves all ways of payment of internal claims", said Vrankic, explaining that the law in question would not write off the old foreign currency savings. Svetozar Pudaric, an SDP MP, who was against the moratorium, says it is a rare case that a debtor has the ability to postpone its obligations.</p>
<p><b>Freedom House annual report point at corruption in BiH</b></p>	<p>Nezavisne Novine pg 4 'Corruption is an obstacle to Rule of Law in BiH' – The annual report of "Freedom House", the USA non-governmental organisation, reads that the corruption in judiciary, police forces and civil services is an important obstacle to the establishment of Rule of Law in BiH.</p> <p>The report reads: "BiH has four times more judges than Germany (that has the largest number of judges in Europe). However, BiH judges resolve only 25% of cases on an annual basis. The international officials claim there is certain misbalance between basic elements of the Rule of Law."</p> <p>The trafficking in women has been included into the report as one of main problems, with which post-war BiH is faced.</p> <p>Report further emphasises efforts placed by UN Mission on improving border control and hence the number of illegal entries into the state.</p> <p>Commenting on independent electronic and print media, the report states that the media depend on foreign investments in order to survive.</p>

<p><b>NN: Tihic and Covic irrationally spent budget resources</b></p>	<p>Nezavisne Novine cover and pg 2 'Tihic and Covic irrationally spent budget resources' – NN learnt from a service at the BiH Presidency that although deadline expires in two days, by which BiH Presidency should provide response upon audit report on expenditures of BiH Presidency budget resources, the response has not been prepared as yet. Ranko Ninkovic, Secretary General of BiH Presidency, said response is under preparation.</p> <p>NN source at BiH Presidency claims that the audit report is especially unacceptable for Croat and Bosniak members of BiH Presidency, Dragan Covic and Sulejman Tihic.</p>
<p><b>Farmers to distribute products in sign of protest</b></p>	<p>Blic, pg. RS2 'Farmers: we will distribute pigs and chicken for free' by <u>SRNA</u>, Vecernje novosti, pg. 21 'They are protesting and distributing' by <u>N. G.</u> – RS Association of Farmers and BiH Association of Poultry Farmers has announced a public protest that will be held in front of the RS Government building in Banja Luka at 11:00 hrs on June 3 because 'RS Government and delegates at the BiH Parliamentary Assembly have created an issue regarding the enactment of good measures for agricultural production'. The two Associations have issued a press release on this occasion saying that they will distribute pigs and chicken for free to pensioners, whom they have invited to join the protest.</p>

<p><b>Update to oil field in BiH</b></p>	<p>Nezavisne Novine pg 8 ‘Energoinvest” cannot prevent the oil boring in RS’ – Commenting on yesterdays’ media reports in F BiH, the officials of the company Oil Refinery in Serb Brod claim that the Serb Brod Oil Refinery possesses all necessary documentation to implement the project on exploitation of 50 million tons of oil, which can be found at the depth of 2 km in Posavina region.</p> <p>Mika Sukurma, Refinery expert, said that: “Energoinvest wants to cooperate with us and their officials did not tell us they would not give us final document. Still, if we do not get it from them, we will ask for a copy from “Amoc”, the American company that carried out the research.”</p> <p>Dnevni Avaz pg 8 ‘There are a few oil fields in BiH worth to be commercially exploited’ also covered the issue.</p>

<p><b>British Inter-Parliamentary Union delegation visits BiH</b></p>	<p>Herceg Bosna Radio, BHTV, Oslobođenje pg 6 'Stable state way to European integration', Dnevni Avaz pg 4 'HR powers should be transferred to the state institutions', Slobodna Dalmacija last pg 'BiH to Europe independently, without tutors' by F and Dnevni List pg 6 'By reduction of HR's role to stable and self-sustainable state' by Nina, FENA – Reducing the role of the High Representative, i.e. transferring his powers to the BiH institutions, is one of the basic conditions for a stable, self-sustainable state and its road towards Euro-Atlantic structures, it was concluded at a meeting between the British Inter-parliamentary delegation and leaders of the BiH Parliamentary Assembly delegation to the Inter-parliamentary Union in Sarajevo on Monday. "In order for BiH to continue moving towards Europe all sides need to equally cooperate with the ICTY, and the arrest of indicted war criminals should not hold back its admission to European structures", the British guests stressed. During the first day of their visit the British delegation also held talks with members of the BiH House of Representatives and House of Peoples Collegia. BiH House of Representatives Speaker Martin Raguz informed his guests about the functioning of the BiH parliament, current situation and reforms in BiH. His Deputy Sefik Džaferović urged the guests to use their influence and lobby for BiH admission to the Partnership for Peace and the NATO Summit in Istanbul. He said that the state should not be held hostage by any one's non-cooperation with the ICTY and that those opposing it should be sanctioned. House of Peoples Deputy Speaker Mustafa Pamuk said that BiH is the only country in the broader region that does not have its program on the BBC World Service and he therefore requested support and financial assistance for its establishment.</p>

According to NN inset, Zeljko Manojlovic has been sentenced to 2 years imprisonment in March this year. He admitted during the trial that he paid 0.25% of the sum to be laundered to these clerks, who split the money.
