### Constitutional changes

EU Parliament passes resolution which underlines necessity for constitutional changes: changes not crucial for SAA, but for more functional state

BHT1- At the session held on Thursday in Brussels, the EU Parliament adopted the resolution recommending and outlining a necessity for the constitutional changes in BiH to ensure functional state which can complete the negotiations on the Stabilisation and Association Agreement with the EU. EC President Jose Manuel Barroso stated that the beginning of the SAA talks between BiH and EU is a signal of EU's commitment to help BiH. However, Barosso emphasized that there are still many problems to be solved, and he announced he would discuss them with BiH authorities during his visit to Sarajevo on February 18. EU Commissioner from Slovenia Janez Potocnik stated that the changes of BiH Constitution are not only important for the SAA process, but also for the state and all its citizens. Reporter commented that the resolution of the EU Parliament clearly shows that the EU is going to insist on soon completion of the process of constitutional changes in BiH. Hayat – "As the resolution reads, constitutional changes are not crucial in terms of the SAA negotiations; what is crucial is how to make BiH a functional state and how to make progress on its way to Europe", said the Spokesperson to the ECDelegation to BiH, Frane Maroevic. Maroevic added that the EU had no final solution to impose on BiH, but instead expects it come to come out as the result of talks and negotiations between BiH political parties. RHB-Chair of European Parliament's Commission for Southeast Europe Doris Pack presented the resolution and stated that a time has come for BIH to reconsider its internal structure. RTRS, Nezavisne Novine pg 4, announced on cover 'BiH needs a simpler Constitution' by M. Jovic: EU resolution would boost talks on constitutional changes	BN TV current affair program 'Puls' by Suzana Radjen-Todoric – Referring to the passed EU Parliament's resolution urging BiH authorities to continue constitutional reform, Chair of BiH Presidency Ivo Miro Jovic stated that it would only boost the negotiations on this issue since up to now they did not result in the desired way. "If anyone imposes the Constitution we will face the long- lasting crisis" explained Jovic adding BIH has this unique opportunity to change the Constitution and much time. Jovic stated that BIH has finally entered the Brussels phase, which immediately implies Europeanization of BIH standards. "That is the reason why EU more and more emphasises the BIH faults in order for their improvement."
BHT1: talk on const. changes might continue next week, but parties still have same stances	BHT1- According to BHT1 information, the talks on constitutional changes in BiH might continue next week. Parties from FBiH claim that certain compromises have already been reached, and that the talks might bring some results. On the other side, RS parties are still sceptical. SDA leader Sulejman Tihic believes that the solution lies with more pressure from the side of international community over RS parties. "I believe that the EC should change its stance and say that the Stabilisation and Association Agreement can be signed only after completion of constitutional changes", said Tihic. Momcilo Novakovic from SDS announced that this party is not going to accept anyone's opinions regarding this issue. HDZ's Niko Lozancic believes that BiH citizens are aware of the need for constitutional changes, and that the international community shouldn't impose the solutions. SNSD believes that their suggestion for Presidency consisting of one RS and two FBiH members who would rotate every 16 months is a compromise. SNSD's Milorad Zivkovic stated that huge demands of some FBIH parties have prevented the negotiations to end with success. SBiH founder Haris Silajdzic believes that the things shouldn't be rushed, especially if fast solutions mean that most authorities remain at the entity level.

BiH CoM discussed the granting of status of institution of state importance for six cultural institutions and decided that this status could be granted to NationalMuseum, while the request of remaining five institutions needs additional consideration. Miletic said that these persons have been in been put in detention, following their arrest thanks to the information gathered by the BiH Intelligence Agency (OSA). "I believe that we have provided enough evidences and I hope that the BiH Prosecution will file indictments against these persons", said Miletic. Miletic also said that in comparison to 2005, the rate of criminal activities is in decrease, while the number of solved cases is getting higher, as well as that the rate of traffic accidents is also in decrease.
