BiH HoP adopts police agreement	<b>FENA</b> – BiH House of Peoples has adopted the Agreement on restructuring of police structures in BiH at the session commenced this morning.
FBiH HoP to discuss education	<b>RHB, BH Radio 1</b> – The FBiH HoP continued its regular session in Sarajevo today with discussion on labour law/rights issues. An announced special session to discuss education affairs in light of current events will be held in the course of the day.

CoE's monitoring mission meets RS officials	<b>RTRS</b> – The delegation of the Monitoring Mission of the Council of Europe' Parliamentary Assembly has been visiting Banja Luka, during which the delegation has met with <b>Dragan Cavic</b> , RS President, and <b>Pero Bukejlovic</b> . Press statements will be issued later on.
Terzic meets NATO SG Scheffer	<b>FENA</b> – Chairman of BiH CoM <b>Adnan Terzic</b> met with the NATO Secretary General <b>Jaap de Hoop Scheffer</b> at Brussels on Tuesday, when Scheffer congratulated Terzic on adoption of defence laws and political agreement on reconstruction of police forces. Scheffer stressed the necessity of full cooperation with the ICTY and extradition of main war crimes suspects before BiH is to join the PfP.

<p>British Ambassador Rycroft hopes EU Foreign Minister will recommend start of SAA talks with BiH on Dec 12</p>	<p><b>Dnevni Avaz</b>, front pg splash and pg 2 'Green light for BiH on December 12?', by <u>L. Sinanovic</u> – The UK Ambassador to BiH, <b>Matthew Rycroft</b>, told journalists that EU Foreign Ministers, who are to meet on December 12, could give the EC the green light for start of SAA talks with BiH. Asked whether he shares the opinion of some senior officials from Brussels, who believe that BiH authorities seem do not know what they want from the EU, Rycroft says the fact is that the (BiH) Directorate for European integration, the Prime Minister and several other individuals exactly know what they expect, however <i>"there are others who do not share the vision"</i>. He also noted that the full cooperation with the ICTY would be one of pre-requisites for joining the EU, however he did not specifically said whether BiH would be given the same condition like SiCG – extradition of <b>Radovan Karadzic</b> or no membership in the EU. <b>RTRS, Oslobođenje</b> pg 3, mentioned on cover 'Recommendation for talks with EU (to be given) on December 12?', <b>Nezavisne Novine</b> cover pg splash, pg 3 'Negotiations on 12 December' by <u>S.Josovic/M.Cubro</u> – also carried.</p>

<p>Rycroft on OHR future: Transformation of OHR to EUSR to take a year followed by EU decision on final shutting of OHR</p>	<p><b>Dnevni Avaz</b>, front pg splash and pg 2 'Green light for BiH on December 12?', by <u>L. Sinanovic</u>, inset 'Change of status of OHR' carries UK Ambassador <b>Matthew Rycroft</b> as reiterating that as soon as BiH starts with SAA talks, a transformation of the OHR into the EUSR would begin. <i>"That reform would last one year, after which the EU would assess the progress we will have made and take a decision on final shutting down of the OHR. In the meantime, the High Representative and European (Special) Representative would work together. Authorities of the HR would gradually decrease, whilst the EU Representative would not have executive authorities, he would be here to help solving of political problems"</i>, says Rycroft. <b>Oslobodjenje</b> pg 3, mentioned on cover 'Recommendation for talks with EU (to be given) on December 12?' – Daily carries that the candidates for the position of the HR should be proposed official by 28 October. <i>"In any case, there is a plan for completely withdrawing HR Bonn powers by December 2006, and OHR role to transform into EUSR,"</i> says Rycroft.</p> <p><b>RTRS</b> – In a statement for RTRS Radio, Rycroft said that as of January next year, HR will become EU Special Representative. <b>Nezavisne Novine</b> cover pg splash, pg 3 'Negotiations on 12 December', inset 'About Ashdown's successor on 21 October' – Rycroft said that SAA talks of BiH with EU will most likely commence by the end of HR <b>Paddy Ashdown's</b> mandate, who has been the best HR so far according to him. He noted: <i>"One of three candidates from CzechRepublic, Holland or Italy will succeed Ashdown."</i></p>

<p>Terzic departures for Brussels , scheduled to meet Schefer, Solana, Rehn</p>	<p><b>RHB, RTRS, Oslo bodjenje</b> pg 3 'Paving path for talks'- Chairman of CoM <b>Adnan Terzic</b> has departed for Brussels on Monday, where he will meet with the NATO Secretary General <b>Jaap De Hoop Scheffer</b>, EU Commissioner for Security and Foreign Policy <b>Javier Solana</b>, as well as with EU Commissioner for Enlargement <b>Olli Rehn</b>. <b>PINK</b> – Officials will discuss further BiH integration into European and Euro-Atlantic institutions. <i>"What I wish to achieve in Brussels is to get a precise [answers] on what BiH has to do, what the EC has to, having in mind their bureaucratic procedures and the fact that now 25 EU member states have to decide on the content of the agreement"</i>, said Terzic. CoM Chair added that it would be good if BiH succeed on agreeing timing for the start of the negotiations with the EC by mid-December. <i>"That would give us space to sign that agreement perhaps until the (next year's) elections or just after the elections"</i>, concluded Terzic.</p>

<p>BHT 1 comments atmosphere in Brussels regarding BiH has changed significantly, anticipates Terzic visit to have concrete results</p>	<p><b>BHT 1</b> <u>Elvir Bucalo</u> – With regard to the CoM Chair, <b>Adnan Terzic</b>, visit to Brussels, BHT 1 reporter comments that the atmosphere in Brussels regarding BiH has changed completely. This stance was confirmed by the BiH Ambassador to the EU, <b>Lidija Topic</b>, who stated that the preparations for opening SAA talks have already started. EU Commissioner for Foreign Affairs <b>Javier Solana</b> stated that EU expects from BiH to do a lot of work when preparing for start of SAA negotiations on the 10<sup>th</sup> anniversary of Dayton Peace Agreement. Thus, BHT1 says Terzic's visit to Brussels is expected to bring very concrete results. After the positive change of attitude towards BiH in EU, it seems that NATO member countries also have a new, milder opinion on BiH and it's obligation to arrest <b>Radovan Karadzic</b> and <b>Ratko Mladic</b> before the accession to the Partnership for Peace programme. BiH Ambassador at NATO, <b>Sven Alkalaj</b>, stated that it may be possible for BiH to become PFP member state before Mladic/ Karadzic are extradited to Hague. However, this obligation would remain a priority in any case. According to reporter's unofficial sources, date of start of negotiations n SAA for BiH might be set by the end of this week.</p>

<p>Terzic, Lagumdzija discuss SAA talks preparations: parties to meet to agree on joint activities</p>	<p><b>PINK, RHB, Hayat, FTV, Oslobođenje</b> pg 7, mentioned on cover 'No consensus on how to go to Europe', <b>Dnevni Avaz</b> pg 2 'Terzic: We need consensus on ways how to get to Europe', <b>Nezavisne Novine</b> pg 3 'No consensus on how to go to Europe' by <u>M.Cubro</u>, <b>EuroBlic</b> RSpg 3 'They are in search of European path from Bosnian macadam road' by <u>D.S.</u>, <b>Dnevni List</b> pg 3 'Ruling parties and opposition together for Europe' by <u>E. Kristo</u>– Before BiH starts the negotiations with the European Union, it is absolutely necessary to form expert teams on the state level, which would conduct those negotiations – concluded BiH Council of Ministers Chair <b>Adnan Terzic</b> and SDP President <b>Zlatko Lagumdzija</b> after the meeting in Sarajevo. They agreed that there is a consensus in BiH about its admission to EU, which makes it even more important to define the way it should be done. The main reason for the meeting was the letter Lagumdzija sent to Terzic and BiH House of Representatives Chair <b>Nikola Spiric</b>, in which he urged them to reactivate activities included in the agreement on parliamentary parties' support to BiH's European path made reached in 2004. <i>"I am sure that we all want to join Europe, but we still don't have a consensus on how to go through with our European path"</i>, said Terzic. He agreed to create an action plan for conducting the negotiations with the EU, until the meeting with the leaders of political parties on this issue is held. HoR Chair Spiric should be the one to convene this meeting. Asked by the journalists how will BiH get the green light for SAA talks without the PBS law adopted, Terzic said that this law is in its final stage of adoption. <b>BHT 1</b> – Terzic and Lagumdzija have signed the platform on joint tactics of negotiations on SAA. Political leaders of all parties should approve this platform as well.</p>

Medunjanin</u> – The Federation of BiH House of Representatives (HoR) on Monday did not support the changes to the Law on sale of apartments with tenancy rights. If this law was adopted, it would allow occupancy rights holders to purchase nationalised apartments in which they are living for decades, as well as financial compensation to earlier owners. At the Monday's session, only SDP representatives supported those changes, SDA representatives abstained from voting while HDZ representatives were against the changes. FBiH HoR rejected the amendments to the Law which would allow purchase of all nationalized apartments expect those initially owned by legacies, foundations such as Vakuf, after which the FBiH Urban Planning Minister <b>Ramiz Mehmedagic</b> withdrew legislation from the procedure.</p>

<p>Beta interview with Wolfgang Petritsch: DPA reform necessary</p>	<p><b>RTRS, Glas Srpske</b> pg 5 'A step – made backwards' by <u>Beta</u> – Former HR to BiH <b>Wolfgang Petritsch</b> has assessed that a reform of the Dayton Agreement was necessary in order for BiH to become a country that can negotiate with EU. He noted that ten years since the Dayton Agreement was signed, the international community in BiH should make one step backwards and let BiH start deciding on its future alone. He also assessed it is the time to move on, considering the fact a significant progress was made in development of bodies and institutions, as well as in return of property and refugees. He said BiH now needs a rational model of the Constitution in order for it to resemble to European countries. He said BiH needs a government, while its administration should be more of a public service than a bureaucratic system. Asked whether a change of the Dayton Agreement or the Constitution would represent a threat to survival of RS, Petritsch said this was an unpleasant issue but added: <i>'RS is made of people who live there and they must get a perspective of EU, new jobs, better education. This, not a piece of paper, will decide on whether RS would survive or not'</i>, Petritsch said.</p>

<p>Sarajevo dailies strongly criticize Dodik's 'federalization or separation of BiH' rhetoric displayed in last week's interview to RTRS</p>	<p><b>Oslobodjenje</b> pg 9 'In a glory of genocide' by <u>Zija Dizdarevic</u> – Commenting the interview SNSD leader <b>Milorad Dodik</b> gave to RTRS show 'Oci u oci' last Friday, the author focuses at the Dodik advocating the constitutional changes in a manner that would define the RS as the Federal unit. He is highly critical of Dodik's presentation – federalization or separation of BiH – calling his statements as the <i>"harshest threat for BiH and Bosniaks since Karadzic had threatened they would be extinct."</i> In this light, author notes that Dodik's desire is to seal BiH fate in accordance with the Serb plans in 1992 – for this purpose he makes fun of <b>Paddy Ashdown</b>, but praises US Under Secretary <b>Nicholas Burns</b>, who did not question RS existence, and former PDHR <b>Donald Hays</b>, whose proposal for new BiH Constitution includes the RS. <p>Both primary and secondary school pupils (Croats) in Zepce area do not attend classes</p>	<p><b>FTV, BHT1, Slobodna Dalmacija</b> last pg 'Croat students do not attend classes' by <u>P. Marincic</u> – Croat pupils in all secondary schools in the area of the Zepce Municipality will not be attending classes as of October 18 (today). This decision was passed at the meeting of parents of primary and secondary school pupils held on Monday. SD says that this decision has resulted in complete suspension of classes in the Zepce primary and secondary schools. The reason for such decision is unfulfilling of the demand for giving up the 9-year primary school education according to the Croat curriculum until conditions for it were not met. They also demand passing of the decision about transferring of powers in the domain of education at the Municipality.</p>
<p>VL: 35.000 people sign petition for separation of RS</p>	<p><b>Vecernji List</b>, pg 8 'As many as 35.000 Serbs want separation', by <u>B. S.</u> – The 'Serb People's Movement' (Srpski Narodni Pokret) has collected 35.000 signatures for separation of the RS from BiH. The Movement was collecting signatures at Banja Luka 's 'Krajina Square ' on Monday.</p>

<p>Dodik, Kondic acquitted of charges</p>	<p><b>RTRS</b> by <u>Nada Arlov</u> – Former RS Prime Minister <b>Milorad Dodik</b> and former RS Minister of Finances <b>Novak Knodic</b> were acquitted of charges for abuse of position. Verdict was passed by the Council of Banja Luka Basic Court. Dodik and Kondic stated that they have had full trust into the Court, stressing that they were convinced that justice would prevail. Chairman of Court's Council <b>Spasen Keleman</b> stated that evidences have shown that all decisions that Dodik and Kondic were incited for were passed by the Government, thus the Council has acquitted them. Defence Attorney <b>Krstan Simic</b> stressed that this case is a proof that pressures on judiciary exist, adding they must end, while Prosecutor <b>Milenko Delic</b> didn't want to comment this, adding that he assumes that appeal will be submitted to the Court's verdict. <p>VL: BiH Prosecution wants to arrest Covic this week?</p>	<p><b>Vecernji List</b>, front pg splash 'Arrest of Covic and Lijanovics being prepared?' and pg 3 'Dragan Covic will be arrested this week?', by <u>Zoran Kresic</u> – VL claims to have learned from sources close to the BiH Prosecution and FBiH police that the Special Department of the BiH Prosecution (for organized, economic crime and corruption) is planning to arrest the President of HDZ, <b>Dragan Covic</b>, this week in order to prevent him from escaping BiH the same way <b>Ante Jelavic</b> did. Similar thing could happen to other indictees in the 'Covic and others' case.
