<p>RS police in search in Zepa</p>	<p>RTRS – Spokesman of RS MoI, Radovan Pejic, confirmed to RTRS that the RS special police unit is engaged in raiding of several facilities in the Zepa area acting upon an information that a war crimes suspect from the ICTY's public list could be present in the said area. The operation started at 04:00 hrs this morning (Wednesday), however Pejic could not confirm which indictee is in question. He said that more details regarding the action will be made public later on. Pejic could not confirm neither deny media speculation saying that search after General Ratko Mladic is underway. He also said that RS police is undertaking this action by itself. BH Radio 1, RHB – also reported.</p>

<p>Decertified police awaits results of CoM session</p>	<p>BH Radio 1 by <u>Mirsad Bajtarevic</u> – Decertified policemen from both entities decided to freeze hunger strike, while expecting outcomes of an extraordinary session of the Council of Ministers in session today Wednesday. UN Security Council has the mandate to solve the issue, said presenter, dealt with by the UN IPTF. BiH Human Rights Ministers Mirsad Kebo should submit the report to that should also be discussed by BiH Presidency. Together with Foreign Ministers Mladenom Ivanicem, Kebo has planned meetings with Ambassadors of states that are permanent members of UN Security Council. RS Decertified Policemen Association Zoran Bijelic said that continuation of hunger strike depends of BiH CoM decisions. RHB also reported.</p>
<p>Ashdown calls on CoM to bring decision on SIPA seat</p>	<p>FENA – HR Paddy Ashdown called on the BiH CoM to pass the decision on the permanent SIPA seat at the BiH CoM's session that is to take place on Thursday. During today's visit to the SIPA's temporary seat the HR warned that further SIPA's work is being obstructed since the decision on its permanent seat has not been passed yet.</p>

Talks on constitutional changes

<p>Talks on constitutional changes end without reached agreement: RS/ FBiH parties accuse each other</p>	<p>FTV – After two days of talks on constitutional changes, the leaders of eight BiH parties failed to reach an agreement on the BiH Presidency and Parliament. SBIH leader Safet Halilovic stated that the talks failed since RS parties insisted on introducing entity voting in BIH House of Representatives. SDA leader Sulejman Tihic stated that parties had 2 concepts on how BIH as a state should function. <i>“We were trying to find something in between in the end”</i>, says Tihic. SNSD leader Milorad Dodik stated that the package of changes was not adopted since FBiH parties failed to agree on voting in BIH HoR. SDS leader Dragan Cavic feels that the talks failed since the attention was drawn to political issues rather than functional ones. <i>“My impression is that Bosniak parties were trying to find a guilty party rather than solutions”</i>, concluded Cavic. PDP Chair Mladen Ivanic also feels that the talks failed. RTRS – <i>“Talks have been interrupted, they have not failed, a pause has been made since we have entered the final, somewhat critical phase and all achieved agreements need to be recapitalized”</i>, said Tihic. <i>“Talks have faced total debacle. Responsible ones are those from the RS who wanted to turn everything into an entity-based decision-making process”</i>, added Halilovic. Hayat – HDZ leader Dragan Covic noted that not everything planned was agreed on, however noted that large part of job has been done. Dnevni Avaz pg 2 ‘Marathon talks cancelled with no agreement on key issues’ by A.M. – DA carries comment by SDP leader, Zlatko Lagumdzija, reminded that there is one month before expansion of the deadline for constitutional changes agreed in Washington. However, he expressed scepticism success would be achieved. RTRS – RTRS comments negotiations were ceased because RS politicians did not want to accept the requests of FBiH parties for reducing authorities of the entities, election of one BiH President and no rotation. *“All issues faced explicit rejection and denial of entity structure by Bosniak politicians, which the RS reps found unacceptable, even though we have presented some solutions which could have led towards compromise”,* said **Dragan Cavic**. *“The RS reps were willing to accept certain solutions, but the FBiH reps rejected to accept entity voting in terms of the BiH HoR which led towards the failure”,* said **Milorad Dodik**. *“Attempt to change entities in the course of constitutional changes is something we neither can nor want to accept”,* said Ivanic. Prior to the end of the meeting, consensus had been reached when it comes to BiH House of Peoples dealing with the issue of the vital national interest and BiH HoR being a key body for adoption of the laws, however disputes appeared in terms of appointing the representatives to the Houses. **BHT1** – **Sulejman Tihic** says: *“The President will be elected for 2 years with a possibility of re-election for further 2 years.”* *“It is evident that this team cannot make any agreements and it is evident that negotiations are completed”,* says Ivanic. He also stated that new negotiations could be expected after next elections.

Oslobodjenje pgs 4,5 ‘Parties from RS ready to continue after elections’ by **A.O.** – SDS’s **Momcilo Novakovic** said that parties from RS have been ready to reject the principle of rotation within BiH Presidency, demanding at the same time entity principle of voting to remain, but SDA leader **Sulejman Tihic** didn’t accept that. Claiming that lot of issues have been agreed, Novakovic accused parties from FBiH for failure of negotiations, since *“they intended abolishment of entities”*. SBiH’s **Gavrilo Grahovac** stated the party leaders would try to agree on continuation of talks with international mediators. **Nezavisne Novine** pg 3 ‘Dodik: Continuation is possible after elections’ by **D.Muminovic, V.Popovic** – Also notes Serb negotiators were demanded to give up on their rotation stance, and Tihic was asked to accept the entity’s way of voting at the HoR. **Glas Srpske** pg 5 ‘Burns could not help either’ by **Z.Markovic** – GS reports the same, adding Ivanic confirmed **Nicholas Burns** talked with some participants of the talks, adding the important issue is that the Serb negotiators were unified.

<p>Tihic: lousy solutions will not be accepted</p>	<p>Oslobodjenje cover splash, pgs 4-5 'America stands behind unified BiH' by <u>A.Omeragic</u>, Inset 'We would not accept lousy solutions' by <u>Mi.D.</u>- Addressing the public debate on 'Current political affairs in BiH' SDA leader Sulejman Tihic stated that some are criticizing these negotiations in advance, emphasizing that hard work and patience would lead to best solution. <i>"But in any case we would not allow acceptance of lousy solutions in this process of constitutional reforms"</i> said Tihic.</p>
<p>Dodik: talks on constitutional changes to continue after elections</p>	<p>Oslobodjenje pgs 4,5 'Parties from RS ready to continue after elections' by <u>A.O.</u> – Oslobodjenje carries that RS parties are willing to continue talks on constitutional changes after October elections. SNSD leader Milorad Dodik stated for daily: <i>"After elections, there would probably be space for newly elected authorities to discuss these issues, if they have political will"</i>. Nezavisne Novine pg 3 'Dodik: Continuation possible after elections' by <u>D.Muminovic, V.Popovic</u> – Dodik stated that there is no possibility for continuation of talks until after elections. He also said he did not regard the large engagement of the international mediators, especially US Ambassador, as pressure, admitting that the fact talks lasted for 18 hours with breaks after four hours of talks represented a sort of pressure.</p>

<p>IC representatives disappointed with outcome of constitutional talks</p>	<p>PINK by <u>Zeljko Mandic</u> – At the press conference on talks on constitutional changes, the U.S., UK and Austrian Ambassadors to BiH, Douglas McElhaney, Matthew Rycroft and Werner Almhofer respectively, and the Head of EC Delegation to BiH Michael Humphreys expressed their dissatisfaction with the failure of talks but pointed out that there is still time to introduce the changes in the BiH Constitution which would ease BiH's path to the EU easier.</p> <p><i>"Unfortunately, the parties find themselves in a dead-end in terms of several remaining issues referring to the BiH Presidency and Parliament. I have to be honest and say that I am disappointed"</i>, said McElhaney and added that the agreement could be reached if the leaders show political will. Humphreys said that if agreed issues are to be implemented in terms of the BiH Council of Ministers, BiH would have a strong Government with two new Ministries in charge of implementing all the agreements reached in the Stabilization and Association Agreement talks. <i>"Bearing in mind that BiH is about to start SAA talks with the EU, it needs stable Government, able to reach decisions and implement them"</i>, explained Humphreys. Hayat-<i>"As this is the case for countries in transition, we can refer to this as something in between; and when something is in between it must be a platform for future negotiations"</i> commented Almhofer. <p>IC will not give up on const. changes</p>	<p>Oslobodjenje cover splash, pgs 4-5 'America stands behind unified BiH' by <u>A.Omeragic</u> – U.S. Ambassador to BiH Douglas McElhaney on Tuesday told press conference that speculations on Washington supporting the trade with certain parts of BiH. <i>"US interests are consistent and have not changed in last ten years in BiH and the region. Status of BiH as unified state was solved in Dayton"</i> said McElhaney. Head of EC Mission to BiH Michael Humphries stated that there are no new conditions for BiH on its path to EU, but added that BiH institutions would have to be harmonized with European standards. <i>"In that process, let me be clear, more changes would have to be made."</i> Olli Rehn said that in several occasions" stated Humphries. Dnevni Avaz pg 3 'McElhaney: We would not back down from demand for constitutional change' mentioned on cover, by <u>S. Numanovic</u>– McElhaney stated that negotiations would continue, that these were the first steps made. Ambassador emphasized that difficult decisions are before the BiH authorities adding that there are some indications of politicians being ready make a difficult decisions. Mathew Rycroft explained why the IC would not back down from constitutional changes. <i>"There are three reasons for it. First, functionality of the state, which demand existence of the system that works for citizens of this country. Second reason are human rights, third, and most important, reason are preparations for European integrations"</i> said Rycroft.</p>
<p>Tokic: SRS demand for referendum can't threaten BiH or the RS</p>	<p>Hayat By <u>Snjezana Mulic</u> – Reporter comments that only those naive would not doubt timing of negotiations on BiH constitution and status of Kosovo. RS Serb Radical Party (SRS) asked the RS parties involved in the negotiations on const. changes to include amendment on the right for separation and to define the issue of referendum. Reporter noted that, interestingly enough, this request, originally submitted by SNSD two months ago, arrived at the same time when some Serbian officials suggested exchanging Kosovo and RS. Leader of SDU Sejfudin Tokic believes goal of this campaign is to destabilize BiH.</p>
<p>Lazovic: different approach to negotiations necessary</p>	<p>Dnevni Avaz pg 2 'There was no response to ultimatums from RS' by <u>A.M.</u>– SDU vice-president Miro Lazovic believes that negotiations on constitutional changes failed as politicians constantly run away from fundamental issues. He adds that SDA, SBiH and SDP did not have the adequate response to non-compromising stances from the RS and that the approach to the negotiations must be changed.</p>

<p>NGOs wrote to Hays: we would boycott elections if our demands on negotiations aren't fulfilled</p>	<p>Dnevni Avaz pg 2 'You approached the negotiations in formalist and cosmetic manner'- NGOs of war veterans, POWs and women of Srebrenica sent an open letter to official of the US Institute for Peace, Donald Hays, criticizing the model for constitutional changes. <i>"When you worked in the OHR you were disgusted with obstructions coming from the RS side, today in a different role, you approach negotiations in formalistic and cosmetic manner"</i> reads the letter. NGOs added that they would be forced to use all necessary means, such as boycott of elections or mass demonstrations if their demands are not met.</p>
<p>Halilovic: announcements for new round are only alibi for failure</p>	<p>Dnevni Avaz pg 2 'Announcements on new round are alibi for failure' by A.M.— Referring to the announcements of continuation of talks on const. changes by the end January, SBiH leader Safet Halilovic commented this was an alibi for a failure.</p>
<p>DL op-ed: Cardinal Puljic asks for Sanader's help because he does not trust Covic</p>	<p>Vecernji List, pg 2 'Amendments without support of Parliament', by <u>Zoran Kresic</u> – Ascertaining that the constitutional reforms talks have ended in failure, <u>Kresic</u> notes that even if the parties start drafting constitutional amendments, it is hard to expect that the amendments would be supported in the BiH Parliament, owing to different positions of the negotiating parties. VL also notes that the parties could not reach an agreement even after the phone calls from the US Under Secretary of State, Nicholas Burns.</p>
<p>VL: Possible constitutional amendments would not be supported by BiH Parliament</p>	<p>Oslobodjenje pg 9 'Red cloth' <u>op-ed by Senka Kurotovic</u> – Commenting US Ambassador Douglas McElhaney's statement that IC will not give up on their commitment for BiH to become more functional, author says that such argument is like a 'red cloth' for domestic politicians: everybody interprets it in its own way. Author ironically comments that failure of negotiations has been surprise only for international politicians; BiH people would be surprised if the talks were successful. Sarajevo-Washington hot line didn't help as well, says author, concluding <i>"when that fails, sanctions are usually to follow."</i></p>

<p>Oslob. op-ed: Sanctions to follow?</p>	<p>Dnevni List, pg 2 'Cardinal Puljic does not trust Covic!', by <u>Resad Dautevendic</u> – Commenting on the visit of Cardinal Vinko Puljic at the Croatian Prime Minister, Ivo Sanader's, when Puljic asked from the PM to protect the Croats in BiH, <u>Dautevendic</u> notes this is clear message that Puljic does not trust the leader of HDZ BiH, Dragan Covic, the man who leads the party that represents the Croats in the constitutional changes talks. The author says it is Covic who is at fault for the situation because he caused rifts in the HDZ and because he is subjected to numerous criminal proceedings, which makes Covic very vulnerable and who can be easily blackmailed during the constitutional changes talks.</p>
<p>NN op-ed: the Bosniak parties should have respected the fact that many efforts were handled by the Serb side over the past year</p>	<p>Nezavisne Novine op-ed pg 7 'A state that can be' by <u>Anton Kasipovic</u> – Commenting on constitutional changes' talks in BiH, the author notes that there are many people like himself in BiH, who have received and sent many messages greeting religious holidays to their colleagues, stressing that BiH with such people is possible. He emphasizes that if the politicians had acknowledged this team work and recognized problems of the state on the other side of the negotiating table, this opponent would not have evaded defeat. He concludes by saying that there had been no joint opponent, but politicians played against each other. He also notes that the Bosniak parties should have respected the fact that many efforts, referring to reforms, were handed by the Serb side over the past year, including defence and police reforms, unification of tax policy, etc.</p>

According to him, it is clear at this moment initial steps towards constitutional changes have been made, and this course must continue and proper solutions for BiH Presidency and Parliamentary Assembly must be reached. He concludes: <i>"It is left upon BiH leaders to demonstrate will that hard and necessary compromises must be reached, not only because of promises they gave, but for the sake of those who elected them."</i></p>

EUFOR spokesman James Gatter stated that EUFOR received information on the weapons from local inhabitants. RS MoI Spokesman Radovan Pejic confirmed that local police participated in the action. He wouldn't reveal any details on amount of discovered weapons. Pasic, Glas Srpske pg 2</p> <p>'Obstruction of justice'- The High Representative to BiH Paddy Ashdown said that by not implementing its legal tasks in terms of decision of the Human Rights Chamber within BiH Constitutional Court on Avdo Palic's case Human Rights Committee Hu, the RS Government was obstructing the justice. On October 3rd, 2005, the Commission for Human Rights extended the deadline to the RS Government by which it should meet the decision of the Chamber, namely to submit all information it had on Avdo Palic from Zepa, who has been missing since 1995. <p>BiH Prosecution denies report that it is conducting investigations against former Croatian PMs</p>	<p>Dnevni List, pg 2 'Investigations are not being led against former Croatian Prime Ministers', by <u>HINA</u>, Slobodna Dalmacija pg 4 'BiH: There is no investigation against Sarinic, Valentic and Greguric' by <u>H</u> – Secretariat of the BiH Prosecution denied a report published in print media of Tuesday (see OHR Media Round-up, Jan 17) that the Prosecution is conducting an investigation against former state and military officials of Croatia for alleged crimes against the BiH Serbs. The explanation from the Prosecution says that the criminal report, which was submitted by the Trebinje Public Security Centre, has been given to a prosecutor who is to see whether there are elements of the crime stated in the report.</p>

Police has confiscated his computers and ordered him to turn off his website. RHB, Hayat– also carried.</p>

<p>DA: Karadzic willing to be arrested for 5mil € ;EuroBlic: negotiations on Mladic surrender ongoing, his family possibly to receive US \$ 5 million</p>	<p>Dnevni Avazpg 12 ‘Karadzic will be arrested in set up action on Cyprus’ by <u>E.Sarac</u> – DA speculates that Radovan Karadzic could be arrested when Cyprus by the same pattern as Ante Gotovina. Serbian Security Intelligence Agency [BIA] allegedly organized Karadzic’s trip to Cyprus, providing him with the fake passport. DA speculates that Karadzic accepted to be arrested for € 5 million. EuroBlic pg 2 ‘Foreigners are giving five million dollars for surrender’ by <u>Tanja Nikolic Djakovic</u> – A source of <i>EuroBlic</i> claims the official Belgrade will, at the next meeting with ICTY Chief Prosecutor Carla del Ponte, give its consent for establishment of a joint team composed of domestic and Hague intelligence agents with an aim to locate Hague indictee Ratko Mladic. The source also claims it is quite possible that there are ongoing negotiations with Mladic with regard to providing his family with US \$ 5 million in an exchange for his surrender. According to the source, a foreign country is involved in negotiations as well, adding it is possible Mladic would be transferred from Serbia to some foreign country where he would either surrender or be arrested.</p>

RTRS by Sandra Kalacanic – At the press conference, held on Tuesday, the BiH Helsinki Committee for Human Rights presented the report which notes the beginning of the talks on the Stabilization and Association Agreement was the most important political event in 2005. The report also reads that situation with human rights is burdened with the fact that **Radovan Karadzic** and **Ratko Mladic** are still at large. BiH has been established as an expensive and inefficient state, while the Dayton Peace Agreement neglects citizen as an individual, said the Chair of the Committee **Srdjan Dizdarevic**. Even though a part of the DPA dealing with human rights issues had to be changed, in 2005 no agreement between the leading political parties has been reached, due to what no constitutional changes took place, said Dizdarevic. *“International relations in BiH are still burdened with efforts of leading nationalistic parties to preserve ethnical homogenization, including territorial divisions”*, said Dizdarevic. **RHB, PINK, Hayat, BHT1, FTV, Dnevni List**, front pg splash ‘Education of children is still ethnically coloured’, by Danka Polovina-Mandic, **Nezavisne Novine** pg 4
‘The most vulnerable categories are refugees, children and ethnic minorities’ by S.Lemo – carried reports from the press conference.

<p>Decertified police officers cease hunger strike following meeting with Kebo</p>	<p>BHT1 by <u>Irena Kljajic</u> – After they protested before the OHR building for two days, decertified policemen ended their hunger strike asking after the meeting with the BIH Minister for human rights and refugees Mirsad Kebo. Kebo promised that this issue would be on the agenda of an extraordinary session of the Council of Ministers scheduled for Wednesday. Chair of FBiH Association of Decertified policemen Ramo Suljic repeated the demands of policemen for audit of decertification process carried out by UN IPTF. RS and FBiH Union of policemen support the demands of decertified policemen. Vrhovac Mihajlovic– As for Refinery, the management of the refinery stated that its loss was estimated to 89 million KM, while the audit proved that the amount is higher by 27 million KM.
