Agreement on Constitutional changes

BiH political leaders reached agreement on constitutional changes; President and Vice-Presidents to be nominated from directly elected MPs in BiH Parliament

BHT1– Leaders of seven major political parties [SDA, HDZ, SDS, SDP, SNSD, PDP, HNZ] reached the agreement on constitutional changes at the meeting held in the residence of US Ambassador **Douglas McElhaney** in Sarajevo on Saturday. They agreed on the method of election of BiH Presidency members, which was the last remaining unsolved issue regarding constitutional changes. HDZ President **Dragan Covic** explained that according to this agreement, all directly elected members of BiH Parliament Assembly are potential candidates for position of BiH President and two Vice Presidents. 20% of BiH House of Peoples members or 10% of BiH House of Representative members can propose one candidate each. After that, HoP makes a list of three candidates that must be approved by BiH HoR. **PINK**– *“By this agreement, neither one party got what asked for nor wished; this is the result of a compromise... BiH and its citizens got the most,”* said **Sulejman Tihic**, SDA leader. *“We all should work on getting set of amendments that are in accordance with the Agreement to the Parliament as soon as possible”* said **Dragan Covic**, SDS Leader. Covic explained that these amendments would enable implementation of agreed changes in time for upcoming election. *“We all know that it is going to be hard to get votes of two thirds of Representatives in both Houses. But we expect that. We know that there are some that would oppose it such as SBiH and SRS “Dr. Vojislav Seselj”*”, said **Zlatko Lagumdžija**, SDP leader. *“I expect that after this agreement, messages from Brussels would be more positive on Monday”*, said **Mladen Ivanic**, PDP Leader. *“This is compromise and it represents harmonization of the Constitution regarding functioning of BiH institutions with current European practice”*, said **Milorad Dodik**, SNSD Leader. **RTRS** – *“I feel this (agreement) as confirmation that BiH can make decisions on its own. This is the moment when the international community as protector will reduce its role”*, said Dodik. **RHB, Hayat, FTV, RTRS, Dnevni Avaz** cover splash ‘McElhaney: this is good for everyone in BiH’ pg 2 ‘Package of constitutional changes goes to parliamentary procedure’ by A.Malagic, **Oslobodjenje** cover splash and pgs 4-5 ‘State deputies will elect members of BiH Presidency’ by A.Omeragic, **Dnevni List** pg 2-3 ‘Constitutional changes signed’, mentioned on cover by **Resad Dautefendic**, – carried similar report.

It was stated that political leaders have agreed to increase number of deputies in both Houses of BiH Parliament and to enlarge Council of Ministers. Laws are still to be passed by simple majority, with obligation that every decision gets votes of at least of one-third of deputies from each entity. BiH House of Peoples would serve as protective mechanism for vital national interests and would not be passing laws. CoM would pass decisions by simple majority, where minimum one Minister from each people have to support it. Chairman of the CoM would now be a Prime Minister and would have authority to replace certain number of Ministers.</p>
<p>HDZ' Covic: I see no reason for Croat MPs not to support this agreement</p>	<p>Vecernji List cover splash and pg 2 'Croats would elect their Presidency member' <u>by Zoran Kresic</u>– Talking about reached agreement on constitutional changes HDZ leader Dragan Covic in statement for VL expressed his satisfaction, stressing that equality of all three peoples is now insured at the state level. Asked about announced boycott of HDZ deputies, Covic said <i>"I see no reason for Croats MPs not to support this agreement, because they would approve 'status quo' which is the worst for Croats"</i> said Covic.</p>

Dnevni List pg 2 'Croats insured election of Presidency member' <u>by A.Vrebac</u>– in a statement for DL, Brkic said that Croats gained most with such election of BiH Presidency. <i>"Namely as of now Caucuses would elect its members of Presidency, and would not be possible for Bosniaks and Serbs to elect President for Croats, as was the case with Ivo Miro Jovic"</i> said Brkic. <i>"I do not believe that such agreement would pass the parliamentary procedure, since it would not be supported by SBiH and as it is expected by HDZ as well"</i> said Brkic.</p>

<p>BiH political leaders inform US State Secretary Rice about reached agreement; second round foreseen for after elections</p>	<p>RTRS-US Ambassador to BiH Douglas McElhaney believes that BiH by this agreement fulfils commitments that took in November 2005, which were part of the declaration that BiH politicians signed during their meeting in Washington with US State Secretary Condoleezza Rice, and that is being closer to the EU and NATO. <i>"Parties wrote a letter to the US Secretary of State Condoleezza Rice and informed Rice that fulfilled commitments that took in November last year in Washington DC"</i>, said McElhaney. PINK– <i>"We agreed to change the Constitution and propose Laws that would establish Presidency with one President and two Vice Presidents, strengthen power of BiH Government and BiH Council of Ministers, establish more efficient Parliament and strengthen protection of human rights"</i>, said leaders of SDS, SDA, PDP, SDP, HDZ, SNSD and HNZ in the joint letter that sent to US State Secretary. Hayat– Austrian Ambassador to BiH Werner Almhofer and Great Britain Ambassador to BiH Mathew Rycroft have also attended the talks. Some citizens stated that they cannot see why Lagumdzija and Sulejman Tihic are excited that much when the agreement is terrible. Citizens also expressed concern with the fact that everything was closed for the public and 'wrapped in veil of secrecy' believing that "arrogant politicians" deceived them.</p>

Boric expressed satisfaction with the reached agreement on the constitutional changes adding that Leaders did show that they could reach the agreement without International Community's interference. <i>"I agree that IC was present at the talks but they stated that the agreement should be reached by BIH politicians and that they will not impose a single decision. I would like to live in a country without IC but this is our reality"</i> commented Boric. Milosevic's funeral

<p>Milosevic buried in Pozarevac, despite harsh objections of his family</p>	<p>FTV– Seven days after his death in ICTY detention cell, former Serbian President Slobodan Milosevic has been buried in his family tomb in the yard of his house in Pozarevac. Several thousands attended the funeral. However, there were no members of his family or SCG officials. His daughter Marija Milosevic harshly opposed the location of burial, claiming that her father shouldn't be buried in the yard of a house that belongs to his wife's family.</p> <p>She announced that she would demand excavation and new burial in Montenegro, where Milosevic family originates. The funeral was among others, attended by former US state prosecutor Ramsey Clark, President of Russian Communist Party and Ambassadors of China, Cuba and Russia.</p> <p>50.000 – 100.000 of people gathered for commemoration ceremony in Belgrade, among them also a number of people from RS and Croatia. RHB, PINK, BHT1, Hayat, RTRS– carried similar reports. It was stated that even on Saturday citizens in Banja Luka have displayed Milosevic's picture at the square where people placed their flowers and lit the candles while 'Glas Srpske' featured the obituaries.
Mothers of Srebrenica say that too much attention was given to Milosevic's death	BHT1 – BHT1- Commenting Slobodan Milosevic's funeral, members of Association "Mothers of Srebrenica and Zepa Enclaves" Munira Subasic said that Milosevic was the greatest war criminal after Adolf Hitler , claiming that too much attention has been paid to his death. Another member of this Association Kada Hotic said that living in a country where Milosevic is being so honoured, she fears for the future of her grandchildren.
Protests against Milosevic and his supporters on streets of Belgrade	BHT1 – At the same time when commemoration ceremony for Slobodan Milosevic was held, several thousands of his opponents gathered in Belgrade to protest against Milosevic and those honouring him. Media broadcasted that mainly young people attended this protest, while mainly old ones attended the funeral. It is interesting, as media informed, that protesters were invited to protests by SMS, which read " <i>come to celebrate spring three days before and to wish that Milosevic never returns again</i> ". FTV – also reported.

<p>EU official Lange: technical part of SAA is essence of the agreement</p>	<p>Dnevni Avaz pg 5 'We are concerned because BiH does not respects treaties', mentioned on cover 'Technical part of negotiations with the EU is the most important' by <u>Tarik Lazovic</u>– Head of EC's General Directorate for Enlargement and official who is leading technical EU team in negotiations on Stabilization and Association with BiH, Dirk Lange stated in interview for DA that technical part of negotiations, which considers trade relations is the essence of the agreement for which BiH authorities hope that would be signed as soon as possible. Asked about his statement that he is irritated by customs that BiH introduced to beer from Slovenia and would that be the condition for signing of SAA, Lange stated that he wouldn't go that far, but: <i>"this is about the issue how prepared BiH is to honour international treaties on trade"</i>. He stressed that Slovenia , as EU member, is not treated adequately and now the assessment is being reached on what BiH is doing regarding the trade relations. Inset 'BiH economy is capable for free trade with the EU'- Lange stated that he believes that BiH economy is capable to fulfil conditions on free trade with the EU. He stressed that BiH has made some regulations to protect domestic protection, since it is believed that BiH is disabled to gain in free trade. NOTE: Lange never explicitly said that BiH doesn't respect treaties.</p>

Asked how much demands for resignation of BiH Defence Minister Nikola Radovanovic [SDS announced that would withdraw all its Ministers, after reshuffle in RS Government] are making their work difficult, Becirbasic said that he is not most competent to speak about that, but stressed that they are trying to keep political issues a side.</p>

BiH vs. SCG lawsuit

<p>SCG representative before ICJ says they do not deny crimes occurred, but claim that they can't be labelled as genocide</p>	<p>Hayat By Senad Hadzifejzovic– SCG representative Sasa Obradovic in the BiH lawsuit against SCG before International Court of Justice stated that the first round of oral presentation of the arguments has finished. Asked to comment the recent decision of ICJ to close the hearing for the media during the testimonials of witnesses, Obradovic stated that the testimonials would be presented to the public after the second phase is finished because <i>“ICJ has the rule that witnesses cannot hear what was stated previously on that issue by other witnesses”</i>. Commenting Slobodan Milosevic's death, Obradovic stated that it would not influence in any way the proceedings before ICJ adding that evidence presented during his trial can be used in other trials. Obradovic stated that his team was defending the dignity of SCG since it was accused of the <i>“worst crime”</i>. <i>“We do not deny that horrible crimes were committed in BIH but we argue that these crimes cannot be labelled as genocide. Another thing is that we want to prove that SCG had nothing to do with those crimes”</i> noted Obradovic.</p>

<p>Protests of Serb NGOs in Bijeljina; posters of Karadzic and Mladic and minute of silence for Milosevic</p>	<p>RTRS– Associations of Serb NGOs “SPONA” organized meeting in Bijeljina due to the BiH lawsuit against SCG for genocide. Several thousands of people were present. The meeting started with minute of silence for RS killed soldiers and late Yugoslav President Slobodan Milosevic. “SPONA” believes that the lawsuit is not legitimate and legal and asks for suspension of this lawsuit. Branislav Dukic, “SPONA” said that SCG accepted many refugees during the war regardless their nationality and religion. Hayat– At the occasion, Deputy Head of SPONA, Slavko Jovicic reiterated that RS has to be preserved and that RS citizens should condemn the Lawsuit. BHT1– protesters were carrying pictures of ICTY indictees Slobodan Milosevic, Ratko Mladic and Radovan Karadzic. Hayat– Gathered citizens held banners with inscriptions such as: “Europe You Should Be Ashamed”, “Mladic and Karadzic Do Not Give up”, “Muslims We Do Not Want to Live with You”.
