<p>BiH Presidency, leaders of political parties, CLAC to discuss const. changes</p>	<p><b>RTRS</b> – The BiH Presidency members and leaders of the leading political parties in BiH will meet today in Sarajevo to discuss addenda to the agreed amendments to the BiH Constitution. <b>Dragan Cavic</b>, SDS President said the meeting will exclusively focus on technical issues, adding that these talks in no regard represent changes to the agreed amendments to the BiH Constitution. <b>Milorad Dodik</b>, SNSD President, has stated that RS should remain a permanent category, whose existence will not be brought into question during talks on constitutional changes. The members of the BiH HoR's Constitutional and Legal Affairs Commission will also vote on the constitutional amendments today.</p>
<p>CoM Chair Terzic meets senior UN staff; says they agree issue of decertified police should be solved jointly by OHR, CoM, EU, UN</p>	<p><b>RTRS</b> – During the meeting with <b>Adnan Terzic</b>, BiH CoM Chair, in New York, the newly appointed Deputy Secretary General of UN, <b>Mark Malloch Brown</b>, has supported demand of the BiH to become a member of the Peace Building Commission, the newly formed body at the world organization. According to press statement released by BiH CoM, Brown accepted this demand regarding it as a grounded initiative. <b>BH Radio 1</b> – Terzic also met with the UN Peacekeeping Undersecretary <b>Jean-Marie Guéhenno</b>. They agreed that the OHR, BiH CoM, EU and UN experts should join efforts to find a solution for 598 police officers decertified by the United Nations International Police Task Force.</p>

<p>FBiH HoP discusses decision on FERK's electricity price increase</p>	<p><b>BH Radio 1</b> by <u>Ljiljana Radl</u> – At an extraordinary session of the FBiH House of Peoples in Sarajevo dedicated to a decision of the Federal Electricity Regulatory Commission [FERK] to increase the electricity prices, FERK representative <b>Zdenko Simunovic</b> addressed the HoR explaining the decision was grounded on obligations towards the Energy Community of the South Eastern Europe. He also reminded of FERK's legal authority to bring decisions independently. The House of Representatives asked the FERK to reassess its decision and requested the Commission to postpone implementation of a part of decision referring to the price increase for households until FBiH Government creates a program ensuring social welfare for vulnerable citizens, setting deadline for this by June 30. <b>RHB</b> – also announces the session.</p>

<p>BiH Presidency tasks political leaders to verify whether const. amendments are in line with agreement</p>	<p><b>BHT1</b> – The BiH Presidency held the session on Tuesday at which it failed to reach a decision supporting addenda to the draft amendment to the BiH Constitution. Instead, it tasked the leaders of the seven parties who signed the agreement on constitutional changes [SDA, SDS, HDZ, SDP, SNSD, PDP, HNZ] and who are expected to met on Wednesday to give their opinion as a matter of urgency on the addenda to the draft amendments. After this, the Presidency would proceed with adopting the amendments. The Presidency Chair <b>Sulejman Tihic</b> informed the members of the BiH parliamentary Constitutional-Legal Affairs Commission [CLAC] about this decision. <i>“I’ve heard many discussions and different opinions about the proposed amendments (to the BiH Constitution). <p>CLAC postpones voting on const. amendments: 25-30 changes to amendments submitted, session continues on Wednesday</p>	<p><b>BHT1</b> – The Constitutional-Legal Affairs Commission [CLAC] of the BiH House of Representatives would declare itself on the principles of a proposal for the amendments to the BiH Constitution on Wednesday 19 April, since between 25 and 30 new amendments to the basic text of this law were put forward on Tuesday. <i>“The commission will declare itself on the principles on Wednesday because some colleagues put forward amendments to the proposed amendments, which not only go deep into the text of the constitutional amendments but also represent important principal issues,”</i> CLAC Chair <b>Mirsad Ceman</b> said. <i>“I expect us all to sleep on this, and to see if we are ready to accept what is necessary and realistic. I would like us to be constructive”,</i> CLAC member and HDZ 1990 official <b>Martin Raguz</b> said. <i>“I’ve said before that I would support the constitutional amendments, because I believe they are in accordance with the constitutional organisation of BiH”,</i> stated SDS’ <b>Momcilo Novakovic</b>. Members of the CLAC expect a situation to be much clearer on Wednesday after the leaders of parties who reached the agreement on constitutional changes meet. The CLAC could than meet on afternoon of the same day. <b>Nezavisne Novine</b> pg 4 ‘Decision on amendments today’ by <u>M. Cubro</u> – CLAC members <b>Tihomir Gligoric</b> and <b>Petar Kunic</b> on Tuesday asked that the competences in field of security be shared between the state and entities. <i>‘All states strive to decentralise this sector. Therefore, BiH as a federal state should go in this direction too’,</i> Kunic stated. <b>RTRS</b> by <u>Zorica Rulj</u> – Raguz objected the decision-making process concerning the constitutive peoples in BiH institutions, transfer of legislative power to the House of Representatives, reducing existing role of the House of Peoples, and preservation of the entity voting in the HoR. CLAC member <b>Petar Kunic</b> said his fellow members of the Commission also sharply criticized the way the negotiations on const. changes were lead. <p>CLAC postpones votes due to RS officials' letter; Comm. members object both essence of const. reform and method of negotiations</p>	<p><b>Dnevni Avaz</b> pg 2 'No stance on constitutional amendments' by <u>H.Orahovac</u> – BiH Parliament's Constitutional-Legal Affairs Commission [CLAC] postponed vote on constitutional amendments due to the letter leaders of SNSD, PDP and SDS, <b>Milorad Dodik</b>, <b>Mladen Ivanic</b> and <b>Dragan Cavic</b> respectively, submitted to the BiH Presidency demanding some 'technical changes'. CLAC members, SDU's <b>Nijaz Durakovic</b> and SBiH's <b>Beriz Belkic</b> stated earlier that they would vote against the proposed amendments, explaining main reason was the preservation of the entity voting. HDZ 1990's <b>Martin Raguz</b> commented: <i>"We cannot accept solutions that lead Croat people into unequal status... BiH House of Representatives, thank to entity voting, Serbs and Bosniaks have right to call for veto. Croats do not have that right."</i> CLAC member <b>Filip Andric</b> agrees with Raguz. BiH Presidency Chair <b>Sulejman Tihic</b> was present at the session and was on disposal for questions of the CLAC members. <b>Oslobodjenje</b> pg 5 'Around 30 amendments on constitutional amendments were submitted' by <u>A.Omeragic</u> – Addenda to the constitutional amendments were also submitted by the BiH HoR deputies <b>Zlatko Lagumdzija</b>, Belkic, Raguz, <b>Petar Kunic</b> and <b>Tihomir Gligoric</b>. Lagumdzija tried to encourage some CLAC members to adopt the amendments saying the continuation of the reform is guaranteed by the US State Secretary <b>Condoleezza Rice</b> and EU High Representative for the Common Foreign and Security Policy <b>Javier Solana</b>.</p>

RS PM Dodik on second phase of const. reform: Talks on mid-level of authorities, where RS is undividable federal unit

**Nezavisne Novine** pg 4 'Dodik: Changes to the Constitution should be adopted' by D. R.– Apart from noting that the continuation of the talks on constitutional changes is possible only if the existence of RS is guaranteed, RS PM **Milorad Dodik** told the press conference he would be glad if the constitutional changes were adopted at BiH Parliament next week so that this phase of the talks could be completed. **RTRS** – *"The negotiations on the mid level [of authorities] foresee talks on establishing of three or more federal units, whereas RS is undividable, single federal unit"*, said Dodik. **Oslobodjenje** cover splash, pg 5 'Continuation of talks only with survival of RS' by O.Vukovic – Dodik declared that nobody should fear continuation of reform as the RS is an indisputable and permanent category. He is of the opinion that the RS officials should participate in such talks, regardless of how many phases there would be. However, he stressed that they need to know what they want before the talks itself take place. He reiterated that SNSD would vote in favor of the amendments to the BiH Constitution under condition certain 'technical' corrections are adopted [as requested by Dodik, RS President **Dragan Cavic** and PDP's leader **Mladen Ivanic**]. In opposition case, SNSD would vote against the amendments, said Dodik.

<p>Croat Coalition for Changes meet Croatian President Mesic, inform const. changes unacceptable due to entity vote</p>	<p><b>RHB</b>– Croatian President <b>Stjepan Mesic</b> met with representatives of political parties from Croat Coalition for changes. <b>Marko Tadic</b> from Croat Peasant Party [HSS], <b>Ivan Musa</b> from Croat Christian-Democratic Union [HKDU], <b>Petar Milic</b> from Croat Demo-Christians [HDK] and <b>Miro Grabovac</b> from Croat Democratic Union [HDU] introduced Mesic with their stance on constitutional changes. They stressed that entity voting in BiH Parliament is unacceptable for Croats and expressed their expectations that Mesic will warn international community on the constitutional changes that are damaging to Croats in BiH. <b>Oslobodjenje</b> pg 4 'Croats loose constitutionality' – The Coalition also stated Mesic expressed his support to all the ones that are trying to join their forces to ensure equality of Croats and other peoples in BiH, and expressed his hope that the new forces after the elections would faster bring BiH into the circle of developed countries. <b>BHT1, FTV, Nezavisne Novine</b> pg 4 'All peoples in BiH must have equal rights' by <u>Srna</u>, <b>Dnevni List</b>, pg 2 'Members of HK for changes with Mesic', by <u>NINA</u>, <b>Dnevni Avaz</b> pg 2 'Stjepan Mesic is expected to warn International Community' by <u>Fena</u> – reported on meeting</p>

Mesic that entity voting is unacceptable</p>	<p><b>Vecernji List</b>, pg 2 'Mesic about position of Croats in BiH', by <u>Miroslav Vasilj</u> – According to VL's knowledge, President <b>Stjepan Mesic</b> personally said that the entity voting is unacceptable. He also stated that he for the first time learned about the real problems related to the constitutional changes during the meeting with the Croat Coalition on Tuesday. Finally he promised that he would be talking to BiH authorities in Sarajevo as well as with representatives of the EU and US administration about the issue, however Mesic once again stressed that Croatia did not want to interfere into internal issues of an other state, reminding that however Croatia has obligations stemming from the Dayton agreement.</p>

<p>DL: HR, Head of European Parliament's Comm. for SEE meet Cardinal Puljic trying to persuade him to change Church's stand on const. changes</p>	<p><b>Dnevni List</b> cover pg splash and pg 5 'Cardinal Puljic still against Constitution' by <u>Z. Jukic</u> – According to sources close to the <b>OHR</b>, High Representative <b>Christian Schwarz-Schilling</b> and Head of the European Parliament's Commission for Southeast Europe <b>Doris Pack</b> talked on eve of Easter with Cardinal <b>Vinko Puljic</b> and Archbishop <b>Pero Sudar</b> about constitutional changes and they tried to persuade Puljic and Sudar to change their stand on this issue. DL explains that people from the International Community believe that the constitutional changes would get support of Croat MPs in the BiH Parliament if the Church changes its opposition against them and according to the article US Ambassador <b>Douglas McElhaney</b> met Cardinal Puljic with this purpose last week, however, the IC and the Catholic Church did not approach their stands on this issue at this meeting either.</p>
<p>Round Table in Mostar on const. changes: US is ready to help</p>	<p><b>RHB, RTRS, Dnevni Avaz</b> pg 2 'Last thing we want is that more Croats leave BiH', mentioned on cover 'Aim is for BiH citizens to have more efficient authority' by <u>F.Vele</u>, <b>Nezavisne Novine</b> pg 4 'USA is ready to help' by <u>Agencies</u>, <b>Dnevni List</b> pg 10, mentioned on cover 'We should not be afraid of constitutional changes' – "Nansen Dialogue Center" (NDC) Mostar Tuesday organised a round table on constitutional changes in this city, at which introductory notes were given by <b>Douglas McElchany</b>, US Ambassador to BiH, and <b>Slavo Kukic</b>, Professor at Mostar University. McElchany stressed that the US' engagement in talks on constitutional changes in BiH is not surprising if it is known the USA is always ready to assist in resolving serious issues and problems, adding: <i>"We have only helped in organising talks."</i> Kukic stressed that much credit for running talks on constitutions changes goes to the USA Administration, adding he is not certain the talks would have been held if that assistance had been absent. <b>Vecernji List</b> pg 2, mentioned on cover 'Constitutional changes will not move Croats from BiH' by <u>M. <p>Ambassadors of France , Austria , Holland and Belgium view Agreement on constitutional changes a progress</p>	<p><b>Dnevni Avaz</b> pg 4 'Aim of international community is to create state capable for talks with EU' <u>not signed</u>, <b>Nezavisne Novine</b> pg 4 'Agreement on constitutional changes is a progress' by <u>Agencies</u> – The French Ambassador to BiH, <b>Anry Zipper de Fabbiani</b>, has stated that the Agreement on constitutional changes, concluded between the main political parties in BiH, represents a progress welcomed by the EU states and USA, and this is a significant stage on the path of strengthening state efficiency BiH citizens and European integration of the state are in need for. The Dutch Ambassador to BiH, <b>Karel Voskuller</b>, and Head of Diplomatic Bureau of Belgium in Sarajevo., <b>Stijn Mols</b>, lso welcomed Agreement and its purpose to create a functional and efficient state of BiH. <b>Werner Almhofer</b>, Austrian Ambassador to BiH, also viewed Agreement as great success.</p>

<p>IFIMES (think-tank from Ljubljana ) claims: Constitutional changes without citizens' support</p>	<p><b>Vecernji List</b>, pg 5 'Sidelining of Croats from politics', by <u>Valentina Rupcic</u> – the Ljubljana-based IFIMES (International Institute for Middle East and Balkans Studies) carried out a phone survey in BiH on sample of 1233 citizens from whole of the country and asked them whether they supported the proposed constitutional amendments. Apparently, 61,4% did not support the changes, whilst 27,1% did support them. IFIMES' conclusion is that the entity voting in the BiH Parliament will mean that the entities will have a complete control over the state, highlighting that due to their small numbers, Croats will not be in position to influence voting in the Parliament. <p>SD commentary: Americans want adoption of constitutional changes by end of April at any cost</p>	<p><b>Slobodna Dalmacija</b> pg 19, mentioned on cover 'Constitution at any cost' by <u>V. Vegar</u> says that the constitutional changes must be adopted by the end of April since the US administration set this deadline and it does everything to meet it. The author concludes that from all sides involved in these talks Americans care about this issue the most. The commentary goes on to say that it is also interesting that Americans do not talk at all with SBiH representatives that oppose the constitutional changes, however they strongly influence Croat representatives that are against the changes and the author concludes that this shows that Americans obviously need support of the Croat people for this issue.</p>

<p>HR addresses UNSC, points 3 priorities for BiH: elections, const. reform, SAA negotiations; urges UN SC to solve decertified police officers issue; OHR to close down in spring 2006?</p>	<p><b>RTRS</b> by <u>Marina Marjanovic</u> – The High Representative, <b>Christian Schwarz-Schilling</b>, on Tuesday addressed the UN Security Council on Tuesday, for the first time in the HR role, stressing BiH has three priorities in 2006: constitutional reform, the general elections in October and the negotiations on the Stabilisation and Association Agreement with the EU. He stressed also no progress for both BiH and other regional countries was possible without full cooperation with the ICTY. OHR Spokesperson <b>Ljiljana Radetic</b> stated for RTRS that the HR stated the adoption of amendments to BiH Constitution would send an important signal that BiH is ready to undertake reforms. He also announced that before the end of the mission, OHR would have to annul all decisions banning certain individuals from performing public functions and to solve the issue of the decertified police officers <i>“who have been deprived of their rights by IPTF”</i> [UN International Police Task Force]. <b>FTV</b> – CSS stressed one of his key tasks is to oversee the end of the OHR and the full establishment of the EU Special Representative Office in BiH. The end of the OHR will also mean the end of the special executive powers, the so-called Bonn Powers, stated HR, adding he expects the full support of the UN Security Council in completing a successful transition. <i>“I hope that this can occur in the first or second quarter of 2007,”</i> HR said. <b>Nezavisne Novine</b> pg 5, announced on cover ‘OHR might be closed in spring of 2007’ by <u>D. Risojevic</u> – Commenting later, HR added the transformation from OHR to EUSR would depend on the capability of domestic authorities to take the responsibility for management over the state. <b>Dnevni Avaz</b> pg 4 ‘It is necessary to adopt constitutional changes’ by <u>S.Numanovic</u>, Inset ‘Support network to ICTY fugitives still exists in some parts of RS’- HR also argued that obligation of the full cooperation with the Tribunal should be observed in the context of entire region and not BiH alone. <i>“Supporting network to war crimes’ indictees still exists in some parts of the RS. <p>CoM Chair Terzic addresses UN SC informing of BiH improvements; focuses on decertified police officers</p>	<p><b>BHT1</b> by Erol Avdovic, New York – The Chair of the BiH Council of Ministers <b>Adnan Terzic</b> attended the session of the United Nations Security Council in New York. Addressing the UN SC, Terzic talked about improvements BiH has made in last two years. Big part of his speech Terzic dedicated to the issue of the 598 police officers who were decertified by the United Nations International Police Task Force [who at the time of the UN Mission to BiH had a mandate to carry out certification process] saying some of those officers have been unjustly deprived of their right to work. He stressed the UN Security Council should solve the issue. The CoM Chair was supposed to hold a meeting with the UN SG <b>Kofi Annan</b>; however, Terzic told BHT he would meet the UN Undersecretary for peacekeeping operations <b>Jean-Marie Guéhenno</b>, and the Deputy Secretary-General <b>Mark Malloch Brown</b>. BHT 1 says the BiH Mission to the UN did not manage to organize a meeting with Annan. <b>Dnevni Avaz</b> pg 4 ‘Special attention paid to decertified police officers’ by S.N.– <i>“Most of the attention in my address was paid to issue of decertified police officers. The HoR asked the FERK to reassess its decision and requested form the Commission to postpone implementation of a part of decision referring to the price increase for households until FBiH Government creates a program ensuring social welfare for vulnerable citizens, setting deadline for this by June 30. <b>Nermin Vila</b>, member of the European Ecologic Party commented that FERK is appointed by the Parliament and should be held accountable, but stressed <i>“it seems FERK is independent of BiH citizens, economy and the FBiH institutions – but very dependent of Elektroprivredas lobbies”</i>. FBiH Labour and Welfare Minister, <b>Radovan Vignjevic</b>, emphasized that at least 200,000 FBiH citizens live under poverty line: <i>“This is not the right time to make such reforms of the electricity prices. I am not against reform processes, but at this moment when we still do not know the full consequences of the VAT introduction I think we have rushed too much.”</i> FTV comments none of three FERK officials wanted to talk to media; Chair of the Commission <b>Zdenko Simunovic</b> told FTV reporter they are not obligated to address public.
