Radetic also said that elected officials in BiH now have a chance to speak about amendments inside a forum. According to her, HR to BiH said <i>“it is now up to the Parliament to discuss these amendments”</i>.</p>
<p>RS Association of former detention camp inmates sues F BiH Premier and former Head of F BiH Comm. for missing persons</p>	<p>RTRS – The RS Association of former detention camp inmates has filed a lawsuit with BiH Prosecution against Ahmet Hadzipasic, F BiH Premier, and Amor Masovic, former president of F BiH Commission for search after missing persons, for their failure to comply with the decision of the BiH Constitutional Court (dated 27 Mar 2005) regarding information on destinies of missing Sarajevo Serbs.</p>

<p>BiH Presidency approves corrections to amendments to BiH Constitution after agreement by political parties</p>	<p>Hayat – The BiH Presidency on Wednesday defined a proposal of the amendments to the BiH Constitution and said that this was related just to “<i>technical corrections</i>.” Prior to the session, the leaders of the political parties met in the BiH Presidency and agreed on “the corrections” to the amendments. The BiH Presidency Chairman Sulejman Tihic told at the press conference that these were only technical corrections, adopted following the discussion whether these are in line with the Agreement on the constitutional changes adopted by the parties in March.</p> <p>Following the adoption, the leaders forwarded the amendments to BiH Presidency for approval. Tihic confirmed this and explained that the corrections did not change essence in terms of what the BiH Presidency had adopted before. Tihic explained that competencies of BiH institutions are arranged by the state law in accordance with the Constitution. With regard to the BiH Parliament, the legislative authority of BiH is given to the Parliament in accordance with the Constitution. Every law that does not require concordance of the BiH Parliamentary House of Peoples is strictly under the jurisdiction of the House of Representatives, said Tihic. It was foreseen earlier that the Parliament will be dismissed if it does not elect the Chairman of the BiH Council of Ministers after the third attempt, and now it is foreseen that the Parliament will be dismissed if the BiH Presidency, which would consist of a president and two vice-presidents, is not elected in a certain number of attempts. US Ambassador to BiH Douglas McElhaney, who, according to Hayat’s unofficial information, exerted pressure against the political parties’ leaders, also attended the meeting.</p> <p>Dnevni Avaz cover splash, pg 2 ‘We have reliable 27 votes of deputies’ by <u>A.Malagic</u> , EuroBlic pg RS2 ‘Agreement was reached’ by <u>D. <p>Leaders of parties that signed agreement on const. changes convinced that proposed amendments would get support of BiH HoR</p>	<p>RTRS – Following the meeting in the BiH Presidency, during which political parties approved corrections to proposed amendments to the BiH Constitution and the BiH Presidency endorsed them, SNSD leader Milorad Dodik stated that a lot of negative energy appeared in the process especially from the FBiH parties. <i>“The RS has made significant compromises related to the election of the BiH Presidency members and BiH House of Peoples as well as some other things”</i>, stressed Dodik. HDZ leader Dragan Covic stated that in his opinion constitutional amendments would be adopted in both Houses of the BiH Parliament. SDS leader Dragan Cavic stated that all disputable issues related to the constitutional amendments have been agreed upon. Cavic added that the matters related to defence and security have been coordinated as well. <i>“We hope that the amendments will be voted on next week in the BiH Parliament”</i>, concluded Cavic. BHT1 – BiH Presidency Chair Sulejman Tihic stated after the meeting that there are guarantees that 27 deputies in the BiH HoR would vote in favour of proposed amendments. Malagic</u> SNSD leader, Milorad Dodik, explained which parts of the proposed text that was prepared earlier were debatable.</p> <p>He noted that interpretations (of solutions) were not clear enough for defence and security. <i>"We only asked that that they be clearly defined and to say that the defence and security will be regulated by the state law. On the top of it, you have legislative powers of BiH where, intentionally or accidentally, I do not know, the word 'level' was omitted"</i>, said Dodik. Malagic</u>, inset 'Amendments are passing for sure' – DA's anonymous source claims the meeting of political parties secured adoption of the constitutional amendments in both houses of the BiH Parliament: <i>"There are enough votes in the BiH HoR even if most of Croat deputies were against them. <p>CLAC endorsed amendments to const. changes, forwards them to Parliament</p>	<p>BHT1 late news – The Constitutional-Legal Commission of the BiH House of Representatives at its session on Thursday adopted the addenda to the amendments to the BiH Constitution determined by the BiH Presidency following the meeting of the political parties. 5 members of the Commission supported the principles and four members were against them. After the principles were supported, discussion on 55 amendments that have been put forward continued. Only 4 amendments of technical nature were adopted. CLAC Chair Mirsad Ceman, confirmed the decision would now be submitted to the BiH HoR, which should start discussion on proposed amendments on April 25 [Tuesday]. Dnevni Avaz, pg 2 'Five in favour of amendments, four voted against', by <u>H. Orahovac</u> – Avaz notes that CLAC endorsed the proposed changes and in the same time 'honoured requests' of the SDS, PDP and SNSD, which the other day asked that technical changes to the amendments be carried out concerning authorities of BiH in the field of defence and security (that defence and security should be under authority of BiH pursuant to the state laws). Petar Kunic, Tihomir Gligoric, Momcilo Novakovic, Mirsad Ceman and Mirsad Sipovic voted in favour the amendments to the BiH Constitution. Martin Raguz, Filip Andric, Beriz Belkic and Nijaz Durakovic were against it. Article also carries that Raguz and Andric left the meeting before its end. <p>Oslobodjenje: CRO President Mesic to raise issue of const. changes at Inter-state Council meeting with BiH?</p>	<p>Oslobodjenje, pg 2, mentioned on front 'Mesic and Tihic are not Tudjman or Izetbegovic', by <u>D. Zadavec</u> – According to official confirmation from the office of the Croatian President, today's (Thursday) session of the BiH-Croatia Inter-state Cooperation Council will address issues related to relations between the 2 countries and processes related to getting closer to the EU. However, unofficially, one could hear that the Croatian President, Stjepan Mesic, could be raising the issue of constitutional changes in BiH with regards to the position of the Croats and the proposed solution related to the entity voting in the BiH HoR. The headline of the article suggests that two heads of states (Mesic and Sulejman Tihic) are not in position i.e. they do not have the power, to sit down, discuss and agree on important matters like their predecessors used to do (late presidents Izetbegovic and Tudjman).</p>

Milavic</u> – during a round table dedicated to constitutional changes held in Mostar on Tuesday night, the SDP leader, Zlatko Lagumdzija, criticized Croat MPs (in the BiH Parliament) and their SBiH colleagues for not supporting the changes, saying they are doing it for personal benefit, accusing them of joining ranks with 'Seselj's radicals' (Serb Radical Party) and other 'destructive forces' from the RS. SDP called on all citizens and institutions to join in the discussion on constitutional changes. (similar in Slobodna Dalmacija, pg 20, mentioned on front 'HDZ joined Seselj's radicals', by <u>M. <p>Austrian President visits BiH, supports constitutional reform</p>	<p>Hayat– Austrian President Heinz Fischer told press on Wednesday after meeting the BiH Presidency: <i>"I am interested in constitutional reforms in BiH, as well as in results of the ongoing constitutional reform since it would enable BiH to develop successfully."</i> BiH Presidency Chair Sulejman Tihic said that he informed the Austrian President about the results of the constitutional reforms agreement reached by political parties leaders due to the fact that they had met with leaders of political parties in BiH prior to the meeting with Mr. Fischer. The delegations talked about improving bilateral relations between the two countries, the current situation in BiH, the results of party talks on the constitutional reforms, improving the economic relations and possibilities for extending cooperation in the field of defence and culture. <p>Former HR Petritsch regrets EU does not lead const. reform</p>	<p>Oslobođenje pgs 4-5 'EU gave BiH over to US' by <u>Mile Lasic</u> – Daily carries interview published in Die Presse in which former HR Wolfgang Petritsch comments on the constitutional changes in BiH saying it is "sad" that the EU leadership is missing in the process: <i>"When I was the HR, I tried to improve BiH's approach to the EU, and to avoid all Euro-American hybrid systems in judicial and administrative bodies. We made a great progress in 2002 when the constitutional reform is in question. My ancestor did not continue with that."</i></p>

<p>Oslobodjenje op-ed: EU has no strength nor wish to take over steer from US, not even on its own ground</p>	<p>Oslobodjenje pg 9 'EU without steer in BiH' op-ed by <u>Edin Krehic</u> – Following the interview with former HR Wolfgang Petritsch for Die Presse, in which he criticized the EU foreign policy for letting the US taking steer over Balkans, the editorial reads it has not happened recently, but in 1995 when administration of the former US President Bill Clinton stopped the war in BiH. Further criticizing EU policy towards BiH during and after the wartime, author concludes: <i>"Europe simply does not have strength, unity or, finally, the wish to take over the steer from America. Not even on its own ground, even in Balkan."</i></p>
<p>Creator of DPA Holbrook: Abolishing or creating new entities would bring conflict back in BiH</p>	<p>Oslobodjenje cover splash, pgs 4-5 'Abolishing or creating new entities would bring conflict back in BiH' – Commenting on constitutional changes in BiH, creator of Dayton Peace Agreement Richard Holbrook said for daily: <i>"Proposed constitutional changes are not perfect...Nobody will get everything what one wants from these reforms... Abolishing entities is also not practical... Abolishing entities or creating the third one is a way back to a conflict."</i> Underlining that at this time it should not be insisted on such dangerous change, he said that the entities could be discussed later on. Commenting on the DPA, he stressed that it was a mistake to allow the RS to preserve its name, adding that SDS should not be allowed to remain in political life.</p>

Grubisic</u> carries that 'Croat political and Catholic Church' representatives as well as Croats in general have expressed their dissatisfaction over the constitutional changes agreement, however people from the International Community do not care about it. The author goes on to say that instead of dealing with the reasons of the Croat concern when this issue is in question the IC is pushing them to adopt the changes as soon as possible and all Croat arguments are being rejected without valid explanation.</p>

<p>1st official agreement signed between BiH and Vatican/Agreement guarantees full autonomy to Catholic Church</p>	<p>PINK- BiH Presidency member Ivo Miro Jovic and Apostolic Nuncio Alessandro D'Ericco signed in Sarajevo agreement between BiH and the Holy See which regulates and defines position and rights of Catholic Church in BiH. <i>"We are assured that the agreement is going to be of extreme use for BiH in terms of international issues, namely that it would present BiH as a place where religions are being respected"</i>, said D'Ericco.</p> <p>The agreement would give Catholic Church absolute autonomy; namely the Church will be able to establish education institutions, while the state would have to provide means for it.</p> <p>The state will also have to return property, which belonged to the Catholic Church within 10 years. If the agreement was approved by the BiH Parliament it would come in force immediately after ratified documents were exchanged. Hayat By Zumra Arnautovic – British Deputy
Defence Minister **Adam Ingram** met in Sarajevo
with BiH Defence Minister **Nikola Radovanovic**.
Both of them agreed that the situation in BiH
has improved and that a number of EUFOR troops
in BiH could be reduced. *“At the very moment,
EUFOR mission, made of 6,000 members, suits the
situation and needs in BiH, and the crucial
event are the October elections and
establishment of new institutions, after what
the issue of needs should be assessed so to
have the number of troops reduced”*, said
Radovanovic. *“First of all I would like to
thank BiH Defence Minister for BiH’s engagement
in peace missions in Iraq. We are living in the
world faced with great difficulties and you
yourselves have gone through certain
difficulties recently. Soon after, you have
offered your help to others in trouble”*, said
Ingram. In terms of **Ratko Mladic**, Radovanovic
pointed out that Mladic’s extradition to The
Hague was a joint BiH-SCG term for joining
Partnership for Peace. Being asked whether BiH
and SCG should join PfP together, Ingram said
that he would like to see the entire region
move forward and added that the International
Community had to be cautious in order not to

<p>SDS claims that RS representatives in PRD SB are pressured by FBiH reps.</p>	<p>BHT1-SDS will demand from the RS National Assembly to discuss the information on work or Police Restructuring Directorate as soon as possible. According to SDS' Dusan Stojicic, RS representatives in Directorate's Steering Board, are under pressure of representatives from the FBiH, adding that decisions are often passed without an agreement and consensus. RTRS – Stojicic claims that SDS has information that the police reform in BiH is not being carried out in accordance with the police reform agreement.
