The acting president, <b>Bozo Ljubic</b>, told the press that the party has been registered with a competent court under the name ‘HDZ 1990’, putting an end to speculations that the party will not be able to use the name of HDZ. Ljubic also noted that many people are joining the HDZ 1990, stressing that the whole of HDZ BiH Municipal Board of Capljina has joined the HDZ 1990.</p>

<p>Croatian president Mesic on constitutional changes: Reform must provide protection for all three constituent peoples</p>	<p><b>FTV</b> – During the meeting of the BiH-Croatian Inter-state Council, BiH Presidency Chair <b>Sulejman Tihic</b> briefed the Croatian President <b>Stjepan Mesic</b> about the course of the constitutional reform in BiH. Mesic said that he supported any solution which would make BiH function like a state. <i>“Constitutional changes have to protect all three constituent peoples and provide mechanisms which would prevent blockade in constitutional changes in its second or third phase”</i>, said Mesic. <b>Dnevni Avaz</b> pg 3, mentioned on cover ‘Mesic: We can move to EU only as good neighbors’ <u>not signed</u> – Mesic added: “I support everything could help BiH, but I consider that current constitutional changes in BiH need to fully protect all three constituent peoples.” He added that “cementing” could damage BiH thus if the country <i>“is determined to progress on the road to Europe, than we all must support this, as the South East Europe must also become a part of the EU.”</i> <b>Vecernji List</b>, pg 2, mentioned on front ‘Mesic wants guarantees for constitutional changes’, by <u>Dejan Jazvic</u> – VL notes that Mesic’s statement on constitutional changes in a way supports positions of parties that want clear guarantees that the issue of entity organization of BiH will be raised after the October elections. <b>PINK, RTRS, Glas Srpske</b> pg 5 ‘To avoid blockades’ by <u>SRNA</u>, <b>Dnevni List</b>, pg 5, mentioned on front ‘Governments will solve debatable issues’, by <u>D. BiH political leaders claim that they have provided majority for support of the vote on proposed amendments

**BHT1** By Marina Boskovic– Leaders of leading political parties in BiH who signed the agreement on constitutional changes in BiH claim that they have provided enough votes to have the amendments passed in BiH House of Representatives. After months long negotiations between the leaders of the political parties, final version of text of the Constitution has been harmonized and if amendments are not passed, BiH would have another chance only in 4 years. *“I do not expect it to happen, but if does, BiH will not be able to move towards Europe as other states”*, said the British Ambassador to BiH **Matthew Rycroft**. HDZ 1990 representatives believe that the proposed amendments would not be passed. After their amendments were rejected, HDZ 199’s **Martin Raguz** and **Filip Andric** left the Constitutional and Legal Affairs Commission’s session. In five days it will be familiar whether BiH is going to get the new Constitution. *“We have agreed on the final text of the amendments, it came out as the result of compromise reached by all political participants and the BiH Presidency has reached the final decision and no changes can be introduced”*, said SDS leader **Dragan Cavic**.

<p>Oslobodjenje: Despite criticism/opponents, parties believe const. changes would be adopted</p>	<p><b>Oslobodjenje</b> pgs 4-5 'Votes for changing the Constitution assured', mentioned on cover By <u>A.Omeragic</u> – Daily comments that despite the objections to the proposed amendments to the BiH Constitution, the leaders of the political parties are entirely sure that the changes would receive the support in the Parliament.</p> <p>Commenting the session of the BiH parliamentary Constitutional Commission [CLAC] which adopted only 'technical corrections' to the amendments to the BiH Constitution and the walkout from the session by the CLAC members from HDZ 1990 [<b>Martin Raguz</b> and <b>Filip Andric</b>], SBiH representatives in CLAC <b>Beriz Belkic</b> also expressed dissatisfaction. However, he added that his party would not abandon a demand to abolish entity vote in the BiH House of Representatives. <i>"Even though our amendment wasn't passed we have submitted it to the procedure immediately, so that it would be discussed about at the Parliament's session"</i> said Belkic.</p>
<p>CLAC member Kunic: traps for RS's competences remained empty</p>	<p><b>Glas Srpske</b> pg 5 'Traps remained empty' by <u>Z. Markovic</u> – Member of Constitutional-Legal Affairs Commission <b>Petar Kunic</b> stated for <i>Glas Srpske</i> that the status of RS would have been reduced down to the level of a municipality if the originally suggested amendments to BiH Constitution had been adopted. <i>'Only upon the intervention of delegate <b>Tihomir Gligoric</b> and me, leaders of parties changed the amendments and this prevented the republic competences from falling in a trap from which these would never got out alive'</i>, Kunic stated.</p>

<p>Member of Constitutional Legal Commission of BiH Parliament Andric called on Croat MPs in BiH HoP to prevent adoption of const. changes amendments</p>	<p><b>Slobodna Dalmacija</b> pg 19, mentioned on cover 'Covic's Central Committee (Communist time body) against Croats' by <u>P. Milos</u> carries an interview with member of the Constitutional Legal Commission of the BiH Parliament <b>Filip Andric</b>. Commenting on the fact that correlation of forces in the BiH House of Representatives has changed when support to constitutional changes is in question and that it is quite certain that these changes might be adopted, Andric said: <i>'Unfortunately, this is the way it is. The only chance is to do something in the BiH House of Peoples, that might prevent this deceit.'</i> Andric called on Croat MPs in the BiH HoP to prevent adoption of such Constitution <i>'on the ground of which others would be deciding on destiny of Croats'</i>. Asked about the 2<sup>nd</sup> phase of the constitutional changes talks, Andric says that the Constitution is something that should be built at one time and completely.</p>
<p>Chairman of Croat Caucus at HoR Zoric: Croat delegates will not support constitutional changes</p>	<p><b>Nezavisne Novine</b> pg 2 'Croat delegates against changes' by <u>M. Cubro</u> – Chairman of Croat Caucus at BiH HoR <b>Vinko Zoric</b> on Thursday stated Croat delegates at BiH Parliament will not support changes to BiH Constitution and will again ask for entity voting to be abolished. He says they will ask for the introduction of a principle according to which at least 1/3 of delegates from the three constitutive peoples will have to vote for a law in order for it to be adopted.</p>

<p>SDS leader Cavic: I believe parties who signed agreement would vote in favour proposed amendments</p>	<p><b>PINK</b>– Following the session of the BiH parliamentary Constitutional Commission [CLAC] which endorsed the amendments to BiH Constitution, SDS Leader <b>Dragan Cavic</b> said that BiH House of Representatives would vote on the amendments at the session scheduled for April 25: <i>“Our representative in BiH CLAC insisted amendments to remain the same as agreed by political parties...and political party, which I lead [SDS] will, in accordance with the Main Board’s decision vote in favour of the amendments. I do not know about other parties but I believe that the parties that signed agreement on constitutional changes would do the same”</i>, said Cavic. <b>RTRS, Nezavisne Novine</b> pg 3 ‘SDS will vote for amendments’ by <u>Agencies</u>, <b>EuroBlic</b> pg RS2 ‘SDS supports amendments’ by <u>R. <p>SDP’s Lagumdžija: automatic disband of parliament set</p>	<p><b>Nezavisne Novine</b> pg 3 ‘Automatic disband of parliament set’ by <u>P.K.</u> – <b>Zlatko Lagumdžija</b>, SDP President, has stated that technical corrections of the Amendments to BiH Constitution have defined that the State Parliament would automatically be disbanded – instead of seeing it reach decision on its disbandment – if it fails to elect Council of Ministers’ President in three circles. AT the public debate on constitutional changes held in Banjka Luka, Lagumdžija said he sees no reason why these proposals for the change of BiH Constitution would not be supported by all, since the alternative is to maintain the current situation.</p>

HR Schwarz-Schilling  
welcomes CLAC  
decision: reform is  
now up to

**PINK** – OHR Spokesperson **Ljiljana Radetic** stated the High Representative, **Christian Schwarz-Schilling**, welcomed Wednesday's decision of the Constitutional-Legal Commission of the BiH Parliament to accept the proposed amendments to the BiH Constitution. *"The decision means that BiH's elected representatives now have the opportunity to discuss these amendments in a broader forum"*, said Radetic reporting the stand of the High Representative, together with the message that it is now up to Parliament to consider these amendments. Schwarz-Schilling said that the proposed changes are important steps towards streamlining the State structures, which will help equip BiH better for EU integration. *"The amendments are the first step in a longer process. There will be an opportunity to put forward further amendments in a second phase"*, declared Schwarz-Schilling. **RHB, Oslobodjenje** pgs 4-5 'Votes for changing the Constitution assured', mentioned on cover By A.Omeragic, inset 'Better organization of the state' by Fena, **Dnevni Avaz** pg 8 'Additional amendments in second phase of negotiations' not signed, **Glas Srpske** pg 3 'First step is successful' by M.Dz., **Dnevni List**, pg 8 'Situation is better than it looks', not signed – also carried.

US Deputy Assistant Secretary DiCarlo: Adopt constitutional changes now!; US would not exert pressure on RS to abolish entities

**Dnevni Avaz** cover splash, pg 5 'Message from Washington: Adopt constitutional changes' by S. Numanovic – Welcoming adoption of the amendments to the BiH Constitution by Constitutional Legal-Affairs Commission [CLAC] of BiH Parliamentary Assembly in an interview for DA, Deputy Assistant to US Secretary of State **Rosemary DiCarlo** said: *"These changes are not depriving any people by any chance. Aim of these reforms is to strengthen the state and its efficiency so all BiH citizens could live prosper. This is just the first step towards more efficient authority that is much more in accordance with European standards... If you do not pass the first one, you will never reach the second phase of the changes."*

DiCarlo stressed that one of the main changes that have to be made in the future is reform of public sector. Inset 'Adopt amendments now!' – Commenting an official US stance, DiCarlo said the amendments must be adopted now, so they could be applied before October elections. *"This is important as we believe that OHR will close soon. Those that are elected in October elections, will constitute new responsible authority... If that does not happen, BiH will preserve same authority structures as it had before."*

<p>EC President Barroso welcomes agreement on const. changes</p>	<p><b>Dnevni Avaz</b> pg 8 'Manuel Barroso: Place of BiH is in Europe' by <u>S.N.</u> – In the letter to BiH Presidency Chair <b>Sulejman Tihic</b>, European Commission President <b>Jose Manuel Barroso</b> welcomed the agreement of BiH political parties on amendments to the BiH Constitution. Barosso said: <i>"It is of great importance that the agreement respects rights of all citizens and constitutive peoples in BiH, and that is in accordance with European Convention on Human Rights... Now, it is very important that BiH Parliamentary Assembly adopt the agreed changes as soon as possible... That would be a positive signal to EU and its members that BiH has decided to implement other reforms and additionally close the state to the Union."</i></p>

<p>UNDP: About 40% of BiH citizens support const. changes: 51% Bosniaks, 48% Croats and 27% Serbs support amendments</p>	<p><b>Hayat</b> – According to results of an opinion poll carried among 2000 citizens by UNDP in the past ten days as part of the Early Warning System Report for the first quarter of 2006, 40,1 % of BiH citizens support constitutional changes, 10 % oppose them while 33,5 % are neither in favor nor against, and 16,4 % don't know or do not have an answer on the changes. In FBiH 50,3 percent of citizens support constitutional changes, with only small percentage of 4,5 against, but 27,2 % neither support nor are against, and 18% do not have an answer. In the RS, 26,9 % of citizens support the changes, 40 % neither support nor are against, and 14,7 don't have an answer. Author concludes: <i>"If that does not happen, it will be strong blow for both US and EU, and they would share [this criticism] with opponents of the constitutional changes."</i></p>

<p>SD op-ed: Most BiH political leaders support const. changes due to huge IC' pressure or in order to preserve their positions</p>	<p><b>Slobodna Dalmacija</b> pg 18 'You can either support constitutional changes or lose position' by <u>M. Karacic</u> comments on behaviour of BiH political parties when changes to the BiH Constitution are in question and the author concludes: <i>'Most BiH political leaders support these changes mostly because of huge pressure of the International Community or in order to preserve the positions that they occupy at the moment, however, unfortunately this is the way the politics in BiH is.'</i></p>
<p>Dani comment: Whatever happens to proposed const. changes, it will not be US 'headache any more</p>	<p><b>Dani</b>, pg 3 'It is easy for America without us', by <u>Ivan Lovrenovic</u> – commenting on the process of constitutional changes, <u>Lovrenovic</u> stresses that BiH, <i>"chained with impossibility to change the situation within, with minimum of domestic forces"</i>, has no other option but to turn to the IC, in this case the US administration, to carry out the necessary changes. The author says that by judging the appearance of the US Ambassador <b>Douglas McElhaney</b>, on FTV's '60 minutes' show, during which, according to <u>Lovrenovic</u>, the Ambassador <i>"lost his cool"</i> when he was advocating for the changes, it looks as though the chances that the amendments will be adopted are not that big. As a conclusion, <u>Lovrenovic</u> reckons whatever happens to the changes in the BiH Parliament, whether they get rejected or adopted, it will not be the <i>"US' headache any more, not at all"</i>.</p>

<p>BiH-Cro interstate council meets in Sarajevo : proposes abolishment of Councils, issues to be solved by state institutions</p>	<p><b>BHT1</b> – Members of the BiH-Croatian Interstate Council at this 10<sup>th</sup> session agreed in Sarajevo on Thursday that relations between the two countries were good and friendly, and called on settling outstanding issues in keeping with European standards. President <b>Stjepan Mesic</b>, who headed the Croatian delegation, stated in Sarajevo that the relation among two countries have an ascending line thus there was no more need for the Interstate Council. <i>"We believe that relations between the two states have improved so that we need no Interstate Council, at least not in that form, since these are two sovereign, European states, and the issue of relations should be solved through institutions in charge"</i>, said BiH Presidency Chair <b>Sulejman Tihic</b>. The officials also agreement launching initiative to hold the meeting of Presidents and Prime Ministers of BiH, SCG and Croatia in Dubrovnik in May which would focus on the fate not only of the BiH-Croatia Interstate Council, but also the BiH-SCG Interstate Council. BiH Presidency members and Mesic discussed Port Ploce and Peljesac bridge issues. <b>FTV</b> – In terms of Port Ploce, nothing new has been said. <i>"We have agreed to call on our Governments to solve this issue in line with the existing agreements and European standards"</i>, said Tihic. On regional issues, it has been said that BiH and Croatia were not going to interfere in the issue of Kosovo status. He also told journalists the BiH Council of Ministers has not prepared material for the session which was a reason for absence of the Croatian Prime Minister <b>Ivo Sanader</b> or any Croatian Minister. <b>Oslobodjenje</b> cover splash, pg 3 'Governments have to solve problem of Port Ploce' by <u>Az.Kalamujic</u> – Tihic said that the Governments of two states are working on text of the new agreement on Port Ploce. <b>RHB, PINK, Hayat, RTRS, Dnevni Avaz</b> pg 3, mentioned on cover 'Mesic: We can move to EU only as good neighbors' <u>not signed</u>. <b>Nezavisne Novine</b> cover pg splash and pg 2 'Equality for all peoples in BIH' by <u>A. <p>BiH CoM Chair Terzic on RSNA Committee for Defence/Security's session on police reform: There is no place for any further interpretations</p>	<p><b>Dnevni Avaz</b> pg 4 'Without police reform there is no European path', mentioned on cover 'Terzic: No deviating from already adopted agreement' by <u>E.Sarac</u> – Commenting upcoming session of the RS National Assembly's Committee for Defence and Security Issue which would should discuss police reform on April 28, the BiH Council of Ministers Chair <b>Adnan Terzic</b> said that this discussion among the RS officials which would focus at the things that have done in the course of the reform to date is welcomed only if carried within the set deadline. <i>"But, if that discussion means changing the Agreement [on police restructuring signed last year], some deviations from things already agreed, it should worry us all."</i> He reminded that the Agreement on the police reform and three European principles of depoliticised police, regions organized by technical criteria and state control over police have to be respected. Terzic concluded: <i>"There is no place for any further interpretations. It is clear that there has to be single state budget, and not a consolidated one. It is clear that the police has to be organized at the state and local levels and that there should be no political interference in its work. We must not allow to be stopped in our way to Europe, specially due to the fact that we had a good start."</i></p>
<p>FBiH Government established Law proposal on Amnesty for those that avoided military service</p>	<p><b>Dnevni Avaz</b> pg 4 'Amnesty proposed for all deserters' by <u>M.Kukan</u>– At its Thursday's session FBiH Government has established a Law proposal on Amnesty for avoiding military service and submitted it to the FBiH Parliament in urgent procedure. Passing the Law was in accordance with the proposal of Defence reform Commission and stipulates general amnesty for all citizens who refused or for some other reason haven't served military in period as of 1992. FBiH Government also rejected the initiative by the deputy <b>Nermin Pecananc</b> to set more favourable retirement conditions for members of FBiH Interior Ministry. It was emphasized that Police reform Directorate is also working on plan proposal for implementation of the reform, which includes analysis of decrease of surplus employees and social welfare packages. <b>Oslobodjenje</b> pg 4 'Law proposal on amnesty established' <u>not signed</u>, <b>Dnevni List</b> pg 4 'Amnesty for desertion in whole country' by <u>I. RS Govt. approved pension increase of BAM 10 to 15 until 30 June, increases salaries to RS MoI

The RS Government also determined proposal of Law on RTRS and program of public investments in period 2006-2010; passed program for mitigation of consequences on socially endangered categories caused by introduction of VAT and decided to increase RS Ministry of Interior employees got raise of salaries in amount of 100 KM. The financial advisor for privatization of Telekom Srpske "Reiffesein" to submit privatization program by the end of this month in order to accelerate the process.
