### Beginning of Schwarz-Schilling's mandate

New HR Schwarz-Schilling addresses BiH Parliament: use of Bonn powers only when necessary

**RTRS** – The High Representative, **Christian Schwarz-Schilling** met with representatives of both Houses of BiH Parliament Assembly on Wednesday. At the meeting, Schwarz-Schilling once again reminded that BiH citizens must alone decide on their future, adding his role is mainly advisory while the major responsibility lies with BiH Parliament. He also stressed that the elections scheduled for October provide a chance for BiH citizens to determine which way the country would go in the future. Asked about possible pardoning of politicians dismissed by former HR **Paddy Ashdown**, Schwarz-Schilling stated that he has not yet consider this issue, adding that he first needs to examine all cases and create an own opinion on each one. **BHT1**– *"I told the HR that we expect the politicians to be credited for the results of their work and that the best ones would be those who [are good for] BiH citizens, not the HR"*, said the Chair of the BiH House of Representatives **Nikola Spiric**. *"We have discussed the models of cooperation between the Parliament and the HR in order to become a single team, which would bring BiH to the Euro-Atlantic integrations"*, said the Chair of BIH House of Peoples **Mustafa Pamuk**. Commenting to his Bonn powers, the HR said this would be the last instrument used only in urgent situation, in case of endangering peace or obstructionism that would lead the country in jeopardy. *"We have agreed on the most important issues; SAA, Partnership for Peace, economy and elections which are to follow"*, said the HR. **RHB, PINK, Hayat, Dnevni Avaz** pg 2 'Schwarz-Schilling: I will act as councillor in partnership' by H.Orahovac, **Oslobodjenje** pg 5 'Priorities: Europe, Partnership for Peace and better life of citizens' by A.Omeragic, **Nezavisne Novine** pg 2, announced on cover 'I will use powers in urgent situations only' by M. <p>IHT op-ed by CSS: BiH citizens must cease to expect IC to deliver reforms for them</p>	<p><b>International Herald Tribune</b> pg 'How to move Bosnia forward' by <u>Christian Schwarz-Schilling</u> – IHT publishes an editorial written by the newly appointed HR to BiH, <b>Christian Schwarz-Schilling</b>, who notes that despite the past, BiH's progress would be irreversible once its citizens take responsibility for the peace process. Schwarz-Schilling praises his predecessors for using "Bonn powers" to take the peace process forward, adding that limits have almost been reached to such policy. Author said that institutions created by imposition would never function effectively, unless BiH citizens stop expecting IC to deliver reform. HR comments that consequence of seeking to avoid using the Bonn powers could be a slowdown in the perceived pace of progress in 2006, expressing his hopes that BiH citizens could surprise the world and prove that <i>"the caricature of their country as a 'failed state in Europe' is no longer accurate"</i>. Author said that <i>"Elections in October should provide Bosnians with an opportunity to debate the way forward and to choose leaders who are best equipped to secure their country's European future. For they – not I – will be responsible for negotiating the terms and speed of their country's entry into Europe."</i></p>
<p>BiH HoR Co-Chair Raguz: CSS ' address to Parliament on his first working day acknowledged institution</p>	<p><b>RHB</b>– Following the joint session of BIH Parliament Collegium, BiH House of Representatives Deputy Speaker <b>Martin Raguz</b> stated that new High Representative <b>Christian Schwarz-Schilling</b> acknowledged the BiH Parliament as a central democratic institution by addressing it on his very first working day. Raguz stated for RHB that successful continuation with negotiations on Constitutional changes, development of economical and welfare area, removal of the obstacles for the sustainable return were some of the agreed priorities for the coming period. Raguz pointed out that new HR demonstrated that he is well informed and familiar with the real situation in BIH. Raguz added that he hopes for better relations with HR in general.</p>

<p>HDZ expects Schwarz- Schilling to be active partner to BiH politicians</p>	<p><b>RHB</b>– HDZ spokesperson <b>Miso Relota</b> stated that HDZ expects from a new HR <b>Christian Schwarz-Schilling</b> to be an active partner to representatives of the executive and legislative authority at all levels in order to remove obstacles for development of economy and welfare area so that BiH meets all positive, European and democratic standards. Also, it has been expected from the new HR that, unlike his predecessors, he would not remove legally elected officials.</p>
<p>Refugees to send petition to HR Schwarz Schilling</p>	<p><b>Oslobodjenje</b> pg 7 ‘Petition for 100.000 returnees’ by <b>Fena</b>, <b>Dnevni Avaz</b> pg 2 ‘Petition with question for Schwarz- Schilling’- Chairwoman of BiH Association of Refugees, <b>Mirhunisa Zukic</b> stated that 90 of local associations have started with signing of the petition for employing of 100. 000 returnees. This petition would be sent to new High Representative <b>Christian Schwarz Schilling</b> with a question shouldn’t everyone work in place of returning and in a service they worked before.</p>
<p>Political analyst Topic: Schwarz- Schilling would probably consult politicians more then former HR did</p>	<p><b>RTRS</b> late news – Political analyst from Banja Luka, <b>Tanja Topic</b>, talked about the work of the new HR <b>Christian Schwarz-Schilling</b>, stressing that despite announcement made during his first speech the HR would not have merely advisory role. However, she believes that Schwarz-Schilling is probably going to consult BiH politicians more often than former HR did. Topic assessed that CSS is quite familiar with the situation in BiH, but she emphasized that most of his experience refers to the local communities. According to Topic, HR’s announcements on BiH’s Euro-Atlantic integrations during his mandate are paradox, being that BiH obviously can’t enter EU with such strong role of HR. However, Topic believes that the position of HR is going to be transformed into position of EU Special Representative.</p>

<p>Danas on Ashdown's departure: 'Departure of Guardian of Republika Srpska'</p>	<p><b>Danas</b> front pg splash 'Departure of Guardian of Republika Srpska' and pgs 18-21 'Ashdown was advocator of survival of RS and friend of HDZ, SDA and SDS', by <u>Zvonimir Jukic, Toni Sarac</u> – Weekly comments on the change in the OHR arguing that the ruling parties mostly commended the work of the former HR <b>Paddy Ashdown</b>. On the other hand, say the authors, opposition parties welcomed his departure, such as HSS leader, <b>Marko Tadic</b>, who labeled him as 'the most passionate advocator of survival of the RS'. As for the new HR, <b>Christian Schwarz-Schilling</b>, Danas carries statements of <b>Sefik Dzaferovic</b> (from SDA, hopes that CSS would continue with reform processes), Tadic (expects more positive moves that would lead BiH to Europe) and leader of HSP Djapic-Jurismic, <b>Zvonko Jurisic</b>, who welcomes CSS' appointment, expecting from him to complete economic recovery of BiH. <b>Danas</b>, pg 13 'First task to improve economy', <u>not signed</u> – the weekly assesses <b>Schwarz-Schilling's</b> statement that his priority would be to revive economy in BiH as 'an excellent move'.</p>
<p>Oslobodjenje opened: Schwarz-Schilling could hardly wake us up from nationalistic sleep</p>	<p><b>Oslobodjenje</b> pg 9 'In lap of new nanny' by <u>Gojko Beric</u> – Author comments not much should be expected from newly appointed HR <b>Christian Schwarz-Schilling</b> as he has not even promised much. Commenting CSS' statement on responsibility of the BiH elected leaders to lead BiH towards prosperity, author says that if such leaders did exist, they wouldn't wait for HR to tell them what to do. Author states that international community is still the only supranational and integrative factor in BiH. Author comments that "<i>our new nanny</i>", Europe would still have lot to do to wake BiH up from its "<i>nationalistic sleep</i>". Editorial concludes that even if he would have such intentions, Schwarz-Schilling could hardly wake BiH citizens up.</p>

<p>SNSD leader Dodik officially nominated for RS PM-designate, party claims support of 44-50 MPs in RSNA</p>	<p><b>RTRS</b> late news- RS President <b>Dragan Cavic</b> met SNSD representatives on Wednesday night to discuss the composition of the new RS Government and the appointment of RS Prime Minister designate. After the meeting, SNSD's <b>Krstan Simic</b> stated that the party has officially proposed its leader <b>Milorad Dodik</b> as new Prime Minister designate, adding that he expect Cavic to support this. Simic stressed that, considering the number of votes for Dodik, <b>Nedjo Djuric</b> doesn't stand a chance to get the support of RS National Assembly majority. Cavic is obliged to take the final stance by February 5. <b>Oslobodjenje</b> pg 8 'SNSD expects appointment of Dodik for a Prime Minister designate' by <u>O. V.</u>— After meeting with Cavic, Simic stated that SNSD did not bring a list with names of MPs supporting them, but underlined the SNSD is supported by 44-50 MPs in the RSNA. According to schedule, Cavic should meet with representatives of PDP and SRS on Friday. <b>Dnevni Avaz</b> pg 8 'Dodik could count on support of SDA, SBiH and SDP' by <u>N. **BHT1** – Speculating about the RS PM-designate, BHT 1 comments that SDA, SBiH and SDP support **Milorad Dodik**, while SDS would like to see **Nedjo Djuric**, former member of SP RS, at the position. *"We reiterated our stance that Dodik should be appointed as the RS PM designate"*, said SDA official **Adil Osmanovic**. *"We find it normal to support the strongest political party in the RS, namely SNSD"*, said SBiH representative **Dzevad Osmancevic**. *"We do not exclude the possibility of supporting the candidature of Nedjo Djuric, but we are not going to support those who have been destroying the Government"*, said the SDS representative **Mladen Bosic**. *"I think that the RS President is aware of the fact that Mr Djuric has lesser chances than Mr Dodik"*, said the SDP representative **Zekerijah Osmic**. **RTRS** – Osmanovic confirmed that if Dodik is appointed SDA would participate in talks on assembly of the new Government. He added that for SDA would also consider which parties would make new Government, programme of the work and possibilities for SDA personnel to participate in it. **RHB, PINK, Hayat** – reported on the meeting. **Nezavisne Novine** pg 3, announced on cover 'Dodik has the majority for composing the Government' by V. Popovic – The article reads SDP, NHI, Party for BiH and SDA on Wednesday informed Cavic they support Dodik as RS PM designate. The article also carries statements of Osmic, Osmanovic, Osmancevic and Bosic. **Glas Srpske** pg 5 'Dodik or Djuric' by Z. Markovic, **EuroBlic** pg RS2 'SDS announces support to Djuric' by Rajna Radosavljevic, **Dnevni List** pg 3 'Support to Dodik as RS PM Designate' not signed, **Slobodna Dalmacija** pg 23 'SDP supports Dodik' by B. Kristo – also reported.

<p>SDA leader Tihic: SDA doesn't support HDZ initiative for restructuring of FBiH Govt; nothing officially has been agreed with SNSD regarding forming new RS Govt</p>	<p><b>Dnevni Avaz</b> cover splash 'Nothing has been agreed with Dodik', pg 5 'Due to argument for positions in the FBiH Government and adoption of budged are blocked' by <u>Admir Malagic</u> – In light of recent crisis of the FBiH and RS Governments, SDA leader <b>Sulejman Tihic</b> says in his interview for DA that his party would not support HDZ initiative for restructuring FBiH Government. HDZ made such request after the FBiH Defence Ministry [whose Minister traditionally came form HDZ] was abolished in the course of the defence reform. On the RS Govt, Tihic says that SDA would support SNSD leader <b>Milorad Dodik</b> as new PM-designate. Tihic added that he spoke with Dodik, but nothing has been officially agreed. Talking about constitutional changes, SDA leader said his party is ready for continuation of the talks, underlining that though he doubts ideal solutions are within reach, better solutions than the present ones would be reached. Tihic didn't want to comment on sudden change of stances regarding the constitutional changes. <p>FBiH President Lozancic: Two new ministers must be appointed to hold sessions of FBiH Govt, HDZ doesn't want ministry of portfolio position</p>	<p><b>Hayat</b> by Nebojsa Radulovic – FBiH President <b>Niko Lozancic</b> said on Wednesday that FBiH Government needs to appoint two Ministers, namely a FBiH Minister of Energy, Mining and Industry and a FBiH Minister without Portfolio, in order to be able to schedule the next session. Lozancic added that two candidates run for the position of FBiH Minister of Energy, Mining and Industry but none for the position of FBiH Minister without Portfolio. <i>"In case for position of Minister without portfolio no one has applied while for position of FBiH Minister of Energy, Mining and Industry we have two candidates."</i> concluded Lozancic. Meanwhile, the FBiH Parliament scheduled the session for 7 February, however would not discuss budget proposal for 2006 and FBiH Finance Minister <b>Dragan Vrankic</b> stated that he doesn't know when the next session of the FBiH Government would be scheduled. Reporter ironically added that FBiH Government has to solve the resignation of FBiH Minister of Energy, Mining and Industry <b>Izet Zigic</b> and abolishment of FBiH Ministry of Defence as well as the budget for 2006 but it seems that no one cares. Reporter notes that FBiH and its citizens lack budget, whereas Lozancic and Vrankic do not feel responsible. <i>"I am just one link in the chain"</i> said Lozancic. <i>"This is more issue of politics than of expertise"</i> stated Vrankic. <b>Oslobodjenje</b> pg 6 'HDZ doesn't want minister without portfolio' by <u>A.Omeragic</u> –Lozancic couldn't specify for Oslobodjenje when is he going to appoint candidates for ministers in FBiH Government. Namely, DL was told by the Chairwoman of BiH House of Representatives' Commission for finances and budget, <b>Ljiljana Milicevic</b> (SDS), that the said Commission adopted the proposal of the budget without votes of the SDS and SNSD representatives. Milicevic notes that the SDS MPs in the BiH HoR will reiterate their amendments (to the budget proposal) that 4,5 million KMs be allocated for the BiH Statistics Agency i.e. for preparations for organization of population census, otherwise the SDS MPs will vote against the budget proposal. <b>Dusanka Majkic</b> (SNSD) has the same position.</p>

<p>Ambassador McElhaney: My Government is very interested for urgent passing of FBiH Law on public revenues</p>	<p><b>Oslobodjenje</b> pg 2 'Croat parliamentarians do not want 'imposed' solutions' by <u>A. Terzic</u>– US Ambassador to BiH <b>Douglas McElhaney</b> sent a letter to Collegiums of FBiH House of Peoples, at end of January, in which he pointed to necessity of urgent passing of the law on affiliation of public revenue in FBiH. <i>"Former system of allocation of public revenues was based on sales' tax, which was replaced by new VAT regime. Result of that is that currently there is no system for channeling of revenues from single account to municipalities and cantons,"</i> said McElhaney. At the end of last year, the FBiH House of Representatives passed the draft law foreseeing separate and direct payments of revenues to municipalities and cantons which was later rejected by the FBiH HoP which prefers solution proposed by the FBiH Government under which payments to municipalities go through cantons.</p>

## Economic and judicial issues

BiH parliament's

to Law on  
Ombudsmen

**BHT1** by Boris Grubescic – BiH Parliament's joint commission for harmonization of laws adopted in different texts in Houses on Wednesday failed to harmonize the text of the law on BiH Ombudsmen. Namely, at the end of 2005, the law was passed in both Houses in different texts. BHT1 says that only one member, **Tihomir Gligoric** opposed the changes of BiH Law on Ombudsmen. Due to the fact that amendments to the Law have not been passed, the OHR has already reacted, stressing that it is going to endanger future European integration process. Namely, according to the new law, one ombudsman and two deputies should be appointed with the head office in Banja Luka, while other three would be in Sarajevo, Mostar and Brcko. Ombudsmen would be elected on period of 6 years, while the Chair would rotate every 2 years. The amendments, which are at the same time the condition set by the Council of Europe, foresee abolishment of entity ombudsmen by the end of 2006. *"We absolutely support these principles and we believe that a single institution has to be established"*, said a BiH Ombudsperson **Branka Raguz**. Gligoric insists on having the existing ombudsmen continue performing their duties till the end of their mandate, namely three more years. Other members were ready to accept the amendments. *"If we want to enter Europe, we have to meet standards Europe asks as to"*, said a member of the Parliamentary Commission **Osman Brka**. **PINK, Hayat, FTV, RTRS, EuroBlic** RSpg 3 'Law on Ombudsmen without agreement' by T.V. – briefly reported on session of Joint Commission.
