Conference on ICTY closer contacts with local communities in BiH held in Srebrenica on Saturday

The reason for this is that war criminals who are the most responsible for crimes in Srebrenica are not arrested, she added. "Convictions and sentences can't bring back what was destroyed, can't bring back the people who are murdered, but that is what we do, that is our role," said ICTY Outreach Officer in BiH, Matias Helman. ICTY efforts in finding the truth on war crimes in BiH are not enough alone. "RS judiciary didn't made a single serious step in the past 10 years in order to investigate war crimes and prosecute war criminals," said RS Helsinki Board for Human Rights President, Branko Todorovic. **TV PINK** – Former ICTY investigation judge, Jean Rene Ruez spoke about the most difficult thingshe had faced during his work.
