US Embassy reported that the constitutional amendments would strengthen BiH Council of Ministers and BiH Parliament and that BiH Presidency would become more functional due to establishment of one president and two vice presidents who would rotate every sixteen months during four-year mandate.</p> <p><i>“We call all BiH Parliament Representatives to take the responsibility for making better future for citizens of this country”,</i> US Embassy stated. <b>RHB, TV Hayat, FTV, BHT1, Oslobodjenje</b> pg 2</p> <p>‘Appeal to delegates to take the responsibility’ <u>not signed</u>, <b>Dnevni Avaz</b> pg 2 ‘Take the responsibility for the making of a better future’ <u>by A. | <p>US<br/>Undersecretary<br/>Burns met with<br/>HR, urged<br/>deputies to<br/>adopt const.<br/>amendments</p> | <p><b>RTRS</b> – US Under Secretary for Political Affairs <b>Nicholas Burns</b> asked from BiH to introduce Presidential system instead of current three-member Presidency. During the meeting with High Representative to BiH <b>Christian Schwarz Schilling</b> in WashingtonDC, Burns said that Dayton Peace Agreement should be modernized in order to make BiH normal and single country. Burns welcomed constitutional changes and stressed that the international community should slowly withdraw from BiH and transfer the decision making process onto BiH politicians. <i>“I know that it is the most important that the US is fully engaged in this area. I believe that the US took decisive steps in 1990s in peace establishment so the US has to do the same in 21<sup>st</sup> century and give one more contribution”</i>, the High Representative said. <b>BHT1</b> – Burns urged the Parliament deputies to think about the future of their countries and adopt the proposed amendments to BiH Constitution.</p> <p><b>Oslobodjenje</b> pg 2 ‘Constitutional changes, joint wish of the international community’ <u>not signed</u>, <b>Dnevni List</b> pg 2 ‘Main priority is to complete constitutional changes’ <u>by D. | <p>Will BiH HoR adopt the amendments to BiH Constitution?</p> | <p><b>BHT1</b> – Following the media speculations, which reported that 25 delegates support and 14 delegates oppose the constitutional amendments as well as the decision will depend on votes of the only remaining HDZ deputy <b>Vlatka Komsic</b>, DNZ deputy <b>Ibrahim Djedovic</b> and the independent deputy <b>Sead Avdic</b>, BHT quotes Djedovic as saying that the proposed amendments are not perfect, but he is aware of the responsibility and the need for support to the amendment and he said he was 99% sure he would support the amendments. Avdic and Komsic didn't want to comment their possible votes. BiH Presidency member <b>Ivo Miro Jovic</b> stated that he expected thorough changes of the Constitution, which didn't happen. Still, Jovic believes that the agreed changes represent a progress, and they should be adopted so that the second phase of constitutional reforms can start. Chair of BiH presidency <b>Sulejman Tihic</b> reiterated that, if all deputies come to the Tuesday's session, there will be 27 votes for the amendments.</p> |

Sp.</u> – Municipal Board of the Party for BiH organised a public tribune on constitutional changes in Ilijas. Party for BiH's <b>Haris Silajdzic</b> and <b>Safet Halilovic</b>, BOSS's <b>Mirnes Ajanovic</b>, SDU's <b>Sefedin Suljevic</b> and <b>Kada Hotic</b> from the Association "Movement of mothers from Srebrenica and Zepa enclaves" addressed the participants of the tribune. | <p>43 victims of Susica camp buried in Vlasenica</p> | <p><b>BHT1, TV Hayat, FTV, RTRS, Oslobođenje</b> pg 3, announced on cover 'Funeral for 43 murdered Bosniaks from Vlasenica' <u>by S. Smajlovic, Dnevni List</u> pg 3 'No justification for the fact responsible for crimes have not been brought before courts' <u>not signed, Dnevni Avaz</u> pg 3 'Little daughter Ajla was begging: Let's go mom, I can't take it anymore', announced on cover 'They were killed just because they were of other religion and had different names' <u>by A. Hadzic</u> – Remains of 43 Bosniak victims that were exhumed from mass graves were buried on Saturday in Vlasenica. These victims were killed in camp Susica. Chair of BiH Presidency <b>Sulejman Tihic</b>, who stated that there is no excuse for the committed crime or the fact that the responsible ones still haven't been punished, attended the funeral ceremony. He stressed that the state institutions will insist on truth and justice for the victims and their families. <b>Murat Hurtic</b> from Tuzla team of BiH Commission for missing persons stated that only one third of victims from Vlasenica have been found so far. <b>Amor Masovic</b> from BiH Commission for missing persons sharply criticized the fact that persons responsible for war crimes are often hiding in other countries, and they are not being extradited to BiH. <b>FTV</b> – So far, only one person has been sentenced for the crimes committed in this area – the commander of Susica camp <b>Dragan Nikolic</b>. <b>RTRS</b> – BiH Presidency Chair Sulejman Tihic said that return of refugees and support to their stay is necessary for the reestablishment of the multiethnic structure.</p> |

Head of the Centre for Security Strategy <b>Claude Monet</b> (SP) stated that in comparison to Afghanistan , BiH is not a safe place for terrorists, and there are no terrorist training camps there. He added that according to some sources, asylums for terrorists exist near Zenica, but he stressed that the number of terrorists there is not large. According to Monet, terrorist can more easily hide in Belgium of Netherlands. He emphasized that BiH Muslims could be of a great help to anti-terrorism campaigns.</p> |

| <p>RS PM Dodik: it is necessary to adopt final decision on distribution of ITA funds</p> | <p><b>TV Pink</b> – According to PINK, at its session that was held on Thursday in Sarajevo, Members of Indirect Taxation Administration (ITA) Steering Board reached technical agreement on allocation of resources from the single account, which should be supported by political agreement of entities' prime ministers and BiH Council of Ministers Chair. If the political agreement were reached, ITA Steering Board would hold another session on Wednesday in order to unblock resources from the single account. RS Prime Minister <b>Milorad Dodik</b> stated that it is necessary to determine a clear methodology and adopt a final decision on distribution of public revenues in BiH. Dodik also said that RS Government wants to support indirect taxation system since it gave high incomes to RS last year but it does not mean that RS is satisfied with the way of allocation of resources. <b>BHT1, RTRS, Oslobođenje</b> pg 9 'Methodology of clear accounts' <u>by Fena</u> – also carry Dodik's statement.</p> |

RS PM Dodik denies US Ambassador and Head of EC Delegation told him to stop politically interfering in police reform

Dodik explained he had not discussed police reform with US Ambassador at all on the occasion and stated they discussed only constitutional changes and, with regard to his conversation with EC Delegation Head, Dodik said they did talk about the police reform and he only reiterated already known stances of RS on this issue. *[Note: the title of Oslobođenje article refers to the statement given with regard to distribution of ITA funds]* **Dnevni Avaz** pg 9 'Prime Minister, thank you for confirming the correctness of reports of "Dnevni Avaz"' by Edina Sarac – **Dnevni Avaz** journalist replied to the denial of RS PM Dodik by saying his reaction only confirmed the correctness of this paper's reports, and she also criticised him for persistently fighting only for "Serb people", "Serb police", "Serb entity" etc.
