NHI: Covic avoids responsibility	RHB – Commenting on the Dragan Covic's statement that the indictment against him is actually directed against the Croat people, NHI issued a press release, which says that in order to avoid his personal responsibility Covic started to hide behind the Croat people.

<p>BiH HoR in session, some provisions of FTAs on agenda</p>	<p>BH Radio 1 <u>Mustafa Karahmet</u>, RHB, RS Radio</p> <p>– The BiH House of Representatives holds the session today to discuss the implementation of the Free Trade Agreements with Croatia and Serbia and Montenegro. Representatives were addressed by the Chair of the CoM, Adnan Terzic, who explained in details as to why CoM has decided to suspend some provisions under FTAs by saying the introduction of the customs taxes for some goods from those countries was a result of the FTAs violations. Claiming that this measure was fully in accordance with the FTAs, Terzic said that two days ago he talked to Croatia and SCG Prime Ministers in Brussels about this, adding they have agreed to discuss this issue in details soon.</p>
<p>OHR welcomes Pandurevic's surrender</p>	<p>BH Radio 1 <u>Brana Markovic</u> – OHR office in Banja Luka said today that OHR welcomed the surrender of retired RS Army general, Vinko Pandurevic, to the ICTY. Pandurevic, accused of war crimes committed in Srebrenica, on Wednesday voluntarily surrendered to the Tribunal. OHR also said that the international community will continue to closely monitor RS authorities' further conduct in cooperating with the ICTY, stressing that all other ICTY indictees at large must be transferred to the Hague, including Karadzic and Mladic. This is the only way to remove the obstacle to BiH's path to EU and NATO, says OHR.</p>

<p>PDHR Hays: BiH still not become a real state</p>	<p>RS Radio – Donald Hays, PDHR, stated in Washington that BiH has not still become a real state, adding that OHR hardly identifies true partners. Participating in a Round Table dedicated to The Balkans, organised by Washington Peace Institute, Hays stressed that nobody in BiH cares about the budget, neither does anybody know where the financial assistance was used and what is the real level of corruption. Hays stressed there are many international financial institutions in BiH, that, regardless of their mandates, policies and directives, do not know what they should do. He also said that apart from numerous difficulties, a progress achieved is visible, especially through strengthening of central authority and with the assent of entity governments. As examples, Hays referred to joint defence ministry, joint intelligence agency, border and customs services. In his view, the Dayton Peace Agreement has been outdone in BiH. He also stressed that BiH must start thinking about creation of the constitution, that would provide foundations for sustainable state.</p>

<p>DA: Ashdown to replace Covic at beginning of next week</p>	<p>Dnevni Avaz cover splash 'Ashdown will replace Covic', pg 2 'Paddy Ashdown will replace Covic next week' by <u>S. Numanovic</u> – DA learns that the HR Paddy Ashdown will replace Dragan Covic at the beginning of next week from the position of the BiH Presidency member. Article reads that it is unclear who would replace Covic, while the most speculated name is that of Martin Raguz, current Deputy Speaker of the BiH House of Representatives. DA says that Raguz is interested in taking over both Presidency and the HDZ President positions, however there is a strong opposition within the party to this. "Covic is strongly against having Raguz to take over. One of the reasons for [Covic] delaying the resignation is an effort to prevent Raguz to take over his place," claims that author adding that Covic is supported by Niko Lozancic, and several other ministers in the Federation institutions. However, despite the fact that some of them may leave the positions following Covic's potential removal, DA says that HDZ is not expected to cause any crisis in the state authorities.</p>
<p>Possible candidates for replacing Covic are eight Croats from BiH Parliament</p>	<p>Dnevni Avaz pg 2 'Eight Croats in BiH Parliament' – If removed, Dragan Covic is to be replaced by one of the eight Croats from the BiH Parliament, while the law doesn't stipulate that a person would have to come from the same party. The possible candidates for the position are: Martin Raguz, Vinko Zoric, Filip Andric, Ivo Miro Jovic and Ruza Sopta from HDZ; Jozo Krizanovic from SDP; Ivo Lozancic, an independent delegate who has just left the NHI; and Mladen Potocnik, another independent representative.</p>

Covic said that he would do that if BiH is a normal, democratic country, but it is not. Covic expressed his readiness to respect the High Representative's decision on his removal, if that happen. He also underlined that indictment against him is only part of political campaign directed against Croats in BiH. <i>"I don't take those pressures to which I have been exposed these days as something against Dragan Covic, I take this as pressure on the people that I represents, Croat people"</i>, said Covic. He added that indictment is full of insinuations and that proved criminal is invited to testify against him as protected witness. <i>"I believe that the time has come to stand up and save the BiH for our children, in order to avoid repeating of war horror"</i>, stated Covic. Asked for comment on OHR's warnings that his decision not to resign would seriously damage BiH's reputation, Covic said: <i>"I think that we damaged BiH's reputation long time ago, by adopting catastrophic measures in this State."</i></p>

<p>Zagreb's Jutarnji List interview with Covic: They want my removal in order to divide Bosnia</p>	<p>Jutarnji List pg 13 'They want my removal in order to divide Bosnia' <u>by S. Pavic</u> carries an interview with Croat member of the BiH Presidency Dragan Covic (the article notes that the interview was conducted before Covic's press conference held on Wednesday). Asked as to why there is a wish to remove him, Covic says: <i>'Internal re-organization is ahead of BiH, and we stand for the organization of BiH as a state of three constituent peoples, who will be equally constituent on the whole BiH territory. It will be difficult to realize this idea since it does not correspond with the strategy of certain power-wielders from international institutions who look at the area of whole Balkan more globally. I am deeply convinced that they want to create BiH, which will finally have two entities, one with Serb domination and another one with the Bosniak domination... I am aware that I could profit a lot on the ground of my withdrawal since there were many offers, which said 'just withdraw and you can choose what you will be doing'.'</i> Covic refused to say what concretely was offered to him.</p>

<p>DL editorial on Covic's decision to remain in office</p>	<p>Dnevni List pg 2 'Covic's manipulations' by <u>D. Polovina-Mandic</u> carries an editorial on Dragan Covic's decision not to withdraw from his current position and the author says: <i>'Having made such decision Covic completely consciously started a battle against the whole International Community and he involved in this battle all citizens and the state that he represents in order to protect his personal interests exclusively...Nevertheless, Covic is right when he says that consequences of his decision will be serious, however, these consequences will be even more serious for us since thanks to our votes Covic and others like him lead us to total disaster.'</i></p>

<p>NN op-ed on Covic</p>	<p>Nezavisne Novine op-ed pg 7 'Covic case' by <u>Natasa Krsman</u> – Referring to Wednesday's press conference of Dragan Covic, the author ironically notes that message was sent out this state is not normal, since media are exerting pressure on basis of upheld indictment, and because prosecutors have published such an indictment, and diplomats from all over the world called on Covic to resign. She notes that transferring of responsibility for a concrete criminal act onto the Croat people does not surprise at all, since leaders of nationalistic parties seem to be doing it regularly. She concludes Croat people has not benefited from tax evasion case in "Lijanovic" affair, neither has Serb people benefited from "Orao" affair or Bosniak people from affair related to Hasan Cengic. She stresses it would have been appropriate if leaders of other political parties had supported independent judiciary instead of supporting their coalition partners.</p>
<p>Danas editorial on Covic's case: Croat member of BiH Presidency without any authorities</p>	<p>Danas Mostar-based magazine pgs 14 -17 'Croat member of BiH Presidency without any authorities' by <u>Danas investigative team</u> carries that in case that Dragan Covic remains a Croat member of the BiH Presidency, Croats would have a virtual 'President' whose suggestions, proposals, objections etc. will be heard only within a narrow circle of his colleagues from HDZ and political circles such as Sulejman Tihic and Borislav Paravac. According to Danas, such situation suits Paravac and Tihic since in that case they would be the ones who will be passing all crucial political decisions. Danas also says that as a result of Covic's and HDZ uncompromising cooperation with the OHR the judiciary reform was carried out and foreign judges and prosecutors were installed as mere observers. The article goes on to say that only after the lawsuit for the Lijanovici case was filed, Covic started to attack these judges and prosecutors, who came to the BiH Court after Covic's party made it possible for them.</p>

The author also says: <i>'Ashdown has just partly succeeded in achieving of the basic task: approaching BiH to the moment when it will be able to mover further by itself without the intervention of the International Community. For this reson, Ashdown's successor, no matter whom it would be, will have a lot to do.'</i></p>

<p>Ashdown addresses UN Security Council</p>	<p>BHT, Hayat, Oslobodjenje cover page, pg 5 'RS still not established full cooperation with The Hague', Dnevni Avaz pg 4 'There is too much politics in work of BiH police' – High Representative Paddy Ashdown addressed the UN Security Council on Wednesday. He was talking about the started reforms as the greater part of his report was dedicated to the BiH cooperation with ICTY. He said that ten years after Dayton and Srebrenica the fight for justice has still not been ended. Ashdown also said that BiH citizens think there is too much politics in the work of BiH police and he added that he agrees with that. He said that RS will remain to exist and emphasized that he is in charge of Dayton Agreement implementation. At the end, the HR spoke on cooperation with ICTY and he commended authorities in Banja Luka regarding the recent voluntary surrenders to the ICTY. This process in BIH will be continued all until all the most wanted ICTY indictees including Radovan Karadzic and Ratko Mladic are arrested.</p>

Dnevni Avaz pg 8 'Defense reform is being carried out for the security of BiH', *Oslobodjenje* pg 6 'BiH Defense Ministry finally filled', **FENA** – It is not for entity parliaments to decide on the nomination for full membership of BiH in NATO, but this is something the state parliament will do after BiH joins the Partnership for Peace program, NATO Headquarters in Sarajevo Commander Gen **Steven Schook** said on Wednesday speaking to members of the Joint BiH Parliamentary Commission for Defence and Security and Control over the Work of Defence and Security Structures in BiH. *"The BiH Presidency expressed willingness on a number of times to join the PfP and eventually NATO. Despite this the RS National Assembly adopts the position that, once BiH joins the PfP, it would decide on whether the country will join NATO or demilitarise. This is certainly not within the authority of any entity"*, Schook said. He said that once BiH meets all requirements for membership in NATO the BiH Parliament will have the role of ratifying accession to NATO, and not the RS or FBiH. He added that the SDS led RS Government has also set a number of limitations before members of the Defence Reform Commission from the RS in developing a full range of proposals for fulfilling requirements of NATO and OHR for further systematic reforms, *"including reforms that are necessary because of the fact that there are still people in the military supporting Ratko Mladic and other indicted war criminals"*. Schook expressed hope that the SDS led RS Government will consider changing its position and give its members of the Commission all that it needed for fulfilling the requirements of NATO and OHR. *"The bottom line is that defence reform is being implemented because of the security of BiH and not the further existence of the RS"*, Schook said.

Dnevni Avaz pg 5 'I expects abolishment of the recruitment in fall', mentioned on cover, by Sead Numanovic – The Co-Chair of the Defence Reform Commission, **Raffi Gregorian**, says in an interview to DA that defence reforms are not in a deadlock, despite the 18 March's decision of the RSNA to limit the work of the Commission, and he noted a progress has been achieved. Asked what BiH could expect at the NATO's Summit to be held on 20 April regarding its pending membership to the Partnership for Peace, Gregorian says that the precondition is the full cooperation with the ICTY and arrests/extradition of the PIFWCs. *"As long as they are at large, this condition has not been met. What will NATO say – that depends only on BiH. If issue of **Karadzic** and **Mladic** is solved by that day, than the entry is certain. RS MoI **Darko Matijasevic** recently said that they are not in BiH. I was surprised by that attitude because it foresees one to know where those two are and to forward the information to the authorities... Claiming they are not in BiH was very interesting and a surprise for me. However, you should know that NATO wants to see BiH in the Alliance,"* says Gregorian. Commenting the possible abolishment of the recruitment process in BiH armed forces, Gregorian says such decision could be made recently and the process should start in summer/fall. On the abolishment of the entities Defence Ministries, Gregorian says that all preparations must be completed by 1 July. He notes the abolishment itself doesn't have to be carried by the end of this year, or even next, because the most important thing is to transfer authorities from those MoDs to the state Ministry, while the act of institutions' abolishment itself is not essential.

Macanovic, **EuroBlic** cover pg splash and pg RS1 'Bosnia cannot enter NATO without army' by Rajna Radosavljevic – BiH "from a functional aspect" should not have three defense ministries, just as none of the NATO participating states have a decentralized chain of command, the standing representative of Slovakia to NATO, **Igor Slobodnik**, said on Wednesday in Banja Luka. During talks between NATO representatives and the military and political officials in the RS, he said that BiH is on a good path towards NATO because it has made substantial progress in defense reform and cooperating with the ICTY, but noted that certain conditions must be fulfilled. In this context, he indicated one political condition – establishing a full cooperation with the Hague Tribunal. Should BiH decides to carry out demilitarization, this would mean that it is giving up on NATO membership since every country must give its military contribution, Slobodnik said in response to a question on the initiatives for demilitarization of our country. Chairman of RS NA Committee for Defense and Security **Velimir Sakan** claims he does not understand why defense reform concept that would be carries out trough entity institutions was unacceptable. Chairman of SDA Caucus at RS NA **Tarik Sadovic** thinks RS politicians believe in vain they could persuade 'the big and powerful ones they were right'.

The current constitutional structure was marked as not functional. The report also says that if part of authorities would be transferred from the lower levels of government to the BiH Council of Ministers (CoM) the governmental structure like that would be the most acceptable.</p>
<p>IFIMES: Ashdown should leave before end of mandate</p>	<p>Dnevni List pg 7 'Ashdown should leave before end of mandate' by <u>NINA</u>, Vecernji List pg 2 'Ashdown leaves before end of mandate' by <u>vr</u> carry that International Institute for Middle East and Balkan Studies (IFIMES) believes that High Representative Paddy Ashdown should abandon this position before the end of his mandate. IFIMES also believes that the HR is the most responsible for the complete situation in BiH in the last 2 years and the he extremely complicated the BiH political scene by accepting national parties as partners. According to IFIMES, the compromise solution in the German-French competition for a position of the Ashdown's successor might be election of the HR from Slovenia or Macedonia since these states are not neighbours to BiH and people from IFIMES claim that some circles in Brussels already discuss this possibility.</p>

FTV, Oslobođenje pg 2 'SDP will not participate in Sarajevo City Council', **Dnevni Avaz** pg 8 'Comprehensive and fast reforms in the interest of all citizens', **FENA** – US Ambassador to BiH **Douglas McElhaney** on Wednesday visited the BiH Social Democratic Party (SDP) and held talks with its President **Zlatko Lagumdžija** about the current events in BiH, economic and security reforms, the unconstitutional establishing of the Sarajevo City Council, and future activities, SDP said in a press release issued following the meeting. Lagumdžija informed Ambassador McElhaney about the *"brutal violation of the principles of equality of peoples and citizens, the BiH Constitution and the Election Law in Sarajevo"*. He stressed that SDP deems that the constituting of the City Council without the representatives of a constituent people is illegal and illegitimate so that the party will not participate in work of such a council.

On this he added: *"I am of the view a large number of them would get satisfaction at the Court."*

– SIPA is not able to open the fourth regional office because SIPA top officials and the BiH Council of Ministers cannot agree on where this office will be seated. This was stated by the Chairperson of the Parliamentary Defence and Security Commission, **Bosko Siljegovic**. According to the proposal made by SIPA Director **Sredoja Novic**, apart from Banja Luka, Mostar, and Sarajevo, Brcko should also be one regional centre. However, the CoM Chairperson **Adnan Terzic** wishes to see Tuzla as seat of the fourth regional centre. SIPA also has problems with the filling of vacancies, as the law does not allow allowances for what is called separate life – life apart from one's family, in another town. The lack of facilities, i.e. a permanent location for SIPA, also remains a problem hindering the filling of vacancies within SIPA.
