<p>Dusan Stojicic tenders resignation from RSNA Speaker position; RSNA discusses new Government</p>	<p>BH Radio 1 by <u>Brana Markovic</u> – The RS National Assembly holds the extraordinary session today, which opened with Dusan Stojicic's tendering of the resignation from the position of the RSNA Speaker. Stojicic accused the new RSNA majority of <i>"trying to put all the main positions under their authority."</i> RSNA will discuss appointment of the new RS Government lead by RS PM-designate Milorad Dodik. RSNA Deputy Chair Tomislav Tomljenovic took over presiding by the time the new Chair is appointed. New SNSD-led majority proposed SNSD's Igor Radojicic for this position.</p>
<p>FBiH HoR in session, expected to discuss PBS and new ministers</p>	<p>BH Radio 1 by <u>Maida Alic</u> – The FBiH House of Representatives holds session today, and is expected to discuss the Law on FBiH Public Broadcasting Service [PBS] and three new ministers in FBiH Government. Candidates are Minister of Energy Vahid Heco, Minister of Environment Ferid Otoja and Minister of Tourism Katica Cerkez.. Twenty representatives of disabled persons spent the night in the building of FBiH Parliament after the issue of budget was not put in agenda.</p>

BiH lawsuit vs. SCG for aggression, genocide

<p>Process in lawsuit BiH vs SCG for aggression and genocide commenced in The Hague ;</p> <p>BiH's representative said that they would prove Belgrade 's responsibility in genocide</p>	<p>BHT1 by <u>Boris Grubestic, The Hague</u> – At the first hearing in the case of the BIH lawsuit against SiCG before the International Court of Justice in The Hague [which as was reported drawn a large attention from media, international officials and diplomats, including the ICTY Prosecutor Joanne Korner and ICTY Presiding Judge Theodor Meron] Sakib Softic, BH representative, stressed that the aim of BIH team is to prove the responsibility of the authorities from Belgrade for the genocide in Sarajevo and Srebrenica. Deputy Head of the BiH team, Phon van den Biesen, said that the destruction of non-Serb population in BiH did not happen accidentally and that suffering was the result of a carefully prepared military, political and economic plan. At this first round of the debate, he added that BIH Team would also present video material as evidences. RTRS – Softic said that BiH wanted neither revenge nor collective guilt, but acknowledgement through the process that SiCG violated international Convention on Genocide during the war in BiH. He added there nobody denies the fact that Serbs in BiH were war crimes victims as well, but underlined crimes committed against them were not a part of official politics by the Government in Sarajevo. Radoslav Stojanovic, SiCG representative, commented that Bisen has not explained what genocide was, neither logically not theoretically. FTV– Biesen talked about the ideology of “Great Serbia” stating this was not only a political agenda, but from very beginning a military operation with the aim of ethnic cleansing. <p>Citizens gather in front of ICJ protesting in sign of support for the BiH lawsuit vs. SCG; Mothers of Srebrenica: someone has to be held responsible for sufferings</p>	<p>Hayat by <u>Asim Beslija</u>, The Hague – Parallel with the opening arguments by lawyers in the case of BiH vs. SCG before the International Court of Justice, hundreds of people gathered in front of the ICJ building in the Hague protesting in a sign of support for the process. Protesters included women from Srebrenica and BiH citizens currently living in The Netherlands and Germany. They carried a 60-meter long poster with the names of victims of genocide in Srebrenica. FTV By <u>Arijana Saracevic-Helac</u>, The Hague – Director to BiH Institute for Endangered People Fadila Memisevic said in an interview for FTV that this lawsuit is very important for the future of BIH and for mothers from Srebrenica as it would ensure that live in their country without the entity responsible for their situation. Memisevic stressed that no one from the Dutch Parliament came to meet them at the protests: <i>"This only proves that they were accomplices to SiCG and that they disapprove BiH's lawsuit. We expect IC to support this lawsuit and redeems for the injustice done to BIH."</i> PINK – "Someone has to be held guilty for our sufferings," said the chair of Association of Mothers of Srebrenica and Zepa, Munira Subasic. <p>Reactions of BiH officials; Dodik claims that BiH is to enter period of political instability because of the lawsuit</p>	<p>BHT1 by <u>Lejla Zvizdic</u> – Brining the reactions on BiH lawsuit vs. SCG, BHT 1 comments the newspapers headlines such as "Trial to Serbia for genocide" or "Justice before dusk" best describe divided stances of BIH officials. For some, reports notes, the proceeding is a tool for justice while others deem it as the new factor of political instability. Member of BiH Presidency, Sulejman Tihic, believes the lawsuit is to establish the truth and serve the justice, stressing the process <i>"is not against Serb people in BiH or SiCG"</i>. RTRS – RS Prime Minister designate Milorad Dodik deems the lawsuit is illegal, adding the BiH agents have no legitimacy to speak on behalf of the state and that by accepting the suit the ICJ would prove that it was not a court of justice but of injustice. <i>"We believe that the beginning of the court process would lead to misunderstanding in BiH and that BiH would enter another period of political instability"</i>, said Dodik. Paravac said that Serb people in BiH believe that war was caused by illegal separation of BiH Serbs from their motherland, Serbia. <i>"Do you know what it means to separate the child from its mother? That is a pain inflicted upon Serb people and it will not healed easily"</i>, stressed Paravac.</p>

Namely, according to the author, should SCG be found guilty, it would be officially labelled as a sponsor of crimes in an other state, which would implicate the issue of war reparations. <u>Kozina</u> also notes that the lawsuit could go other way around, that BiH loses it that is, and in that case, <u>Kozina</u> reckons there would probably be <i>"mass political accusations in Sarajevo"</i>.</p>

According to report, French "Le Mond" and British "Independent" assessed that accusations regarding genocide will be hard to prove. The Berliner "Die Tages Zeitung" stressed it would be easy to declare suit legally ungrounded since suit SiCG filed against NATO was rejected. International Herald Tribune 'Bosnian lawsuit gets under way at The Hague' By <u>Marlise Simons, NYT</u> – Commenting BiH lawsuit against SCG, article alleges that, according to some ICTY officials, the Hague tribunal was unable to obtain documents from Serbian archives because Belgrade feared they could be used against them in the suit before ICJ, adding that the arrest of Ratko Mladic may also have been delayed on the same ground. Times 'Historic genocide trial of Serbian nation begins' by <u>Sam Knight</u> – Commenting the case, author comments that although BIH "lawyers have said that their chief aim is the historical judgement of Serbia, billions of dollars of compensation could follow a guilty verdict. The court's rulings are binding, and a refusal to abide by them could be referred to the UN Security Council for action." Washington Post and Telegraph also reported on the lawsuit.</p>

<p>EU Foreign Affairs Ministers set another deadline for SCG ; extradition of Mladic by April 5 or suspension of SAA talks</p>	<p>BHT1 by Elvir Bucalok, Brussels – At the session held in Brussels on Monday, the EU Foreign Ministers warned SiCG and BiH, precisely RS, that the negotiations on Stabilization and Association Agreement (SAA) with EU could be suspended if both countries fail to fully cooperate with ICTY. EU Enlargement Commissioner Ollie Rehn stressed that EU Ministers have decided not to freeze the negotiations with SCG, but they expect that war crime indictee Ratko Mladic to be arrested and extradited to the ICTY before April 5 before the beginning of the second round of the SAA negotiations. FTV– “If [SCG] fails to unconditionally cooperate with ICTY than the SAA negotiations will be stopped” stressed Rehn. The EU Foreign Ministers have expressed unreserved support to the messages the EC sent recently to Belgrade and Sarajevo, demanding the full cooperation with the ICTY. Otherwise, SAA negotiations are to be stopped. RTRS – “We would like the SiCG cooperation with the ICTY to be full. If that is not to happen, SAA talks will be halted. But, still, there is enough time; negotiations will not be held before the end of March”, said EU HR for the Common Foreign and Security Policy Javier Solana. RTRS – The Chief ICTY Prosecutor Carla del Ponte said that if Ratko Mladic were not to be arrested, Belgrade would have to face consequences. The SAA negotiations, scheduled for April 5 are not going to be held, said del Ponte. <p>BiH CoM Chair Terzic: I am surprised BiH is mentioned in context of cooperation with ICTY</p>	<p>Oslobodjenje pg 3 'Bad signal for BiH' by <u>R.I.</u> – BiH Council of Ministers Chair Adnan Terzic stated that he was surprised by the statement of EU Council of Ministers according to which BiH would may also face a halt in the SAA negotiations if full cooperation with the ICTY is not reached: <i>"I am surprised that BiH is now mentioned in the context of cooperation with the Hague. It is obvious that we in the region have problem with 25 different European policies. ... Involving BiH in the new situation, pointing finger at our country for non-cooperation with the Hague is bad signal. It is also a signal that EU countries' foreign policies cannot have clear stances for the region."</i></p>
<p>Serbian officials: EU warning was serious</p>	<p>FTV– SiCG Minister of Foreign Affairs Vuk Draskovic stated that the officials in SCG should take the warning issued by the EU Foreign Ministers seriously and complete the request on the ICTY cooperation within the set deadline. BHT1 – Serbian Deputy Prime Minister Miroljub Labus stated if this time SAA negotiations with EU were not frozen it doesn't mean that they won't be in future. SiCG Defence Minister Zoran Stankovic denied the speculations that Mladic asked for money in order to surrender adding that Mladic is not interested in financial gains.</p>

SNSD's Dodik claims he enjoys support of 45 MPs in RSNA; SDP denies support because of disagreement on ministerial positions

RTRS – The RS National Assembly will hold session on Tuesday on the issue of appointment of the new RS Government. The RS Prime Minister designate **Milorad Dodik** claims he enjoys support of 45 RSNA representatives. He added his Government would not receive support by three SDP representatives, since they could not reach an agreement on the ministerial positions. *"They are asking for ministerial positions which belong to a Serb and Bosniak; we offered them a position of Croat and Bosniak and they rejected it...SDP will neither support nor take part in the Government"*, said Dodik adding that despite the SDP's stance, his Govt will receive majority support. On Monday, Dodik met with representatives of 'SPONA' NGO, the RS Trade Union, farmers and the RS Employers Association, Trade Union and Employers Association representatives have supported the new RS Government's concept. **Dnevni Avaz** pg 11 'SDP was definitely left without Ministerial posts' by N. RS PM designate Dodik: priorities of the new RS Govt will be adoption of budget, increase of funds for pensioners, education workers, police; It is necessary to reconstruct CoM

Nezavisne Novine pg 5, announced on cover 'Strongly against crime and corruption' by Vesna Popovic – In a full-page interview to NN, RS PM designate **Milorad Dodik** comments the priorities of the new Government announcing it would first see the budget is adopted, funds for pensioners increased, as well as for education workers (although he noted he is aware of the fact he would face problems with IMF over this), the funds for police would also be increased in order to make them possible to do their jobs without obstacles as the Government intends to strongly fight crime and corruption. In light of this, Dodik announced establishment of the special prosecution for the economic crime in the RS Prosecution. *"We will place people who would in the first month set the framework and code of conduct... I believe that High Judicial and Prosecutorial Council will not object people we choose,"* said RS PM-designate. He added that the law on privatisation audit should be presented as soon as during the next RS NA session. According to Dodik, if the Government is not satisfied with the work of courts and Prosecutor's Offices after two or three months, then salaries of judges and prosecutors would be reduced down to the amount of an average RS salary. Asked whether SNSD would withdraw its support to BiH CoM, Dodik said SNSD believes it is necessary to reconstruct CoM. **'Adnan Terzic** *is aware of the crisis at CoM and is now launching a story on European integrations and says he would resign if this does not pass. I am sending out a message to him – SNSD will not vote for this story on European integrations and, should there be more people who will not vote for this, we will help Terzic to resign'*, Dodik said adding that Terzic's handicap lies in the fact his mentor **Paddy Ashdown** had left and now he does not have a support.

<p>FBiH HoR fails to harmonize entity's public broadcasting legislation with state law</p>	<p>Hayat – On Monday, FBiH House of Representatives was expected to harmonize the proposed law on FBiH Public Broadcasting Service with the law on the state level, but failed to do so. On Sunday, OHR reminded that this law is one of the main conditions BiH has to fulfil if it wants to continue moving forward on the path towards the EU, but despite that FBiH HoR decided to discuss this law as the 11th item of the agenda. EC objection to this law refers to the fact that law defines FBiH as the founder of FBiH Public RTV System. FBiH Communications Minister Nedžad Branković stated: <i>"We deem that it has to be defined who is the founder or the owner, it has to be known who controls the finances."</i> Representatives of political parties have different stances on the draft law and SDP's Damir Masić stated that this proposal is inadmissible, since it violates all principles on public system. SDA's Irfan Ajanović stressed that SDA supports the law, but that it might be good to present it on public discussion.
