<b>Pec-Mlini hydro-electric power plan put into operation</b>	<b>RHB, BHT 1, FTV, RTRS, Dnevni List</b> front pg 'Hydro-electric power plant put into operation' and pg 5 'Trial run of hydro-electric power plant Pec Mlini put into operation' by <b>Z. Skoko</b> , <b>Vecernji List</b> front pg 'Hydro-electric power plant Pec-Mlini put into operation' and pgs 2 and 3 'Pec Mlin on trial run' by <b>M. At the ceremony, it was also stated that apart from producing electric energy, the great significance of Pec Mlini is in function

Zivak</u> – Terzic also said that this visit has not solved the issue of a credit which burdens relations between two countries for a long time, adding that authorized Ministers will meet soon in Sarajevo to discuss this issue.</p>

**FBiH Gov in session: on production of electricity, retiring of soldiers, financial situation in FBiH MoD**

**RHB, Dnevni List**, pg 4 'Production of electricity bigger than planned', by NINA – The Federation of BiH Government at its Thursday's session in Mostar, amongst other issues, took a Decision on changes and amendments to Decision of favourable conditions for going into age retirement of the FBiH military personnel. The Decision should allow people, who are affected in the process of downsizing of the FBiH Army, to go into age retirement.

**FTV, Oslobodjenje** pg 5 'About 515.000 KM for help devices' by Fena, **Dnevni Avaz** pg 15 'Soon sale of a part of JNA property' by Ad.H. – Government also decided to invest approx. 500,000 KM from a budget of FBiH Veterans Ministry into the medical treatment of soldiers and disabled soldiers. As for the early retirement, enabled following redundancies in the process of reforming armed forces, FTV says that it has been estimated that about 700 soldiers will apply for it. Most of them have a salary of 700 KM, which means about 3,5 million KM are needed for their pensions. **Radovan Vignjevic**, FBiH Minister for Labour and Social Policy: *"That is about 0,5% of total income of Pension-Disability Insurance Fund. At the session, I emphasized commitments of the government... that the money for privileged pension must be ensured from the budget."*

**Slobodna Dalmacija**, back pg 'Military real estate too much a burden', by Zoran Zekic – The FBiH MoD, led by Minister **Miroslav Nikolic**, is of opinion that all the military real estate, such as barracks, ranges, warehouses etc, are becoming too much of a burden because of financial difficulties the FBiH Army is in. According to the Programme of rectifying financial situation in the FBiH MoD, the right (to the real estate) should be transferred onto third parties.

<p><b>FBiH Government and HT Zagreb in talks on transfer of Eronet shares onto HT Mostar</b></p>	<p><b>Dnevni List</b>, pg 3 'Mudrinic and Hadzipasic optimists regarding transfer of share in Eronet', mentioned on front, by <u>Jurislav Petrovic</u> – A delegation of the HT Zagreb, led by the President of its management, <b>Ivica Mudrinic</b>, visited Mostar on Thursday and also held a meeting with the President of Management of HT Mostar, <b>Stipe Prlic</b>, FBiH Prime Minister, <b>Ahmet Hadzipasic</b>, FBiH Finance Minister, <b>Dragan Vrankic</b>, and FBiH Communications Minister, <b>Nedžad Brankovic</b>.</p> <p>According to DL's information, the meeting was dedicated to the issue of transfer of HT Zagreb's shares in Eronet onto HT Mostar. According to a senior, anonymous official of the FBiH Government, certain guidelines that would help find an acceptable solution to the transfer of the shares were adopted and a decision was taken that an expert team comes up with a memorandum within two weeks time, which would satisfy both parties.</p> <p><b>Vecernji List</b>, pg 4 'Mudrinic and Hadzipasic in new round of talks on HT Mostar', by <u>Zoran Kresic</u>–VL notes that HT Zagreb and representatives of the FBiH Government made a joint Memorandum of Understanding, which foresees the transfer of the share. Apparently, the Memorandum will be discussed at the next session of the FBiH Government. According to Prlic, the parties are close to reaching an agreement.</p>
<p><b>RAK denies Eronet's allegations</b></p>	<p><b>RHB, Dnevni List</b>, pg 3 'RAK denies allegations by Eronet', <u>not signed</u>, <b>Slobodna Dalmacija</b>, pg 17 'Eronet does not have working permit', by <u>M. Landeka</u>–The Communications Regulatory Agency (RAK) denies allegations by 'Eronet' that the RAK is preventing the development of the company and in fact wants to destroy it by not allowing 'Eronet' to use a slot of numbers that begin with 8xx xxx. RAK General Director <b>Kemal Huseinovic</b> reminds that 'Eronet', as an operator that does not have the licence to offer communications services, is not competent to raise issues pertaining to allocations of GSM numbers.</p>

<p><b>OHR to help domestic authorities to sell Natron company</b></p>	<p><b>Dnevni Avaz</b> pg 11 'To the best buyer of Natron, through OHR' by A.Dz. – FBiH Government and Zenica-Doboj Cantonal Government will try to find the best possible solution regarding the sale of Natron paper company from Maglaj, with an assistance from OHR. Upon OHR request, after several months of fights and mutual accusations, both bids for the purchase of the company will be examined – giving a chance to both Turkish businessmen from company Hayat Holding and Austrian consortium AHW.</p> <p><b>FTV</b> – According to FTV, both bidders offer the same financial investment. However, Zenica Doboj Cantonal government is believed to prefer the bid of an Austrian investor, who also offers necessary technical solutions thus ensuring employment for 850 workers, while Turkish investor requests guarantees for amount and price of wood, as well as other privileges, which government can't guarantee. Government established a negotiation team which will continue to talk with both investors, with preference to Austrian investor, who already signed a preliminary contract with ZDC.</p>

on VAT**

**BHT 1** by Tomislav Djuric – The International Monetary Fund has recommended to BiH the single VAT rate of 17% for all products, however BiH House of Representatives' Commission for Budget and Finances has passed amendments which directly oppose IMF recommendations. Draft VAT Law went through the changes, however their creators aren't changing their attitudes. This way, even though IMF recommendation foresees bread price to increase for pfl10, according to the amendments passed by the Commission that price will stay the same. **Enver Kazazic**, member of management of "Klas" company said that IMF proposal would cause the absurd situation in which bread price increases and prices of vehicles reduce. On the other hand, car salesmen see several advantages in a single tax rate – first the competition being 'healthier' and secondly, the cars sold as domestic product would have same taxes in both entities and in Brcko District. IMF representatives didn't want to comment on the amendments, saying that they need more time for analyses, however they stressed that the single VAT rate would be the best solution. They say that not only poor ones would benefit from the smaller tax rate on food, but also the rich ones would, and that poverty issue can be solved with adequate social programs. *"A large number of people in this country, poor people, aren't eating enough exactly due of the fact that food is burdened with taxes and even tough we don't have social programs, we should at least help the basic food products to reach users and be sold as cheap as they can,"* said **Zlatko Lagumdzija**, member of BiH HoR Commission, who proposed lower tax rates for some categories. According to the amendments, zero VAT rate would be applied to the books, food and medicine. Final decision on the issue will be brought by the BiH Parliamentary Assembly, but the influence of International Financial Institutions will be important as well.

**FTV** – RS Association of Farmers protested against decision on 8% VAT for agricultural products, claiming that this will make their more expensive and non-competitive on the market. **Beriz Belkic**, member of Commission, disagrees with this saying that VAT will improve agriculture.

**BHT 1, Oslobođenje** pg 4 'Disturbance at the BiH oil market' by M.K.S., **Dnevni Avaz** pg 12 'Hundreds of trucks cannot go to get oil in Hungary!' by E. Plecic – Distributors of oil and oil products have announced new increase of oil prices and a possible shortage of this resource to happen in next few days. The reason for this is the protocol on road-transport between BiH and Hungary, whose implementation started on Thursday and according to which the number of licences for daily road-transport through Hungary has been decreased to only 3 000 (1000 for RS and 2000 for FBiH). The distributors say that BiH needs at least 30 000 licences per year. President of FBiH Association of Oil Distributors, **Muhidin Alic** said that they will send their conclusions to Council of Ministers, BiH Ministry of Transport and Communications and to BiH Ministry of Foreign Affairs. At the end Reporter concluded that all this could have been avoided if BiH Governments were able to solve the issue of double taxation and started the production in Brod refinery.

**Dnevni Avaz** pg 3 'Is there going to be an oil shortage' op-ed by Enes Plecic – Editorial refers to the warning that protocol on road-transport will cause oil shortage in BiH, saying that such protocol should prevent dual registration of the companies in two countries thus fighting smuggling networks. However, author notes that responsibility on certain oil shortage to occur in BiH lies with the representative of the Council of Ministers, **Nikola Sego**, who signed a protocol which cut the number of trucks licenced for transport for ten times. *"Licences will become like a gold, especially for oil distributors, who purchase 12% from Hungarian company 'Mola.'.. It is clear – ten times less licences, ten times less oil. Shortages are inevitable unless the oil is to be purchased on other side – in Croatia, Serbia and Slovenia, who want BiH consumers 100%. But, at the price not regulated by the market, but monopoly,"* editorial concludes.

M.</u> – The President of RS Association of Petroleum Distributors, <b>Vukasin Vojnovic</b>, claims there will be no increase in prices of petroleum in RS despite to disturbances at the petroleum market in the Federation of BiH. He appealed to the entity Prime Ministers to find a solution for revival of production at Brod Oil Refinery in order to avoid disturbances in future.</p>
<p><b>RS Govt discusses Law on DPs and refugees</b></p>	<p><b>Glas Srpske</b> pg 3 'No more refugees' by <u>G. Dakic</u>; <b>Nezavisne Novine</b> pg 4 'A million BAM for accommodation of workers' by <u>S.G.</u> – At the session in Banja Luka on Thursday, RS Government has set the proposed Law on displaced persons in RS and refugees in BiH and forwarded it for a parliamentary procedure and urgent adoption. <b>Jasmin Samardzic</b>, RS Minister of Refugees and DP's, said that the adoption of the Law would abolish the status of a refugee, but would keep the category of displaced persons and returnees.</p>
<p><b>DL feature on military apartments in FBiH</b></p>	<p><b>Dnevni List</b>, pg 6 'Destiny of military apartments in BiH according to model from Croatia?!', by <u>Arijana Beus</u> – DL reminds of the recent announcement by the FBiH Ministry of Physical Planning that in case the BiH Constitutional Court declares the article 3a of Law on cessation of application of Law on abandoned apartments as anti-constitutional, the Ministry will be using the recent verdict of the European Human Rights Court AKA 'Blecic v Croatia' in making new provisions. The President of BiH Constitutional Court, <b>Mate Tadic</b>, told DL that the Constitutional Court would do its job according to the Constitution and independently, noting that whatever the FBiH Government and Parliament choose to decide, it is a matter for them. Tadic goes on to say that the Government and Parliament can change the law in question and the Constitutional Court has nothing to do with it until a moment someone decides to start a procedure with the Constitutional Court.</p>

<p><b>Dani: Bulldozer Committee 22 months following loudly announced action for salvation of Bosnian business</b></p>	<p><b>Dani</b> pgs 24-26 'Braking for a half of million KM' by <u>Jasna Jelusic</u> – The magazine analyses achievements of the Bulldozer Committee, which was established in October 2002 with a main goal to remove obstacles to development of business in BiH. According to the author, from outside everything related to this project valued at a half on million KM looked very good. On the other side the implementation of reforms proposed by the Committee was too slow thanks to various and narrow political parties' interests. "In April this year, then newly-appointed Head of the Emergency Reform Unit <b>Mirza Hajric</b> told PDHR <b>Donald Hays</b> it was disappointing that the internationals were still heading the Bulldozer because if the local authorities do not accept the project as something of their own, the entire job will be brought into question," wrote Jelusic.</p>

<p><b>ICTY appoints defence lawyers to Milosevic</b></p>	<p>RHB, BHT 1, FTV, RTRS, Dnevni Avaz pg 22 'Lawyers imposed to Milosevic', Vecernji List pg 19 'Court appointed defense lawyers' by H, Slobodna Dalmacija pg 9 'Milosevic: I want to keep defending myself' by H, Glas Srpske pg 11 'Key and Higgins to defend Milosevic', Nezavisne Novine pg 6 'Defence attorneys assigned to Slobodan Milosevic' by BETA, EuroBlic pg 5 'Milosevic to have a stroke or heart attack' by Blic team, Vecernje Novosti pg 17 'Attorney underhandedly' by Miroslav Zaric– Two British lawyers, Steven Kay and Gillian Higgins, have been appointed to defend former Yugoslav leader Slobodan Milosevic before the ICTY. They are "friends of the court", named at the start of the case to ensure Milosevic would get a fair trial. The tribunal had said it would impose a lawyer after medical tests showed Milosevic was not fit to represent himself. Kay and his assistant will take over the case from next Tuesday, when Milosevic's first defence witnesses are due to be called. Milosevic has protested on this decision, and announced he would appeal.</p>

Brod area**

**RTRS, Glas Srpske**, pg. 3 'Clothes are first clue' by B. T.— RS Commission for Missing Persons will search several locations in area of Brod suspected to be sites of the mass graves with bodies of the Serb victims. A number of Serbs disappeared in the area at the time when Croatian Army controlled the city. **Slavko Krulj**, Doboj County Prosecutor, says that the RS Commission is searching for a number of individuals from Srpski Brod and it has to be verified whether those persons are buried in these locations. Krulj says that the search will be finished in a few days **FTV – Aleksandar Radeta**, Head of RS Office for Missing said that no bodies have been found on supposed locations so far. The Office will continue search for possible gravesites in next few days.

**FTV** – FTV comments that the RS Office for Missing Persons used issues around the lack of full information from the Commemoration Centre in Tuzla to publish information on alleged victims of the war crimes, increasing the list of missing Serbs in the area from 22 to over 500. The Office RS has been digging for over two months in part of Trnovac – Tuzla cemetery looking for bodies. **Amor Masovic**, the President of FBiH Commission for Missing Persons says that first DNA analysis of the bodies exhumed show that they belong to Bosniaks, mostly soldiers of BiH Army whose bodies were exchanged during the war. Masovic believes that **Slobodan Skrba**, Member of RS Office for Missing Persons, provides with the false information. Masovic points to the pain of families of missing persons, adding that they don't need cases like this which first happened in Lav cemetery in Sarajevo, and later in Zenica and Tuzla. Amor Masovic: *"When they excavated from Trasnice cemetery 200-300 years old bones, who ended up there during the war from a museum or a similar institution, they published information on murder, torture, etc. All this repeated in Trnovac-Tuzla."* **Nebojsa Jovanovic**, Prosecutor from Bijeljina, said that only two bodies from the list of missing persons have been found both buried regularly.

**Dnevni Avaz** pg 4 'Politicization of Srebrenica Commission's work will not be allowed' by Fena, **Oslobodjenje** pg 3 'Politicization of the Commission's work is not acceptable' by Fena, **Glas srpske**, pg. 2 'Doors are closed for politics' not signed – OHR issued a press release which reads that OHR will not allow impetus given by the RS Government's Commission for Srebrenica to be hijacked by the local elections for short term political gain. In the light of recent speculation about the quality of the Commission's findings regarding the mass graves sites, OHR welcomes and expects the continuation of the current cooperation and contacts between the Federation Commission for the Missing Persons and the RS Government's Commission for Srebrenica. The statement further reads: *"The public should be in no doubt: the OHR and the International Community will be rigorous in their evaluation of the work of the Srebrenica Commission. This evaluation will take place after the 15 October, the deadline set for completion of the Commission's work as a whole, and after assessment of the Commission's work by the BiH Constitutional Court's Commission for Human Rights. Any attempt at a piecemeal assessment before this date undermining the Commission, as a pre-election tactic, would be completely unacceptable, is stated in the announcement of OHR."*

'There was a mass grave in Kazani' by  
Sanita Rozajac – In an interview to  
Oslobodjenje, a member of the  
Srebrenica Commission, **Gordon Bacon**,  
says that there is an indication that  
bodies were buried in Kazani, and that  
the information Commission has  
received was correct [*he commented on  
the decision of the FBiH Commission  
for Missing Persons to halt  
exhumations in Kazani after no body  
was found in several days of digging*].

Bacon also stresses that the  
Srebrenica Commission has submitted  
the information of 32 locations of  
mass graves, and three of these were  
worked by the FBiH Commission. At two  
out of three locality, bodies were  
found and Bacons says that "*it is  
obvious that bodies from Kazani were  
removed.*" He refused to reveal the  
source of the information on the mass  
grave. Just saying that it is from RS.  
He also expresses the hope that the  
commission will finish with its talks  
meeting the deadline of 15 October.

<p><b>Reactions to Brdjanin verdict</b></p>	<p><b>Dnevni Avaz</b> pg 4 'Aren't concentration camps sufficient evidence for genocide' by <u>E. Sarac</u> – Following the ICTY verdict in case of <b>Radoslav Brdjanin</b> who was sentenced to 32 years of prisons, but cleared of charge for genocide, daily brings some reactions. Bosniak officer for liaison with ICTY, <b>Amir Ahmic</b>, and an expert of the FBiH Commission for Missing Persons, <b>Jasmin Odobasic</b>, both objected the dropping the genocide charge. While Odobasic wondered aren't facts on the concentration camps in relevant region enough of the evidences for prove genocide, Ahmic says that such verdict brought ICTY credibility into the question. BiH Association of the PoWs welcomed the verdict of 32 years of imprisonment, but believes that ICTY attitude of those who carried out the genocide in BiH is to soft.</p> <p><b>Oslobodjenje</b> pg 5 'People of Prijedor wondering what is genocide?', mentioned on cover, by <u>B. **Audit report  
notes a number  
of  
irregularities  
in RS MoI; new  
appointments**

**BHT 1** – A number of irregularities were discovered in work of RS Interior Ministry, and they were presented in the report of RS Chief Auditor **Bosko Ceko**. Among other things, irregular money spending was discovered to have taken place during the last year's visit of Pope to Banja Luka. Final report will be published in the next two days, but even its preliminary findings indicted repeated breaches of the Law on Public Procurement. Ceko is still very careful about his statements, being that experts still haven't evaluated all remarks submitted by the MoI. Ceko confirmed that most irregularities are connected with breaking the Law on Public Procurement. Spokesperson of RS Prime Minister, **Goran Radivojac**, didn't either confirm or deny the relation between audit reports and the newest staff changes within the MoI. RS Prime Minister **Dragan Mikerevic**, also in the position of Acting Interior Minister, removed **Milovan Djuric**, from his position of Chief of Administration for procurement. *"When it comes to these replacements, President of RS Government... has seen some discrepancies in functioning of that system and based on that he has replaced these two persons,"* said Radivojac.

**RTRS, Glas Srpske**, pg. 2 'Audit writes dismissals' by V. Janjic, inset 'Appointments' – **Spomenka Vujasinovic** was appointed new Head of the Administration for Property Issues of RS MoI instead of Djuric.

**Nezavisne Novine**, cover 'Spomenka Vujasinovic is the new Head of the Administration for Property Issues of the Ministry of Interior' and pg. 3 'New Head of the Administration for Property was appointed' by P. Klintcov – According to a collocutor from RS Ministry of Interior, the appointment of Vujasinovic is 'a new *indicative decision*' because she was brought in connection with disputable deals between the Ministry of Interior and "new Sanatron" firm from Novi Grad.

**Glas Srpske**, pg. 2 'Audit writes dismissals' by V. Janjic – RS Police Director **Radomir Njegus** has confirmed that the dismissal of Milovan Djuric was in connection with omissions in the work of this body reported in the Audit Report. The Spokesperson of RS Prime Minister, Goran Radivojac, has confirmed that the results of the Audit Report have had an influence on the decision on dismissal, but he emphasised there were other reasons for the removal as well.

**McNair takes  
over  
Sacirbegovic's  
case**

**BHT 1** by Boris Grubestic, **Oslobodjenje** pg 6 'Case against Sacirbegovic to be taken by Corruption department' by L.S. – Prosecutor **John McNair** has confirmed that the BiH Office of the Prosecutor has decided to take over the case of **Muhamed Sacirbegovic**, former BiH Ambassador to the UN suspected of embezzlement of about \$2,5 millions.

BiH Justice Ministry expects Sacirbegovic's extradition from USA to be carried out soon. *"My Department [for organized and economic crime] will review the material and carry out necessary translation and drafting requested by the BiH Court. After that, we will want to examine the status of a request for the extradition which will be considered by the US court,"* McNair explained.

The investigation of Sacirbegovic's case has lasted since 2001. BiH Justice Ministry is in contact with their colleagues in USA and they expect the extradition. BiH Minister of Justice, **Slobodan Kovac** said that the extradition will most probably happen and he pointed that the other side would have to have serious evidences to postpone it.

**Nezavisne Novine**, cover and pg. 3 'Hundreds of false passports have been issued' by A. Sisic – In the course of the investigation against suspects in case of issuing of false CIPS IDs and Drivers Licences, BiH Prosecution has found out that a well organised group has also issued several hundreds of false BiH passports, as according to a source close to the investigation. *'We can say with great certainty that we will find several thousands of forged documents among in total 100,000 files we have to check'*, **Ahmet Halebic**, State Prosecutor in charge of the investigation, stated yesterday. According to a NN source, it is suspected that individuals from several foreign Embassies in Sarajevo were also involved in this affair. Allegedly, the individuals had issued visas for many persons, although they had known their passports were false. **Marinko Jurcevic**, the Chief State Prosecutor, has stated: *'We have come to evidence that Banja Luka was not a solitary case in issuing of false CIPS documents. The investigation was extended because this is a classic case of organised crime from which individuals have earned lots of money and made the position of BiH in Europe more difficult'*. Spokesperson of CIPS Direction **Sanela Turkovic** yesterday reiterated that no employee of the Ministry of Civil Affairs or CIPS Direction was involved in this affair.

**Dnevni Avaz** cover splash 'Zutic will be replaced', pg 4 'Resad Zutic will be removed because of Feroelektro?' by A. Hadziarapovic – DA learns from 'credible source' that since FBiH Privatization Agency has not respected the attitude of the FBiH Government and Trade Ministry in case of Feroelektro company, the Trade Minister **Maid Ljubovic** has decided to completely annul this privatization. This would bring Feroelektro at the beginning of the selling process, while responsibility will be at the Director of the FBiH Privatization Agency, **Resad Zutic**. DA further says that this will not only mean the end of months long affair, but also possible Zutic's removal.

**Glas Srpske** cover page story 'The chorale of the deaf' by S.M. – The author starts the article by saying that *"when Bosniak and Croat politicians speak up about the Serb history, everybody gets the impression that they are listening to the chorale of there deaf"* referring to the most recent statements and reactions upon weekend ceremony held in Dobrun to mark the 200 anniversary of the First Serb Uprising. **Haris Silajdzic**, the founder of Party for BiH, said that the celebration of 200 years of Serb Uprising *"has nothing to do with BiH, but instead with Serbia. BiH citizens should look for a future in the united Europe, instead in myths."* Glas notes **Silajdzic** is wrong because Serb Upraising The First was not the myth but a historical fact. **Safet Halilovic**, Vice President of SBiH said that *"BiH is not a mono-national state and sometimes promotion of some historic events and persons belonging to one people could automatically negate the interest and identity of another people."* President of the Prijedor Association of the refugees and DP's, **Ranko Lale**, responded to this Halilovic's statement by responding *"has Halilovic thought of this"* when a mosque in Sanski most was named after a Turkish conqueror. Glas further notes that **Sulejman Tihic** has also joined this "chorale of the deaf".

street names  
in Mostar**

**Slobodna Dalmacija**, pg 18 'Chetnik dukes and Bosniak Ustashes have their streets too', mentioned on front, by Zlatko Tulic – With regard to the issue of name of Mile Budaka Street in Mostar (senior Ustasha official during the WWII), which triggered reactions in the press and by associations who request the name of the street to be erased, SD argues that in the same time, nobody is interested in two monuments to the Chetnik leader during the WWII, **Draza Mihajlovic**, and names of streets in towns in the RS, which carry names of Chetnik leaders. SD also notes that a street in Tuzla still carries a name of a Bosniak Ustasha officer, major **Mehmedalija Hadziefendic**, and that several streets in Sarajevo have disputable names, such as Crnih Labudova Street (Black Swans, which allegedly committed crimes during the 1992-1995 war in BiH) and Mladih Muslimana Street (Young Muslims Street).

**Dnevni Avaz** pg 9 'Mile Budaka street will be renamed after the elections' by F. Vele – The chair of the Mostar Confidence Building Commission, **Zoran Pajic**, says that he is certain that the Commission will soon adopt recommendations for the city authorities to change the name of Mile Budaka street, as well as other disputable names of squares, streets and public institutions. *"Confidence among peoples cannot be build with the names of streets such as Mile Budak street,"* Pajic says adding that this issue will be address after the elections through institutions, rather than allowing its politicisation.
