Lozancic on Prce's  
pardon

FBiH President **Niko Lozancic** stated on Friday that his decision on granting pardon to **Miroslav Prce**, former FBiH Defence Minister, is legally and constitutionally grounded. He added that this decision was an act of mercy and it has nothing to do with Prce's political, national or any other orientation.

Lozancic underlines that he issued several decisions on granting pardon in the past period, only the one in relation to Prce attracted attention of public and many *"defendants of moral, legal and all other principles, often promoted without arguments"*. He also mentioned Head of the Office for Corruption and Organized Crime within BiH Prosecution, **John McNair**, as the one who reached bargain with Prce on 5 instead of 15 years in prison, however, according to Lozancic none paid attention to that. In relation to the OHR and the High Representative **Paddy Ashdown**, Lozancic says that Ashdown cannot stand easily when someone has a different opinion from his own. *"I know that they are conceited and vengeful, and I know that I can expect a new campaign against my next possible decisions on any issue..."* said Lozancic. He added: *"I claim that the medical reports, on the ground of which I have decided to pardon Prce, are absolutely valid... I have to say that after the 'mess' which has been caused, I am sorry for not having Prce's sentence more radically reduced."*

<p>OHR on Lozancic's stand on Prce's pardon</p>	<p><b>FTV</b> – The <b>OHR</b> commented that <b>Niko Lozancic</b> has a right on his own opinion and that the fact is that existing law allows granting of pardon without any explanations. Still, 48 out of 225 requests for pardon were approved this year in the RS, while 94 requests were approved in the FBiH out of 298, which were filed. The OHR pointed out that this is not about granting pardon to Prce, but it is about the system that allows making of such decisions without control and which has to be reviewed.</p>

I do not participate in the procedure of decision-making on resignations, however, the Ministers are being appointed at the Prime Minister's proposal and I have not been involved in this process in any way yet.'</p>

The Collegiums also adjourned the session and decided to inform the BiH Electoral Commission and international organizations of the incident.</p>

Boskovic</u> – BiH should get a final Law on Public Broadcasting System (PBS) by mid September, when the BiH House of Peoples (HoP) should vote on it. According to the leading political parties, the Law will be adopted at the session on September 15<sup>th</sup> along with over-voting HDZ delegates. <i>“Knowing the Constitutional Court judgment, it is realistic to expect that we will adopt the Law in mid September, which is good. BiH needs this Law.”</i><b>Tomislav Limov</b>, President of PBS legal constitution Commission, stated. <i>“You know that Constitutional Court had made decisions that failed in Strasbourg. We will use this instance and then we will see what happens”</i> <b>Anto Spajic</b>, HDZ delegate in BiH HoP stated. The FBiH Government must discuss the BiH Telecom’s request for cancelling theContract on collection of RTV tax through phone bills.<i>“I think that RTV tax payment through BH Telecom bills is not the best solution. If we privatize Telecom operators, will it survive?,”</i> <b>Nedžad Brankovic</b>, FBiH Minister of Traffic and Communication stated. BiH Council of Ministers excludes possibility of the contract cancelling. The Law on PBS clearly defines that in next 5 years operators of Telecom are collecting RTV tax. <i>“If implementation of the law starts, this will be an additional obligation to the Telecoms. I expect that they will increase provision on tax payment.”</i> <b>Branko Dokic</b>, BiH Minister of Communications and Transport stated.</p>
