<p>Cavic meets Kostunica, Tadic: 'Kosovo and RS are internal issues of Serbia and BiH'; Cavic supports Kostunica's report to UN SC on Kosovo</p>	<p><b>BHT1, PINK, Hayat, Oslobođenje</b> pg 2 'Respect international agreements and resolutions', <b>Dnevni List</b> pg 3 'To respect international agreements fully' by <b>NINA, Nezavisne Novine</b>, pg 2 'Arrests of The Hague fugitives to follow', by <b>N. R.</b>, <b>Glas Srpske</b> pg 3 'Hague to be removed from the agenda' by <b>Srna</b> inset 'No imposing' – RS President <b>Dragan Cavic</b> visited Belgrade on Thursday holding separate meetings with the Serbian President and Prime Minister, <b>Boris Tadic</b> and <b>Vojislav Kostunica</b> respectively. They discussed on the ICTY war indictees, issue of Kosovo, political negotiations with the EU, BiH Constitution, etc. In terms of Kosovo, Cavic told press conference that they agreed that its issues and BiH Constitution were separate issues with a common link of being founded on international acts and documents, presenting interior issues of the respective states. <b>BK TV, RTS</b> [Serbian TVs] – Cavic has fully supported the principles on Kosovo issue to be presented by Kostunica at UN Security Council session, emphasizing they are related to the fundamental principles of the international law, above all the principle of sovereignty and territorial integrity of the countries in the region. <b>Dnevni Avaz</b> pg 9 'Kosovo and RS are internal issues of Serbia and BiH', mentioned on cover, <u>not signed</u> – RS President added he told Tadic and Kostunica that there is nobody in the RS ready to support any constitutional initiative that would change the BiH constitutional structure and making of some new order without the RS. <i>"I told them that there is a readiness in RS to talk about improvements of the constitutional solutions on base of the consensus so BiH is capable of taking the responsibility in the integration processes. That must happen in the sensitive balance with the entities' authorities and RS position,"</i> Cavic. The meeting with Kostunica was also attended by the RS MoI <b>Darko Matijasevic</b>. <b>RTRS, FTV</b> – Officials stated that remaining ICTY indictees <b>Radovan Karadzic, Ratko Mladic</b> and <b>Stojan Zupljanin</b> must be extradited to the Hague as soon as possible. Cavic added that the operational activities are underway to find and apprehend the PIFWCs still at large. <i>"But, the [RS Ministry of Interior] is not a ministry of information to [publicly] talks about its activities,"</i> added Cavic.</p>

<p>Hayat: Terzic also departed for Belgrade?</p>	<p><b>Hayat</b> by <b>Nebojsa Radulovic</b> – In a statement to Hayat, the Chair of the BiH Council of Ministers <b>Adnan Terzic</b> comments the RS President <b>Dragan Cavic</b>'s visit to Belgrade, saying he did not know whether the visit had anything to do with negotiations BiH was to launch with the EU. <i>"I have to admit that I regret the fact that <b>Igor Davidovic</b> rejected the nomination for Chief BiH Negotiator in Stabilization and Association Agreement talks"</i>, said Terzic added. According to NTV Hayat sources, Terzic has also departed for Belgrade on Thursday evening.</p>

Popovic</b> – Spokesperson of OHR Banja Luka <b>Ljiljana Radetic</b> on Thursday stated that HR Ashdown would, by the end of his mandate, deal with the possibility of rehabilitating removed politicians in BiH. Radetic refused to give more details. <b>FTV</b> – OHR Spokesperson <b>Mario Brkic</b> said the OHR is to reassess whether removed persons or actions they conducted presented a threat to the DPA and BiH's stability.</p>
<p>SDS claims 12 removed officials would be rehabilitated</p>	<p><b>Nezavisne Novine</b> pg 3, announced on cover 'SDS claims 12 removed persons will be rehabilitated' by <b>V. Popovic</b> – Sources close to SDS claim HR <b>Paddy Ashdown</b> is expected to rehabilitate 12 officials that were removed in accordance with the decision taken on June 30 last year. The source claims HR should present the decision on rehabilitation before November 10, in order to strengthen the position of SDS President <b>Dragan Cavic</b>. SNSD stated that the announcement on possible rehabilitation of SDS officials was a reward to Dragan Cavic for his cooperation in implementation of reforms. SPRS's <b>Petar Djokic</b> shares a similar view, while SDS and PDP welcomed the announcement of HR on rehabilitation.</p>

<p>Politicians' comments on forthcoming talks on constitutional changes: Serious phase beings</p>	<p><b>EuroBlic</b> pg RS2 'Serious phase begins' by <u>Nedeljka Breberina and Rajna Radosavljevic</u></p> <p>– According to anonymous source, leaders of BiH political parties should commence talks on constitutional changes in Brussels on November 11. PDP's <b>Slobodan Nagradic</b> expects the situation would be much clearer after the meeting in Brussels, as well as that it would result in amendments that would be forwarded to the parliamentary procedure. Party for BiH's <b>Beriz Belkic</b> reiterated that majority of participants believe the Presidency of three members should be kept while only the procedure of election of the members should be changed. SDA's <b>Mirsad Ceman</b> confirmed that a consensus on establishment of a body in charge of agriculture on the state level was reached, while the participants believe culture, education and healthcare should remain under the authority of entities and cantons. SDP's <b>Jozo Krizanovic</b> says many options are still open because the negotiators in the past had no mandate to reach any decisions. SDS's <b>Mladen Bosic</b> claims a serious discussion on constitutional changes is yet to follow because a group that had no authority to reach an agreement on anything participated in past talks. Inset 'No amendments' – HDZ's <b>Mile Lasic</b> claims there are no draft amendments to the existing BiH Constitution, but '<i>a certain progress was made</i>'. He thinks amendments might be adopted in March in order to enable introducing changes to BiH Election Law. <b>Nezavisne Novine</b> pg 5 'Talks on abolishment of cantons' by <u>M. Cubro</u> – also carries the announcement on the meeting, and carries statements of SDA's Ceman and SDS's Bosic.</p>

<p>BN TV int with Mladen Botic on Washington talks/const. changes: VL op-ed: Croats should have their political and territorial exclusiveness</p>	<p><b>BN TV</b> 'Puls' current affairs programme by <u>Suzana Radjen-Todorovic</u> – In an interview to BN TV, SDS Vice President, <b>Mladen Botic</b>, commented on the talks on constitutional changes focusing at those held in Washington under auspices of the US Institute for Peace. After a large number of parties accepted the offer, Botic said SD did so too under strong assurances from the former PDHR <b>Donald Hays</b> first there would be no pressure and nothing would be decided on without a consensus. Botic notes that Dayton Constitution is already significantly changed, for example the BiH CoM. He explains the talks focused at ways to increase administrative functionality, however the sensitive issues, such as BiH structures, two entities, asymmetric FBiH, weren't discussed. <i>"When we put things on the table, it appeared that we can talk about some things, but it is a question how important those things are and how much this can satisfy ambitions of those who would like to see constitutional changes,"</i> he said. Commenting the proposals presented, Botic said: <i>"Story about consensus in making constitutional changes excludes 80% of issues that different political subject would like to change."</i> He added that, at the end, talks were brought down to the structure of Presidency, Parliament and CoM. He referred to analyse that Venice Commission published in April this year saying it clearly said RS doesn't need to be changed or abolished. <i>"Conclusion of the Venice Commission is that, actually, functional organisation has to be created in FBiH, because large number of ministries exists in FBiH, which has a very complicated structure, comparing to simple structure in RS,"</i> said Botic. According to Botic's observation conclusions, it will be difficult for FBiH to reach agreement on this, expressing a surprise that everyone is running away from this issue. Regarding CoM, Botic also mentioned that there is initiative on transforming BiH CoM into BiH Government which has not received the support by three RS parties at these talks (SDS, SNSD, PDP). <i>"For us, the problem would be authorities that evolve from such transformation,"</i> he said. However, he does stressed that the state Agriculture Ministry would be an issue now that BiH is to open talks on SAA. SDS agrees that the CoM needs to be extended and to include the Ministry of European Integrations. Another meeting is scheduled to take place in November 11 in Brussels.</p>

VL op-ed: Croats should have their political and territorial exclusiveness	<b>Vecernji List</b> pg 2 'Equality or sidelining' by <u>M. Bosnjak</u> says that the time has come to talk about constitutional changes in BiH freely and openly. The author added that peoples should be allowed to agree about principles of equality. He added: <i>'It should be made possible for Croats to have their political and territorial exclusiveness from which they can act...Everything else would be a fear of sidelining that has been present in almost all BiH institutions at the moment.'</i>
Feral op-ed commenting on constitutional changes proposals	<b>Feral</b> pgs 21-22 'How Constitution was hardened?' by <u>I. Lovrenovic</u> carries the author's commentary on various proposals on constitutional changes and with regard to the BiH Bishops' Conference proposal the author says that, unlike before, viewing of the whole BiH perspective prevails in this document as well as the BiH re-organization that would bring a better position to Croats in a way that the better positions would be provided to all others and the society in general. The author also says that comparing this stand with the ideas coming from the scientific gathering of Croat intellectuals held in Neum (on the same issue) this Neum gathering seemed miserable and old-fashioned. According to the author, it was obvious that intellectuals gathered in order to help <b>Dragan Covic</b> and <b>Ivo Miro Jovic's</b> HDZ.
SDS to submit name of candidate for RS Education Minister by end of week	<b>BHT 1</b> by <u>Boris Gagic</u> – SDS announced that it would deliver the proposal for the new RS Minister of Education to RS Prime Minister <b>Pero Bukeylovic</b> by the end of the week. High Representative in BiH <b>Paddy Ashdown</b> removed <b>Milovan Pecelj</b> from this position on Monday; according to BHT reporter, the most possible candidates for his successor are the rector of the Banja Luka University <b>Dragoljub Mirjanic</b> , and the dean of the Faculty of Science and Mathematics <b>Rajko Gnjata</b> . RS Government announced that the new minister of Education would be appointed very soon.
OHR approved B. Golub to position of CBC Education Minister	<b>Vecernji List</b> pg 4 'OHR approved Golub's appointment for position of Minister' by <u>kj</u> – The OHR has given its consent for appointment of <b>Branko Golub</b> to the position of a new Education Minister in the Central Bosnia Canton. VL says that the Central Bosnia Canton Assembly should also approve this appointment.

<p>Ljubic: Around 800 members signed Ljubic's promemoria</p>	<p><b>Oslobodjenje</b>, pg 6, mentioned on front 'Around 800 members signed Ljubic's promemoria', by <u>A. Omeragic</u> – According to the daily, it would appear that the number of dissatisfied members of the HDZ is on the rise given that the 'Promemoria', a document requesting new inter-party elections, has been so far signed by almost 800 members of the party. This information has been confirmed by <b>Bozo Ljubic</b>. <b>Oslobodjenje</b>, however, finds out that Ljubic is yet to collect 70 signatures of members of the HDZ Main Board that are required for organization of new inter-party elections. Allegedly, the 'Promemoria' has also been signed by former HDZ leader <b>Bozo Rajic</b>.</p>
<p>BHT1 in with Schwarz-Schilling: I would be more of advisor to BiH, but when needed I would use all powers given to HR</p>	<p><b>BHT 1</b> by Amir Zukic – In interview to BHT1, <b>Christian Swartz-Schilling</b> talked about his nomination for the new HR to BiH [without wanting to comment his election to the position]. Schilling reiterated that his extensive experience in BiH resulted with a trust between him and citizens. He assessed the criticism on his mediation in BiH as democratic adding that all allegations must be supported by evidence. Schilling refused to consider HR to BIH as a monarchic since many issues have been handed over to BiH Institutions. He stated that if elected he would decrease the powers of HR leaving state management to national institutions. <i>"I would be more like a friend or advisor to BIH, but if someone obstructs the implementation of reforms, violates the DPA or organises corruption than I will use all powers given to HR"</i> said Schilling. <i>"These people suffered a lot due to political disagreement but if elected, I would serve to these people and I pray BIH citizens to trust me"</i> concluded Schilling.</p>



<p>Tokic on forthcoming session of 'Igman Initiative'</p>	<p><b>Dnevni Avaz</b>, pg 5 'We will talk to Mesic and Marovic about future relations of three states', by <u>Z. Persic</u> – According to the President of SDU, <b>Sejfudin Tokic</b>, the main topic of the 11<sup>th</sup> session of the 'Igman Initiative' that is scheduled to meet in Sarajevo on November 6 and 7, will be relations between BiH, Croatia and SCG ten years after the Dayton Peace Accord. Tokic notes that the conference is aimed at the states reaching an agreement on future cooperation among them i.e. that all countries be responsible for their acts and that there is no interference into other country's affairs. Tokic also notes that the conference will not be analyzing the DPA, nor will discuss the BiH Constitution, since it is an internal matter of BiH.</p>

## Appointment of BiH chief negotiator for SAA talks

<p>Cavic re-invites SNSD to nominate SAA chief negotiator; SNSD refuses adding it will not support Cenik/Lajsic; RS political parties meet on Monday</p>	<p><b>Glas Srpske</b> pg 2 'Offer still open', <b>EuroBlic</b> RSpG 1 'Bad start to be followed by worse beginning', announced on cover 'Nobody wants to negotiate with EU' by <u>Nedeljka Breberina</u> – After <b>Igor Davidovic</b> withdrew his candidacy for the chief BiH negotiator, RS President <b>Dragan Cavic</b> stated in Belgrade on Thursday he is still waiting for SNSD to propose chief negotiator with EU, stressing: <i>"The offer to SNSD is still open. I will support their candidate and propose him to BiH CoM. Otherwise, I will take responsibility and make decision."</i> <b>BHT 1</b> by <u>Zoran Sarenac</u> – Cavic and leaders of RS political parties will meet again next Monday, and it is expected that the name of chief BiH negotiator will be announced after this meeting. Meanwhile, SNSD refused to nominate new candidate for this position. <i>"We expect that SDS would nominate some of their candidates, probably (RS Minister of Finance) <b>Svetlana Cenik</b> or <b>Djordje Lajsic</b>... If that happens, SNSD would not support them"</i>, stated SNSD Vice-president <b>Krstan Simic</b>. <b>RTRS</b> by <u>Nada Arlov</u> – Cavic still feels that Igor Davidovic is one of candidates, adding that he would insist on the consensus to be reached between 6 main RS political parties on the appointment. <b>FTV</b> – FTV comments that instead of working on BiH strategy for the SAA talks with EU, BiH politicians are arguing about the name of chief BiH negotiator as if it is the biggest problem BiH has. <b>Hayat</b> also carries Ivanic. <b>Dnevni Avaz</b>, pg 9 'Davidovic gives up candidacy', by <u>Fena</u>, <b>Dnevni List</b> pg 2 'Davidovic gave up candidacy' <u>not signed</u>, <b>Vecernji List</b> pg 3 'Davidovic refused candidacy' by <u>bs</u> – Davidovic withdraws candidacy.</p>

<p>Ivanic, Lagumdzija agree first platform to be set, than chief negotiator appointed</p>	<p><b>BHT 1</b> – BiH Minister of Foreign Affairs and PDP leader <b>Mladen Ivanic</b> thinks that this whole process of appointing the chief BiH negotiator turned into real political farce; SDP leader <b>Zlatko Lagumdzija</b> blamed BiH Presidency and Council of Ministers members for such complicated situation, especially <b>Adnan Terzic</b>, Cavic, Ivanic, <b>Sulejman Tihic</b> and <b>Ivo Miro Jovic</b>. Both Ivanic and Lagumdzija claim that BiH's negotiating position should be defined first, and than it would be easy to appoint the chief BiH negotiator. <b>Hayat, RTRS, Glas Srpske</b> pg 2 'It turned into a farce'carry Ivanic.</p>

<p>Simic: SNSD most likely will not participate talks on SAA chief negotiator anymore; Pavic, Mihajlica process in wrong direction</p>	<p><b>EuroBlic</b> RSpG 1 'Bad start to be followed by worse beginning', announced on cover 'Nobody wants to negotiate with EU' by <u>Nedeljka Breberina</u> – <b>Krstan Simic</b> is of the view SNSD will most likely not take part in talks on chief negotiator any longer, noting it would wait for nomination and than accept it or reject it. <b>Petar Djokic</b>, SP RS President, is of the view that <i>"party consultations have no sense any longer and that issue about nomination of chief negotiator should be taken over by institutions where ruling parties make majority"</i>. <b>Marko Pavic</b>, DNS President, also said Davidovic' decision could have been expected, noting: <i>"When we saw draft decision that EU negotiating team head should be above chief negotiator, it was then clear to us it is another pre-determined farce of <b>Adnan Terzic</b> and Dragan Cavic. RS President probably knows name of negotiator, while everything else is useless farce and auction with names."</i> <b>Milanko Mihajlica</b>, Presidnet o SRS, also shares the view the entire process headed the wrong direction: auction with names and undetermined priorities in the entire process. <b>Mladen Bosic</b>, SDS Vice President, expressed regret Davidovic rejected nomination, noting RS President should select person with professional and expertise qualities for the position. He also alleges <i>"it was agreed within SDS not to nominate anybody for chief negotiator in order not to contribute to political and party competition."</i> According to inset 'Negotiator or ikebana', <b>Veselin Poljasevic</b>, Head of PDP Caucus, stated <i>"Davidovic' rejection of candidature is a logical follow-up of something, that started in wrong direction, since PDP has been warning from the beginning the platform should have been first set and then personnel solution should have been reached."</i> <b>RTRS</b> carries Mihajlica. <b>BN TV</b> 'Puls' current affairs programme carries Bosic commenting the current process of forming the team: <i>"Personally, at the moment I think it does not go well."</i></p>

<p>Novakovic ( SDS): Cenic would be good negotiator; Daily: her only burden war-time association w/ Nikola Koljevic</p>	<p><b>Oslobodjenje</b>, pg 7, mentioned on front ‘Igor Davidovic withdraws candidacy for negotiator’, by <u>A. Omeragic</u> – Following the news that <b>Igor Davidovic</b> has withdrawn his candidacy to become BiH’s chief negotiator with the EU, Vice President of SDS, <b>Momcilo Novakovic</b>, assesses that the withdrawal could cause problems to the process of selection of the negotiator and preparations for negotiations with the EU. He also notes that the RS President, <b>Dragan Cavic</b>, should be talking to Davidovic one more time to see whether it is his final position. Furthermore, Novakovic says the SDS Presidency has put <b>Svetlana Cenic</b> in the first position, Davidovic in second and <b>Djordje Lajsic</b> in the third position among the candidates. He then goes on to say that if other (parties) are not ready to support Cenic, the SDS were ready to support Davidovic, adding that all the candidates are ‘equally serious’ to the SDS <i>“however, everything depends on whom the all the parties accept, not only in the RS, but in the FBiH too”</i>. SDS also believes that Cenic, a Cambridge post-graduate, would be a good negotiator working to the interest of BiH, however Oslobodjenje comments that she carries a burden of being a war-time associate to former RS Vice President, <b>Nikola Koljevic</b>, and that she has been recently labeled by the IC as an obstructionist of reforms.</p>

<p>NN: Cenik the most serious candidate for chief negotiator, comments on Davidovic's rejection of nomination</p>	<p><b>Nezavisne Novine</b> pg 5 'Davidovic gave up, Cenik has biggest chances', announced on cover 'Cenik has biggest chances' by <u>V.Popovic</u> – Daily learns from its sources that following rejection of candidature for chief negotiator of <b>Igor Davidovic, Svetlana Cenik</b>, RS Finance Minister, is the most serious candidate for the position. Source claims that at this moment, Cenik has the strongest biography and is the only one, who could meet criteria to assume this position. Cenik Thursday told daily she greatly appreciates Davidovic, expressing regret aftermath of nomination process results in seeing candidates look strange at each other, noting: <i>"Unfortunately, problem is created around every single position here, even when it is not necessary."</i> She said she would give her view on nomination after she holds talks with RS President and RS Premier. <b>Djordje Lajsic</b>, former RS Minister of economy, expressed readiness to accept nomination if party leaders reach consensus on the issue. <b>Igor Radojicic</b>, SNSD senior official claims that <i>"Cavic's calculation with names of candidate has resulted in seeing Davidovic give up on candidature"</i>, adding Cavic has created a confusing situation. <b>RTRS, PINK, Glas Srpske</b> pg 2 'Ugly calculations' – also carry Cenik's statement.</p>

**FTV** by Blazica Kristo – The RS Police has discovered the explosive-activating devices – more than 5,500 different kinds of detonators – stolen nine days ago from “Milos Obilic” barracks in Pale. Police officers were not able to give any details about the perpetrators of this crime.

Police also discovered the stolen explosive devices in the family house of **R.P.** in Vlasenica Municipality; those explosive devices have been stolen from the barracks in Bijeljina. Although it is not clear what was the motive for those crimes, police assumes that those explosive-activating devices were intended for use in some other countries. **PINK** – In a statement for Infotop, Commander to Police Station Pale **Predrag Krsmanovic** said that several persons were arrested, but that he could not disclose their names. **Hayat, BHT1, Dnevni List** pg 4 ‘Explosive returned, thieves on the run’, mentioned on cover ‘Police found explosive stolen from military barracks Milos Obilic’ by D.P. It has been expected that in this way the care would be taken of 800 families of killed HVO members while HVO invalids can get a right on the Croatian assistance in 2007 or 2008 when they pass the procedure for determining the level of their disability according to the Croatian regulations. It has been expected that BiH and Croatia would sign the contract on this issue by the end of the year. <b>HTV, NOVA TV</b> [Croatian TVs]– Kosor stated that at the beginning of next year a law regulating the rights of war veterans and their families would go into force in FBiH, which will considerably restrict the rights of the families of HVO soldiers who were killed, imprisoned or went missing during the war, as well as of disabled war veterans. She went on to say that the agreement would make it possible to cover part of disability and family pension allowances which under the new law would not be paid by the FBiH.</p>
