**Carla del Ponte  
in Sarajevo :  
More recordings  
of Srebrenica  
crimes to be  
released**

**NTV Hayat** – The Chief ICTY Prosecutor, **Carla del Ponte**, came in visit to Sarajevo. She met with the High Representative, **Paddy Ashdown**, EUFOR Commander **David Leakey**, RS Minister of Interior, **Darko Matijasevic**, and mothers of Srebrenica and Zepa. All the meetings were held behind the closed door, and there are no details about them. Del Ponte said that shocking video on execution of 6 men from Srebrenica proved that **Radovan Karadzic** and **Ratko Mladic** should be arrested as soon as possible, since only in that way, tribute could be paid to victims and commemoration could be held as well. *“I am tasked by the UN Security Council to bring Karadzic and Mladic to the ICTY, and if this is not to happen by July 11, I will not attend the commemoration nor will I be able to pay the tribute to the victims”*, said del Ponte. Del Ponte added that the ICTY possessed similar videos and that they were going to be presented at Slobodan Milosevic’s trial in future. On being asked whether she was going to disclose names of NATO members, responsible for Karadzic and Mladic being still free, if they were not to be arrested by July 11, del Ponte said *“Yes, I am staying on that and I can confirm that if they are not to be arrested by the end of the year, I am going to reveal the information”*, said del Ponte.

**FTV** – Del Ponte added that the (Orthodox) Church protects Karadzic, but Mladic should be arrested this summer, according to promises from Belgrade. Meeting with the HR Ashdown, and RS Minister of Interior Matijasevic was also held behind closed doors, while the scheduled press conference was cancelled. OHR spokesman, **Oleg Milisic**, told journalists that the press conference was cancelled because del Ponte arrived earlier than it was planned, so the meeting was finished earlier as well and she departed from the OHR building. Del Ponte denied to journalists that one of the subjects of this meeting was possible removal of Matijasevic and said that subject of discussion were Karadzic and Mladic arrests.

**BHT** – *“She has only got a promise from Serbian President, **Boris Tadic** that Mladic is in Serbia now and that he will be extradited this summer. But she is not sure where Karadzic is now”*, said **Sabra Kolenovic**, Member of Association “Mothers of Srebrenica and Zepa”. Del Ponte also met with the High Representative, **Paddy Ashdown** and RS Minister of Interior, **Darko Matijasevic** but the details of their talks are unknown, said BHT reporter. In an ironic tone, Omeragic notes: <i>"It is interesting that she did not meet with representatives of authorities, and the meeting with <b>Ashdown</b> was so brief that there were no press statements as planned before. <p><b>Update to 'Skorpioni' committing crimes against people of Srebrenica</b></p>	<p><b>Pink</b> – Office for fighting organized crime within Serbian Ministry of Interior informed that former “Skorpioni” members <b>Slobodan Medic</b>, <b>Pero Petrasevic</b>, <b>Aleksandar Medic</b> and <b>Aleksandar Vukov</b> had been arrested. Police has conducted research for their accomplices, <b>Milorad Momic</b>, <b>Slobodan Davidovic</b> and <b>Branislav Medic</b>. They are all being charged with war crimes against civilians. Namely they executed 6 persons, most probably Muslims, from Srebrenica. Out of these 6, 4 were minors.</p> <p><b>BHT</b> – The Prosecution at the Special Chamber for War Crimes in Belgrade has started procedure against 7 out of 10 persons, who were identified from the video-tape recording of execution of 6 Bosniaks from Srebrenica. Three of those persons are still at large. Serbian public has been shocked, after seeing the recording of executions committed by members of “Skorpion” unit. Executed Bosniaks from the videotape have been identified; four juveniles and two men, age under 30. They were tortured before they were executed, confirms Belgrade Prosecution. <i>“None of politicians have said that they admitted responsibility for Srebrenica and that they admit Serbia was hiding documents and facts regarding Serbian involvement in crimes committed in Srebrenica”</i>, stated <b>Natasa Kondic</b>, Director of SCG Humanitarian Rights Fund. She added that the official Serbia announced arrests of the persons who committed these crimes but nobody has taken responsibility for the crimes that the former authorities committed. Media in Belgrade are investigating who is the priest on the tape, who was blessing the persons who committed executions of Bosniaks. Serbian Orthodox church didn’t comment on recording yet.</p> <p><b>Hayat</b> – B 92, TV station, has broadcast video, which shows <b>Slobodan Medic</b>, “Skorpioni” Commander and <b>Milorad Ulemek Legija</b>, member of Serb voluntary guard, who was at that time member of <b>Fikret Abdic’s</b> forces. The event took place in Krajina, several months before Srebrenica genocide took place. Medic ordered civilians from a village to be executed.</p> <p><b>FTV</b> – <i>“Those images are proof of a monstrous crime committed during the war in that area. This crime is committed in the name of our nationality,”</i> said Serbian President, <b>Boris Tadic</b>, and added that he expects all State and national institutions to make clear their views on this recording, adding that they have already known that this has happened based on the report of the RS Government’s Srebrenica Commission. Apart from confirming the news on the arrests, the spokeswoman for the (Serbian) Prosecution for war crimes, <b>Jasna Jankovic</b>, noted that the recording showed <i>“a crime that happened a kilometer away from a village called Trnovo, nearby the Jahorina ski-centre”</i>.</p>

EUFOR and NATO announcement states that Leakey and Schook made such decision because they feel that general Djukic is responsible for events that occurred in Bileca and Manjaca when RS Army recruits refused to plea allegiance to BiH.</p> <p><b>Pink</b> – EUFOR and NATO find Djukic responsible for failure in planning and commanding. <i>"I have informed General Djukic on the removal, and in my opinion, Djukic was extremely professional in his reaction on the removal and he accepted the decision we have brought"</i>, said Schook. <i>"In line with my authorities, I have added two more measures. First, all training of recruits has been suspended and Manjaca recruits are going to be dismissed by Wednesday"</i>, said Leakey. Schook and Leakey pointed out that full defence reform had to be carried out, namely entities' Ministries of Defence have to be abolished.</p> <p><b>Hayat</b> – <i>"These measures are serious measures, removal of General Djukic, the recruits have been sent home, training has been abolished"</i>, said EUFOR Commander, <b>David Leakey</b>. In next period, obligatory military service is to be abolished, as the result of defence reform.</p> <p><b>FTV</b> – General Leakey also said that the role of the veterans' association at the events in Manjaca was particularly inflammatory and offensive to Dayton Peace Agreement, so it is ordered that war veterans' representatives should not participate in an active speaking role at official military ceremonies until the rulebook on such ceremonies is revised and rewritten at the state level.</p> <p><b>NTV Hayat</b> – EU High Foreign Policy and Security Representative, <b>Javier Solana</b> supports such decision, while the High Representative, <b>Paddy Ashdown</b>, said that EUFOR reacted since BiH Presidency's reaction was inadequate. **Terzic  
accepts  
Dokic's  
resignation**

**BHT** – BiH Council of Ministers Chair, **Adnan Terzic** accepted on Friday a resignation of BiH Minister of Traffic and Communications, **Branko Dokic**. Party of Democratic Progress (PDP) will nominate a new minister. It is speculated that the former RS Prime Minister, **Dragan Mikerevic**, is going to be a new Minister of Traffic and Communications, says the presenter. Dokic submitted his resignation due to court proceeding, which is being conducted against him before Basic Court in Banja Luka. He is accused of damaging of RS budget in amount of several hundreds of thousands KM while he was RS Minister of Traffic and Communication. *"I am obligated to accept that resignation but I must admit I am sorry that minister Dokic goes, but it is clear that he cannot stay in BiH CoM "*, said Terzic.

**Pink** – Dokic finds the lawsuit unfounded, first of all due to the fact that it has been filed on the basis of anonymous report. Dokic claims that the whole campaign against him has started due to the fact that he banned import of second-hand mobile phones, in 2000. **FTV** – Several members of the HDZ Presidency left the party's session on Thursday evening, due to dissatisfaction with decision on the way of voting for the party's President at the coming Convention on Saturday. Namely, election on the basis of majority of votes (relative majority) goes in favour of one of the candidates, namely **Dragan Covic**. Previously, a candidate had to win more than 50% of the votes in order to be elected. Also, Covic got support of 12 HDZ Presidency members, out of 23. *"Those who wanted to vote on support to Covic, they did that. There was certain number of members who left the session and those who didn't want to vote,"* said current HDZ President, **Barisa Colak**. Nevertheless, HDZ Assembly doesn't have to confirm Presidency's decision on the way of electing the President. Besides Covic, candidates are **Barisa Colak**, **Bozo Ljubic** and **Ivan Madunic**. (announcement of HDZ Convention and session of HDZ Presidency is also covered by **RHB**, **FTV**, **Hayat**, **RTRS**, **Oslobodjenje**, pg 5 'Covic is party's presidential candidate', by V. BiH Minister of Civil Affairs, <b>Safet Halilovic</b>, sees as justified Terzic’s call to the HR to appoint SIPA Director.</p>
<p><b>Ivanic on SIPA Director appointment</b></p>	<p><b>Oslobodjenje</b>, pg 7 ‘I have nothing against Lukac’, by <u>V. Z.</u> – The BiH Foreign Minister, <b>Mladen Ivanic</b>, stated for Oslobodjenje that he “<i>personally has nothing against Dragan Lukac</i> (becoming) <i>the SIPA Director</i>”, arguing that the issue is whether the professional or political criteria is to be used when appointing people to key positions. Ivanic notes that political parties that make up parliamentary majority should sit down and solve the issue. Regarding announcements that the <b>High Representative</b> will appoint the Director if BiH CoM fails to do so, Oslobodjenje carries an OHR spokesman, <b>Oleg Milisic</b> , as saying that the HR never announces his decisions in advance.</p>
<p><b>Avaz op-ed: RS leaders blocking BiH</b></p>	<p><b>Dnevni Avaz</b>, pg 3 ‘Why is state blocked’, by <u>Lana Sinanovic</u> – Commenting on the removal of <b>Novak Djukic</b> and <b>Adnan Terzic’s</b> announcement that he would call on the <b>High Representative</b> to appoint the SIPA Director, the author argues that these examples illustrate the blockade the state is in. The author points the finger at the RS leaders, claiming that they have not accepted the fact that the entity they are leading is not a state and that the RS cannot be a permanent obstacle to the future of BiH.</p>

<p><b>Andan to respond to HR Ashdown's request</b></p>	<p><b>BHT</b> – RS Police Director, <b>Dragomir Andan</b>, will deliver appropriate answer to the High Representative, <b>Paddy Ashdown</b>, says RS Police Director Spokesperson, <b>Radovan Pejic</b>. The HR demanded from Andan to withdraw his statement that the group who committed terrorist attacks in Madrid last year was preparing in BiH. The information on this case cannot be delivered to the State Information and Protection Agency (SIPA) because Director of this agency is not appointed yet. Pejic claims that all relevant facts regarding this case were given to the EUPM at the begging of the investigation. EUPM denies this. <i>“He did not back up his allegations with any kind of evidences. Mr. Andan had the opportunity to deny these allegations, but he did not do that”</i>, said <b>Zinaida Ilarija</b>, EUPM Spokesperson.</p> <p><b>Dnevni Avaz</b>, pg 2 ‘Andan got information in Belgrade’, <u>not signed</u> – Speaking about Andan's original statements, Pejic says Andan <i>“was delivering operational information and intelligence that he, among other issues, received seven days earlier at a Conference on terrorism in southeast Europe (held in Belgrade) and he stressed that he was checking all the information and facts”</i>.
