**HDZ Neum agst  
construction of

town**

**RHB** – The Municipal Board of HDZ Neum expressed their objection against building of a port in Neum. The HDZ Board believes that this would implicate building of other infra-structural facilities. It was stressed that their stance is based on a project “Southern Adriatic”- the regional plan, which was established by the former state, with participation of the Republic Croatia, BiH and Montenegro.

**RHB** – SDA President **Sulejman Tihic** and PDP President **Mladen Ivanic** confirmed that during the constitutional changes talks it was agreed that BiH will have one President and two Vice Presidents.

**RS Radio** – The representatives of the eight parliamentary parties around midnight last night ended talks on constitutional changes without reaching an agreement on BiH Presidency and BiH Parliamentary Assembly. Discussion on these topics are to resume on 15 and 16 January in Sarajevo. Talks agreed on future functioning of the BiH HoP but not on manner of election and akin. **Mladen Ivanic**, PDP leader, assessed the so far talks failed to result in solutions for significant issues related to constitutional changes. According to him, the new round of talks should provide response to the question as to whether essential changes will take place or not. Ivanic said: *"My stance is that the existing Constitution is the base from which we should proceed further."*

Reporter notes the outcome of the so far talks results from hard-lined stances each side is representing, adding that participants of the talks share the view there has been no pressure by the international officials during talks performed so far.

**RS Radio – Krstan Simic**, SNSD official, told RTRS that some issues related to powers of BiH HoP have been agreed upon to a great extent, adding that the issue of election of delegates and number of delegates to BiH HoP remains open. Simic is of the view that the ideal option would be if 9 delegates from each peoples I elected to BiH HoP. Simic said: *"There were at least 15 solution offered for election of delegates, but not a single one was accepted. RS representatives shared the view election should be performed at the Parliaments of RS and F BiH (7 + 14). SDA and HDZ agreed HoR should be in charge of this issue...What also remains disputable is the issue of Presidency. Stances on this issue largely differed."*

<p><b>Bread prices in CS at satisfying level</b></p>	<p><b>BH Radio 1</b> – Bread prices in Canton Sarajevo maintain within legal boundaries. Market Inspection of CS, as Chief Inspector <b>Midhat Pasic</b> explained it, has conducted activities according to the Law on VAT. Inspectors established that increase of bread prices is on satisfying level of 10%.</p>
<p><b>SDS funds to be transferred to BiH institutions</b></p>	<p><b>BH Radio 1</b> – <u>Daliborka Gavrilovic Kujundzic</u> – Financial means that had been paid to the SDS account in a period from January to September 2005 and later frozen by the HR's decision in October 2005 would be transferred to the account of BiH institutions. According to OHR statement, these means will be transferred to account of SIPA, BiH War Crime Chamber and BiH Election Commission which would contribute to the rule of the law in BiH.</p> <p><b>RS Radio</b> also carried OHR statement on the issue.</p>

<p>Talks on constitutional reform continue, certain progress made regarding the structure of state parliament</p>	<p><b>BHT</b> by <a href="#">Gvozden Sarac</a> – At the continuation of constitutional changes talks in Sarajevo, leaders of eight political parties reached an agreement to expand the BiH House of Peoples, however failed to agree on the election of delegates. Process of launching an issue of the vital national interest [VNI] remains the same, whereas peoples’ caucuses would have 7-10 delegates, reports BHT1, adding that talks have been very hard but there has been some progress with two Serbs to be elected from the territory FBiH. Expansion of BiH House of Representatives has been previously agreed, unlike issue of BiH Presidency members, stated reporter. With regard to the BiH HoR representatives, HDZ leader <a href="#">Dragan Covic</a> said there would be “87 representatives, at least three of that from ethnic minorities”. SDA leader <a href="#">Sulejman Tihic</a> commented the negotiations on the Presidency: “Would it be a President or a Presidency, how he would be elected or would there be rotation, all of those key issues have not been agreed.” PDP’s <a href="#">Mladen Ivanic</a>: “Tihic said he cannot accept anything that would verify entities, but we from the RS cannot accept anything that would abolish the entities.” US Ambassador <a href="#">Douglas McElhaney</a>: “Political leaders have to be aware that they can leave the things as they presently are, i.e. inefficient government that is very expensive, or they can make hard political decisions that would take BiH to the better future. SDP leader <a href="#">Zlatko Lagumdžija</a>: “I’m not very optimistic for today, but I am optimistic that we would finish before the deadline, which is January 16.” <b>RHB, PINK, Hayat, RTRS</b></p> <p>also carried the reports on constitutional changes. <b>BHT</b> late news – <a href="#">Mirsad Ceman</a> from BiH HoR Constitutional-Legislative Commission said that definite agreement on BiH HoP has not been reached, but the definition of VNI has been agreed. PDP’s <a href="#">Igor Crndak</a> confirmed that talks are close to reaching an agreement of having ten members in each caucus in BiH HoP.</p> <p><b>Dnevni Avaz</b> pg 4 “House of Representatives will have 87 deputies”, mentioned on cover by <a href="#">A. Malagic</a>– Inset ‘BiH HoP decides only on VNI’ carries that in a future, BiH HoP will discuss only issues of protection of VNI. Delegates will not address all issues that are submitted to parliamentary procedure. Discussion on number of deputies within BiH HoP continues, whereas FBiH parties are proposing 15 and RS parties’ 21 deputies.</p> <p><b>Oslobodjenje</b> pg 3, mentioned on cover “Still without an agreement on BiH Presidency”- by <a href="#">A. Omeragic</a>– <a href="#">Safet Halilovic</a>, SBiH leader, announces continuation of talks for 15th and 16th January.</p> <p><b>Dnevni Avaz</b>, pg 2 ‘BiH could face bankruptcy if it continues like this’ by <a href="#">L. Sinanovic</a> – University Sarajevo Professor <a href="#">Kasim Trnka</a> said, “BiH state administration is a giant that is hard to feed”, urging for decrease of administration on all levels of authority. Otherwise, he warns, BiH could face bankruptcy.</p> <p><b>Vecernji List</b>, pg 3 ‘More than 100 MPs in state parliament’, by <b>zk</b> – Commenting on the apparent agreement of BiH political parties to make the BiH HoR bigger i.e. with more MPs in it (87), VL ironically says the only result of the two-day talks is that BiH will have a more expensive state apparatus. HDZ leader <a href="#">Dragan Covic</a> comments the issue by saying that BiH citizens have no reasons to be cheerful because it is not about a rational solution. On top of this, Covic argues that the cosmetic changes will not satisfy expectations of the BiH citizenry nor Europe when it comes to having an efficient and rational state of BiH. VL also carries SDA leader <a href="#">Sulejman Tihic</a> who says there is less chance that talks end up in constitutional changes.</p> <p><b>Dnevni List</b>, pg 3 ‘Serb politicians persistent in keeping the entity’, by <a href="#">Ivana Rozic</a> – Carries HNZ’s <a href="#">Mate Bandur</a> as confirming that the future BiH HoR will have 87 MPs. Bandur also notes that when it comes the election of BiH Presidency members, the problem is with the way of election of the Presidency members since the Serb representatives insist that they be elected from the entity bodies. HDZ spokesman, <a href="#">Miso Relota</a>, also confirmed for DL that there had not been bigger developments during the talks. “As things stand right now, it would appear that individuals started the negotiations with an aim to trick other two peoples”, said Relota, noting that everything that has happened so far came down to creation of non-constructive atmosphere and constant disagreements between the Bosniak and Serb politicians. Inset ‘Barbaric approach of politicians’ carries leader of SBiH, <a href="#">Safet Halilovic</a>, who says majority of negotiators have a ‘barbaric’ approach to the negotiations. He notes it is appalling that none of politicians are in favour of establishing a state level Ministry of Culture and Education and Ministry of Healthcare.</p> <p><b>Nezavisne Novine</b> pg 3, announced on cover ‘BiH to get President and two deputy presidents’ by <a href="#">M. Cubro</a> – SDA’s <a href="#">Sulejman Tihic</a> and PDP’s <a href="#">Mladen Ivanic</a> confirmed on Wednesday evening that it was agreed during talks on constitutional changes that the President and two Deputy Presidents of the state will be chiefs of executive authorities in BiH. Ivanic said the manner in which these positions will be filled were not agreed upon as yet.</p> <p><b>Glas Srpske</b> pg 5 ‘Marathon runners are tapping in place’ by <a href="#">Z. Domazet</a> – reports on the agreement reached with regard to the number of delegates at HoR and carries statement of <a href="#">Mladen Ivanic</a> who emphasized that someone must make concessions regarding the constitutional changes adding it was not realistic to expect from constitutional changes to change the essence of BiH Constitution or DPA. He also noted he does not expect from international community to exert any pressures and said he would not accept anything under a pressure even if it were the last decision in his career. SDA’s <a href="#">Sulejman Tihic</a> expressed his dissatisfaction over talks and said he does not feel optimistic and does not think anything would be agreed upon. SNSD’s <a href="#">Krstan Simic</a> and SDP’s <a href="#">Zlatko Lagumdžija</a> stated politicians need more time to discuss the issues. HDZ’s <a href="#">Dragan Covic</a> asked that the issue of middle level of authorities be discussed, while Party for BiH’s <a href="#">Beriz Belick</a> said negotiators view any change as both gain and loss.</p> <p><b>EuroBlic</b> pg RS2 ‘Partial solutions’, announced on cover ‘Ivanic: I will not accept anything under a pressure’ by <a href="#">Dusanka Stanisic</a> – HDZ’s <a href="#">Covic</a> said an agreement on competences and manner of election of HoR was agreed upon, while SDA’s <a href="#">Tihic</a> denied they have agreed on the manner of election of HoR. <p>SNSD’ Dodik: SDS is playing with RS’ destiny</p>	<p><b>Nezavisne Novine</b> pg 4, announced on cover ‘SDS is playing with destiny of RS’ by <a href="#">V. Popovic</a> – In a page-long interview to daily, <a href="#">Milorad Dodik</a>, SNSD President, confirms that SNSD will launch initiative for vote-of-confidence in RS Government at the first upcoming session of the RS NA. He says that SNSD has collected sufficient number of votes to accomplish this mission, in whose successful outcome he has no doubts, stressing: “I am convinced that in January, RS will get a new Government. The current Government led by <a href="#">Pero Bukejlavic</a> must leave, since it is evident it has no parliamentary support, over which reason budget for 2006 was not adopted.” He says it is unbelievable SDS is prepared to jeopardise the Parliament stability because of Government, and also that it is playing with the destiny of RS. On constitutional changes, he stresses: “The starting point for compromise and consensus is the existing situation. Maximalist-like demands do not contribute to success of talks, including insistence on one president and abolishment of entities.”</p>

<b>Nikola Spiric: BiH is not ready to accept one president.</b>	<b>Vecernje Novosti</b> pg 2 'One President too many' by <b>Slobodan Pesevic</b> – In a page-long interview to daily, <b>Nikola Spiric</b> , Chairperson of the BiH HoR, says that the executive authority is responsible for the failure to see budgets for 2006 adopted, owing to which reason a major harm was made upon BiH citizens. He says that <b>Adnan Terzic and Dragan Cavic</b> should leave jointly with <b>Paddy Ashdown</b> (whose end of mandate is approaching), since they worked together, since citizens are not satisfied with the work they have done. In regard to economic situation, he says 2006 will be a hard year, noting VAT consequences will be much harder in BiH than in other states, since there is no readiness of Government felt at entity and state levels to intervene and prevent seeing citizens paying the sole price. On constitutional changes, he says: <i>"Essentially speaking, the changes international community wants will take place. It is still hard to say how Constitution will exactly look like, but I can say there are no sort of cosmetic changes, but instead crucial. I presume medium solution will be sought for, since no mutual trust has been sufficiently built in BiH."</i> He notes BiH is still not ready to accept the institution of one president. He says there is a rift within SDS, proving it by the fact that intentions for removal of <b>Pero Bukejlovic</b> ' Cabinet from <b>Dragan Cavic</b> .
<b>DL op-ed: BiH politicians' main goal in 2006 is general elections</b>	<b>Dnevni List</b> , pg 2 'Fight for positions', by <b>Ivana Rozic</b> – Commenting on the course of constitutional reforms talks and political situation in general, <b>Rozic</b> says the former are marked with lack of agreement and with participants failing to tackle the real problems of the country. As for the general political situation, <b>Rozic</b> argues it is the 2006 general elections that are the most important issue for the politicians in BiH, especially the Croat ones, who are ready to do almost everything to remain in their respective positions, not caring even about the law and basic political manners.
<b>VL op-ed: BiH should use Croatia's experience</b>	<b>Vecernji List</b> , pg 4 'Highway builds togetherness', by <b>Petar Grubisic</b> – Commenting on the constitutional reforms talks and lack of results during the said process, <b>Grubisic</b> says the key issue is that all the political players should strive to achieve progress in BiH i.e. to improve the living standard of BiH citizens. <b>Grubisic</b> reckons BiH should follow Croatia's example, which built a modern highway between Zagreb and Split, which created many jobs, connected the people and areas and benefited economically.
<b>Ambassador Almhofer: 2006 turning point for BiH; status of BiH and Kosovo cannot be compared</b>	<b>Pink</b> – 2006 presents a crucial year for BiH in all domains, said the Austrian Ambassador to BiH <b>Werner Almhofer</b> at the press conference held on Wednesday. Almhofer, whose country took over the EU Presidency on 1 January, added that by beginning of 2006, BiH had achieved progress and started solving challenging issues such as constitutional reform talks. Almhofer said that if the country manages to complete ongoing reforms with success, BiH would sign the Stabilization and Association Agreement by the end of 2006 adding Austria will help BiH in its efforts to do that. <i>"In case of having the ongoing reform processes carried out with success, it is sure that the OHR will be transformed into the Office of the EU Special Representative by the end of the year"</i> , said Almhofer. He reiterated stances of the EU Enlargement Commissioner <b>Olli Rehn</b> that in order to become the EU state member, BiH had to meet three conditions: human rights, efficiency and functionality. Austria announced that it would organize a number of meetings between ministries in all sectors at the EU and region levels. <b>Hayat</b> – Almhofer added that he hopes that <b>Christian Schwarz Schilling</b> was going to be the last High Representative to BiH and that BiH citizens desperately needed changes in the Constitution in order for BiH to become the EU state member. <b>RHB, BHT, RTRS, FTV</b> also carried the Ambassador's statement.  <b>Dnevni Avaz</b> , cover page splash and pg 5 'BiH and Kosovo can not be compared at all' by <b>Sanja Skuletic</b> – Status of BiH and Kosovo cannot be compared at all, said Austrian Ambassador <b>Werner Almhofer</b> , adding that status of BiH has been regulated with Dayton Peace Agreement, and status of Kosovo is yet to be regulated. Main Board has the authority to cancel the decision of Presidency, and can convoke new party Assembly.</p> <p><b>Oslobodjenje</b> pg 7 ‘Signatures will determine whether there will be talk about conflict’, mentioned by cover, by <b>A. Omeragic</b> – Following the announcements that the HDZ Main Board session would discuss internal party’s issues, HDZ spokesperson <b>Miso Relota</b> comments that party is not “concerned” day before the session.
