He is of the view the draft opinion will be finalized by middle next week, and officially confirmed at the session of Venetian Commission on 16 and 17 March.

<p>Report on speech Muhamed Filipovic gave at public discussion on constitutional changes</p>	<p>NTV Hayat – Report carries speech Muhamed Filipovic, academician, gave at public debate on constitutional changes organized by SBiH, SDU and BOSS, on March 2nd, in Sarajevo. Filipovic criticized all the BiH political parties which are now taking part in the constitutional talks. He said that HDZ took part in destroying BiH by supporting the idea on having parts of BiH joined to Croatia. Filipovic continues by saying that Serb parties have been interested in making BiH Serbs' state by joining it to 'The Great Serbia'. Furthermore Filipovic says that he is mostly surprised by the fact that SDA leader Sulejman Tihic calls on continuity of politics. Filipovic raises the following issues: <i>"Which politics?! Politics on defence of BiH's territorial integrity. What kind of politics is the one which legalizes violence reflected in dividing BiH into two entities?"</i>,</p>

NTV Hayat – Report carries interview with **Sejfudin Tokic**, leader of SDU, one of the parties which organized public debate on constitutional changes in BiH. Tokic said that his party strongly condemned the fact that document, the most relevant one in terms of BiH's future, namely Constitution, was going to be signed by several people, while intellectuals, nongovernmental organizations, academicians were totally excluded from it. Tokic says that such agreement, which the political parties are about to sign, supports division within BiH and even legalizes the RS' name. On being asked to comment the role U.S. officials had in the talks, Tokic said he believed that it was about their personal political position; they could lose their positions if they do not do something in BiH. He also said that he believed that great number of representatives of political parties which are taking part in the constitutional talks do not support their leaders. He justifies it with the fact that **Jozo Krizanovic**, SDP representative and **Hasan Cengic**, SDA representatives attended the public debate, saying that they were interested in public opinion and that their leaders should do the same. On being asked whether a coalition between the parties which organized the debate is going to be established, Tokic said that they were just a BiH's patriotic block, which opposed legalization of ethnical division.

Second question: Which political party's stances on constitutional changes you support? Great number of BiH citizens said that they were supporting neither of the parties since they worked against their interests. They also said that none of the above mentioned political parties' representatives had right to sign any kind of constitutional changes agreement on behalf of BiH citizens.</p>

<p>“Others” not included in constitutional changes</p>	<p>TV PINK – Negotiations on constitutional changes include leaders of eight political parties but not citizens, especially “others”. European Parliament Representatives believe that this is discrimination and if BiH does not work on this issue, its way toward EU would not be easy. In the census in 1991, 8% of BiH citizens did not declare themselves as member of one of three constitutional people but as citizen of this country. “Others” were not consulted regarding constitutional changes. Jakob Finci, director State Service Agency said that BiH Parliament did not give seats for “others’ and that BiH Parliament only protects vital national interest of three peoples. Hans Swoboda, European Parliament Representative said that BiH with the Constitution that discriminates someone would not be able to associate with EU. Swoboda said that negotiations on constitutional changes should continue adding that there should be decision made after the October elections that would satisfy all the citizens of BiH.</p>

Political Developments

<p>First session of new RS Government:</p> <p>Many decisions of previous Govt. put out of effect</p>	<p>RTRS – New RS Government held its first session in Banja Luka on Saturday. RS Government outlawed decision of former RS Government on increase of their salaries. New Ministers are satisfied with transfer of duty but not with the work that previous Government left behind. RS Government dismissed Representatives of state capital in companies that have major state capital. Their successors are appointed only in companies that announced shareholders' assemblies. Compensations of Representatives of state capital are reduced. <i>"We limited compensations of Representatives of state capital to average salary in RS, which is 420 KM. That will be the maximal compensation. There were companies that gave them compensations in amount of 1000 or 1500 KM"</i>, said Milorad Dodik, RS Prime Minister. RS Government also outlawed previous decisions on concessions without contracts. Deputy Ministers who resigned are appointed on the acting positions until Government makes the appointments. Those that did not resign would be dismissed by the Government.</p> <p>RS Government also suspended decision on appointments in Councils of the Universities in East Sarajevo and Banja Luka. RS Government will also discuss pays for visiting professors. <i>"They (professors) earn around 6000 KM. For example Mr. Dragoljub Mirjanic earns 6090 KM from the faculties that get money from the budget and also earns additional pay in private faculties and faculties in FBiH"</i>, said Dodik. RS Government asked for the resignations in Elektrokrajina due to irregularities in work. If these resignations are not submitted, RS Government would bring charges. RS Government announced to bring new charges. New session of RS Government is scheduled for Tuesday, March 7 when Government would give proposal for budget, Special Prosecution and Investment Bank.</p> <p>BHT 1 – Dodik announced charges against all companies suspected of mismanagement. <p>Interview with EUPM Commissioner Coppola: Terrorism is no threat to BH security</p>	<p>Nezavisne Novine pgs 8-9, announced on cover 'Terrorism is no threat to safety in BiH' by <u>Almedin Sisic</u> – In a lengthy interview to daily, Vincenzo Coppola, Head of EUPM Mission to BiH, says that <i>"political interference in the work of police in BiH is still strong...I want to be clear: political control over the work of police is normal, bit interference is something else – it is inadmissible."</i> Announcing future activities of the EUPM, Coppola says that it would conduct inspections of local police structures. Responding to press question what the greatest threats to safety in BiH are, he responds there are many sorts of threats, starting with minor crime, via organised crime, trafficking in people, etc. According to him, the fact is that corruption is more visible in BiH than in other states. Noting successful fight against corruption involves the issue of alteration of mentality. In regard to terrorism issues, he says: <i>"It is most likely there is terrorism presence in BiH, but I am not certain whether that presence represents a threat to BiH security. Hence, I am of the view that situation in BiH is – at worst case – akin to the situations in some European states."</i> In regard to police reform, he notes the final goal of reform is to get more efficient police force, with reduced level of command chain.</p>

<p>Shooting in East Sarajevo: Suspected war crime network aider murdered</p>	<p>TV PINK – In the incident that happened in East Sarajevo bar “Ribnjak” on Friday night, unknown person opened fire and killed Ratomir Spaic, businessmen and alleged member of Radovan Karadzic’s support network. On that occasion, Svjetlana Topalic, journalist of BH TV, Stjepan Lazarevic and Zorica Jovancic were injured. Only Topalic was hardly injured and had surgery performed in Kasindol hospital. Topalic is out of life danger. Jasmin Sose, Duty District Prosecutor East Sarajevo confirmed that some people have already been questioned regarding the incident. Police of East Sarajevo is conducting the investigation and doing its best to find perpetrator.</p> <p>BHT 1 – The murderer still hasn’t been identified but the investigation is ongoing. Spaic, owner of RMG company, was often connected with network protecting war crime indictee at large Radovan Karadzic and with mafia. <p>Interview with Phon van der Biesen</p>	<p>NTV Hayat – Report carries interview with Phon van der Biesen, BiH legal representative in BiH vs. SCG lawsuit for aggression and genocide. On being asked whether the evidence documentation BiH team is to present before the International Court of Justice in The Hague is sufficient in order for the lawsuit to be successful, Biesen said that the team has submitted a lot of documentation and that it now was clarifying some issues which have not been clarified enough since there was no sufficient material. <i>“In period of 10 days we are presenting a whole picture of ethnical cleansing period which raged in BiH”</i>, said van der Biesen. Biesen explained why the team did not invited war victims, individuals, to testify in the case because there is great number of war victims and it would not be fair to make any kind of election, making one victim more relevant than the other. While commenting statement Serbian Prime Minister Vojislav Kostunica gave after videotape on his visit to Serb troops at frontline in Sarajevo during the war was shown in the Court, namely when he said that it presented no evidence and that due to such poor evidences the lawsuit was going to be rejected, van der Biesen said that the team believed that it was of extreme relevance to show the Court that people such as Kostunica were passing the BiH borders without asking BiH authorities for permission. Van der Biesen also added that it was not the only piece of document the team was going to present and that it was only 20 seconds out of the 30 hours of material the team had. While commenting the fact that a BiH ombudsman Vitomir Popovic is a defence witness in the case, van der Biesen said that it was too early to comment such issues since he did not know what he or other defence witnesses were going to say. <i>“The whole team believes that the World wants to see that justice is about to be reached in terms of genocide which took place in BiH”</i>, said van der Biesen at the end of the interview.</p>

<p>Three persons indicted for war crimes were arrested in Zvornik</p>	<p>BH T 1 – War crime indictees Ratko Todorovic, Dusan Spasojevic and Mirko Pantic have been arrested in Zvornik on Friday upon the warrant issued by Tuzla Cantonal Prosecutor's Office. Spokesperson of RS Ministry of Interior Radovan Pejic first denied that these indictees were arrested and than in a telephone interview for BHT 1 he confirmed their arrest. The apprehended war crime indictees are charged with war crimes against Bosniaks in Zvornik in 1993. <p>Interview with HJPC President: Selection of foreign judges and prosecutors should be more transparent</p>	<p>Dnevni Avaz pg 5 'Selection of foreign judges and prosecutor is not transparent enough' by <u>Husein Orahovac</u> – In an interview to daily, Branko Peric, President of the High Judicial and Prosecutorial Council (HJPC), estimates that the establishment of the HJPC has ensured a full independence of judiciary from politics. He is of the view that the a long fight is ahead of judicial-prosecutorial authority to reach the satisfactory level of efficiency, the lack of which at the moment Peric sees in the fact that disputes that judiciary should not be dealing with are run as in no other place in developed world (i.e. failure to pay utility bills). In regard to election of foreign judges and prosecutors, he is of the view it is not transparent enough, which is because HJPC is not entirely authorized to deal with the appointments.</p>

Confederation also requests that 50% of VAT is allocated to social categories but not fixed 50 million KM. Cedo Volas, Chair of Confederation believes that budgets should be passed as soon as possible in order that categories (pensioners, socially endangered persons and employees) get resources. Volas expects from BiH Council of Ministers to establish Economic- Social Council on BiH level. Volas will request meeting with the World Bank due to World Bank request for decrease of salaries in BiH.</p>
