<p>Srebrenica Commission</p>	<p>Herceg Bosna Radio, BHTV, FTV, RTRS, Oslobođenje pg. 5 'Culprits for the crime must be punished', Dnevni Avaz pg. 2 'Fassier sharply warned Mikerevic, Cavic', Vecernji List page 4 'To punish perpetrators of crimes in Srebrenica' by Fena, Dnevni List page 18 'Truth about Srebrenica prerequisite for Partnership for Peace' <u>not signed</u>, Slobodna Dalmacija page 17 'To accept truth and punish perpetrators' by A. Macanovic, Blic p 12 'Bring truth to light', Vecernje Novosti p 5 'Truth must be accepted', FENA – Only a positive report by the Srebrenica Commission which will meet all demands posed by the BiH Human Rights Chamber can save the RS credibility, RS Prime Minister Dragan Mikerevic said on Thursday. At an extraordinary session in Banja Luka, Mikerevic addressed the commission for the investigation of the events that happened in and near Srebrenica from 10 to 19 July 1995. He stressed that those who had committed a crime in Srebrenica in the mentioned period of time must be found and punished. <i>"The public must be ready to accept the commission's report regardless of what it will say,"</i> Mikerevic said. Political manipulations must not interfere with the report, he repeated and said that all bodies of RS powers should help with this report. Everyone who will obstruct the commission's work will be sanctioned, the RS prime minister warned.</p> <p>BHTV, FTV, RTRS, Oslobođenje pg. 5 'Culprits for the crime must be punished', Dnevni Avaz pg. 2 'Fassier sharply warned Mikerevic, Cavic', Vecernji List page 4 'To punish perpetrators of crimes in Srebrenica' by Fena, Dnevni List page 18 'Truth about Srebrenica prerequisite for Partnership for Peace' <u>not signed</u>, Slobodna Dalmacija page 17 'To accept truth and punish perpetrators' by A. Macanovic, Blic p 12 'Bring truth to light', Vecernje Novosti p 5 'Truth must be accepted', FENA – Senior Deputy High Representative Bernard Fassier said in Banja Luka on Thursday that neither the High Representative nor the international community would tolerate any obstruction of the work on the development of the report on events in and around Srebrenica between July 10 and 19 1995, and that all those responsible for such obstructions would be held accountable. Fassier stressed that RS political authorities would also be considered responsible for their lack of effort on ensuring the success of the Srebrenica Commission. He said that the sole task of the Commission is to ensure and discover information about the faith of those still considered missing in the Srebrenica events from that period, as stated in the decision of the BiH Human Rights Chamber.</p>

<p>Vrankic: I expect FBiH Government to provide guarantees for temporary release of the Croat indictees</p>	<p>Herceg Bosna Radio, BHTV, Oslobođenje pg. 3 'FBiH Government to give guarantees at the next session?', FENA – The FBiH Government provided guarantees for the temporary release of Bosniaks indicted by the Hague Tribunal in the past and there is no reason why it should not do the same in the case of five Croats who voluntarily surrendered to the Hague Tribunal, FBiH Deputy Prime Minister and Finance and Treasury Minister Dragan Vrankic told FENA. <i>"After it provides guarantees in written form to the Hague Tribunal the Government can, if requested, also present its position verbally in a debate before the court,"</i> Vrankic said and added that he expects the Government to consider the requests of attorneys for the five Croats and to provide guarantees at the next session.</p> <p>Vecernji List, front and page 4 'BiH guarantees for Croat indictees questionable' , by <u>Dejan Jazvic</u> – notes that the FBiH Government is likely to discuss a request of the five Croat indictees' lawyers, who want the FBiH Government to give guarantees for their clients, which will result in pre-trial release, at a session scheduled for Tuesday. VL list says that opinions of FBiH Ministries of Justice and Interior, as well as of Ministries on Interior of cantons where the indictees live, will be crucial for the final decision of the FBiH Government. VL notes that only Jadranko Prlic has a permanent residence in BiH, whilst Bruno Stojic, Valentin Coric, Berislav Pusic and Slobodan Praljak spend most of their time in Croatia, in other words, the BiH authorities cannot control their movements. However, according to VL, due to political reasons, it is likely that the guarantees will be given.</p> <p>Dnevni List, page 5 'Ensure credible guarantees for five indictees', <u>not signed</u> – carries the FBiH Vice President, Sahbaz Dzihanovic, as saying: <i>'Every indictee that voluntarily surrenders to The Hague Tribunal should get the Government's support in terms of giving guarantees for pre-trial release'</i>.</p>

<p>Indictments against 4 former senior Bosniak officials</p>	<p>Slobodna Dalmacija, front and page 3 'Ganic, Delic, Mahmuljin and Alispahic go to The Hague', by <u>M. Landeka</u> – notes that four former senior officials of the then Republic of Bosnia and Herzegovina should be soon travelling of to The Hague. SD got a confirmation from a source in the ICTY that the Chief ICTY Prosecutor, Carla del Ponte, has signed indictments against former member of BiH Presidency, Ejup Ganic, former commander of BiH Army, Rasim Delic, former commander of BiH Army's 3rd Corps, Sakib Mahmuljin, and former Interior Minister of BiH, Bakir Alispahic. Apparently, they are being charged with crimes committed against the Croats in Grabovica and central Bosnia, and crimes committed against the Serbs on Ozren and Kazani in Sarajevo. Similar article in Vecernji List, page 5 'Indictments against four Bosniaks for war crimes', by <u>Hina</u>.</p> <p>Oslobodjenje front page, pgs. 4-5 'The Hague's Prosecution Office conducting investigation against Mahmuljin' – The ICTY Prosecution Office is conducting investigation against former BiH Army Third Corps Commander Sakib Mahmuljin over war crimes committed in Vozudja, and the indictment against him might be filed soon, learns the newspaper from the sources close to the Tribunal.</p> <p>Slobodna Dalmacija, back page 'Indictments from the Belgrade workshop', by <u>B. Kristo</u> – carries Ejup Ganic as denying reports in the BiH media that he will be indicted by the ICTY. <i>'My explanation is that the media are trying to up the sales and have better ratings. I was picked because I was, as you could say, one of people from the authority that defended BiH. I know about the Belgrade project to accuse me for the May 2, 1992. But, it would be the same if BiH were to be accused of launching aggression against Belgrade'</i>, says Ganic.</p> <p>Dnevni Avaz pg. 2 'Tihic: I will do my best to ensure that all persons subjected to the investigation report to the Hague's Prosecution Office' – In a statement for the newspaper, Chairman of the BiH Presidency and SDA leader Sulejman Tihic said that it was his duty and that he would therefore do his best to ensure that all persons investigated/indicted by the ICTY appear before the Tribunal or its Prosecution Office.</p>

<p>Magazines on HR Ashdown's sanctions against SDS</p>	<p>Dani pg 16 'The Bosnian Barometer' column – Dani magazine marked recent sanctions imposed by the High Representative Paddy Ashdown against SDS with three starts [excellent move]. <i>"Now, Ashdown should, if he had courage, finish a job, in which Alija Izetbegovic prevented Richard Holbrooke, and – ban SDS,"</i> concludes the magazine.</p> <p>Slobodna Bosna cover 'Paddy Ashdown vs. SDS: How SDS finances itself?', pgs 34-36 'SDS has millions of KM collected through smuggling, crime, racketeering' by <u>Suzana Andjelic</u> – SB writes that HR's sanctions against SDS were nothing but a "farce", and "the first and main reason" to see that decision as a "trick... is the fact that freezing SDS legal accounts means absolutely nothing. Never since its establishment this party survived financially in legal way, but it always acted as mafia organization." SB further says that SDS "has always had parallel sources of financing. And [Dragan] Kalinic is not that crazy to disclose to Ashdown those parallel channels, so SDS financial report will show that no financial transaction carried out from legal budgetary accounts of the party and its municipal boards has been illegal... Serious analysis creates doubt that this move HR agreed with SDS, at the meeting with Kalinic, [Dragan] Cavic, PDP President Mladen Ivanic and RS Interior Minister Zoran Djeric, held just a night before he announced his decision... With this move, HR will present SDS as victim to embittered Serbs, and protect it from further opposition expected over future RS authorities' actions regarding the arrest of war crimes suspects." SB also claims SDS has a number of illegal ways to finance itself, among which are including oil smuggling, customs frauds, drug smuggling. It also lists companies for which magazine claims to finance SDS: Elektroprivreda RS, RS Customs Administration, Srpske sume company, a number of restaurants, hotel Bosnia in Banja Luka, and Banja Luka Brewery.</p>

<p>SB on SFOR action in Pale</p>	<p>Slobodna Bosna cover splash 'Where is, actually, Karadzic?', pgs 5-7 'RS intelligence framed 'secret' information on Karadzic being in Pale to SFOR' by <u>Suzana Andjelic</u> – Writing that the latest SFOR operation with an aim to arrest Karadzic carried out in Pale was an another amateurish failure, author argues: <i>"There is no doubt that this event is the best election campaign for SDS in the year of municipal elections, and that it suppressed all social issues in RS that opposition has been raising for months. Political damage caused by this is huge, and electoral body once again radicalised as SDS, as many times before, proved it knows how to use situations like this."</i> Giving history of trials to have Radovan Karadzic before the ICTY, SB says international community is the main to blame that Karadzic is at large for eight years, building an image of <i>"uncatchable hero"</i>. Magazine also claims it learned from sources close to intelligence service that RS Intelligence framed to SFOR information on Karadzic being in Pale to provoke SFOR's action in orthodox church's premises at the time Serbs are revolted with events in Kosovo, which would create radical nationalistic homogenisation necessary for SDS' victory at upcoming elections.</p>

Ljiljan cover 'Sulejman Tihic: If there are Bosniak prefixes, let Paravac use his constitutional right', pgs 18-22 'Tihic: Opposition doesn't want reforms, it wants new elections' by **Mirsad Sinanovic** – In an interview with Ljiljan magazine, the Chair of the BiH Presidency, **Sulejman Tihic**, comments his initiative to reconsider the name of Republika Srpska: *"In BiH, no settlement, a city, or entity should bear a name of any of the peoples, or any religious group, and we don't need that discriminatory attribute. I stick to what I said during the elections campaign, that there will be no entity called RS,"* says Tihic. Recent initiative by opposition parties to reconsider confidence towards the Council of Ministers Tihic characterises as evidence that the opposition in BiH doesn't want to work in interests of BiH citizens, bit their own: *"Our opposition wants to halt these reforms, to have extraordinary elections, for us to lose a year in election campaign and constitution of the government. That speaks about the opposition we have. Anyways, elections results proved the trust that opposition enjoys with the citizens."* Asked to comment SDS obstructions towards the reforms, Tihic says: *"We are not in coalition with SDS. There is a necessary constitutional partnership, a consequence of the DPA... We have such constitutional structure which stipulates establishment of the authorities with the parties winning the majority of the votes of its peoples... All those saying that it would be possible to establish authorities in some other way... are deceiving the public."* Commenting that many parties in BiH do everything to prevent implementation of the reforms, Tihic concludes: *"SDA is the only party which is in every sense and completely dedicated to the reforms."*

<p>DA: Sarovic still receiving salary in the BiH Presidency</p>	<p>Dnevni Avaz front page, pg. 3 'Sarovic still receiving salary in the BiH Presidency' – Although Paddy Ashdown put him on the list of the most wanted war criminal Radovan Karadzic's supporters, Mirko Sarovic, the former member of the BiH Presidency, is still receiving salary of KM 1,780 from the state Budget, learns the newspaper. The daily was told in the Presidency's Secretariat that, according to the valid law/regulation, all former body's members were receiving salaries and using other benefits (official vehicle, personal security) yet 12 months after leaving the office/ending the mandate.</p>
<p>Serb Orthodox Church withdraws from the BiH Inter-religious Council</p>	<p>BHTV, FTV, RTRS, Oslobođenje pg. 4 'Serb Orthodox Church withdraws from BiH Inter-religious Council', Dnevni Avaz pg. 2, Nezavisne novine page 2 'Serb Orthodox Church stepped out from BiH Interreligious Council', SRNA – The Serb Orthodox Church has withdrawn from the BiH Inter-Religious Council due to the council not reacting to events, which occurred in Pale on the night of March 31 and April 1 (SFOR operation to find Radovan Karadzic, in which Priest Jeromija Starovlah and his son were seriously injured after the raid on the priest's home). This decision was reached by the Episcopal Council of BiH at a session on Wednesday in Doboj, the Dabro-Bosnian Diocese said on Thursday. <i>"The position of all the bishops has been that, until now, we have actively participated in the work of the BiH Inter-Religious Council and have participated in good faith in all condemnations of crimes, wherever they have occurred. To date this council has yet to show even the least bit of interest in the crime which was perpetrated against us,"</i> the statement says.</p>

Saying "I'm sorry" is not apology. The apology is something deeper.</p> <p>It means that one acknowledges mistake and repentance, Bishop Grigorije stated. He added that after "I'm sorry" there were new conditioning and linking the Church with something it never had anything to do with.</p>

Banja Luka, saying that 'Banja Luka has missed the
chance to again accept its exiled children'. He
added someone must be held responsible for this,
because nobody has the right to deprive someone of
his homeland and remain unpunished. *'Where is the
international community that has allowed, not to
say even helped, this tragedy to happen to our
country? Their representatives must be more
consistent and responsible and they need top show
they want to help here'*, Komarica stated.

The article carries the inset '**Shameless force of
SFOR**', which reads that Bishop **Komarica** sent his
deepest condolences to Metropolitan **Nikolaj** upon
the event in Pale, when Priest Jeremija Starovlah
and his son were injured. *'I was really shocked to
see shameless force was again being applied in
this region...'*, Komarica stated.

of the biggest culprits that BiH cannot stand on

Representative's** statement that the RS is not
cooperating with the ICTY, stated that HR Ashdown
did not have a right to blame anyone, be it a

Dnevni List, page 9 'Croats in BiH fear for language, culture and own identity', by **KTA** – reports that the Archbishop of Vrhbosnia, **Cardinal Vinko Puljic**, met with Senior Deputy High Representative, **Werner Wnendt**, at his residence on Tuesday. According to DL, SDHR Wnendt stressed that he believed that the 'two schools under one roof' project must be completed in order to maintain the right to language and own curriculum, noting that the unification would be based on unification of administrations. Reportedly, Cardinal Puljic did not want to go into process related to enactment of laws, but he expected that the Croats be given assurances that the relevant laws do offer protection to the Croats too, because the BiH Croats fear for their language, culture and identity.

<p>OHR urges BiH authorities to appoint BiH Statistics Agency director</p>	<p>Dnevni Avaz, pg. 5 'Appoint Director of the BiH Agency for Statistics', Dnevni List page 6 'Ruling coalition responsible for non-appointment of Director' <u>by De.L.</u>, FENA – The OHR notes that the BiH institutions seem to be getting more serious about the impending deadlines for the passage of key reforms relating to the 16 pre-requirements set by the European Commission for the start of negotiations on a Stability and Association Agreement, OHR spokesman Kevin Sullivan told a press conference in Sarajevo on Thursday. This week the BiH House of Peoples, at the request of the BiH Council of Ministers, decided to discuss the SIPA legislation, legislation on the BiH High Judicial and Prosecutorial Council and the Law on University Education in shortened procedures. If this indicates a refocused attitude on reform then it is welcome, he said. At the same time there are areas in which BiH's political leadership is clearly failing and has been doing so for months. For example, the appointment of the Director of the BiH Statistics Agency – appointment of a suitable candidate has been pending since December last year. It is not that there is a lack of suitable qualified candidates – this is rarely a problem in BiH. In December last year the BiH Civil Service Agency, in line with applicable domestic legislation, identified</p>

<p>Referendum in Srpsko Sarajevo?</p>	<p>Nezavisne novine page 9 'Referendum will give new names of town and municipalities' – RSNA Speaker Dragan Kalinic said that most probably referendum would give new names to municipalities and town of Srpsko Sarajevo. <i>"Although we would like to question BiH Constitutional Court decision it is not possible because it's obligatory, especially for Srpsko Sarajevo"</i>, Kalinic stated after the meeting with mayors of municipalities and Srpsko Sarajevo leadership.</p>
<p>Locher: BiH will be invited to join PfP in June</p>	<p>Dnevni Avaz pg. 5, mentioned on the front page 'BiH will be invited to join PfP in June' – Interview with James Locher, the chairman of the Defence reform Commission. He said that, by the end of May, BiH would in military sense be ready to join NATO's Partnership for Peace program.</p>

<p>SB on situation in Mostar</p>	<p>Slobodna Bosna pgs 8&9, 16 'While SDA and HDZ fight around distribution of the positions, euphoria of illegal construction spread all around Mostar' by <u>Danka Savic</u> – SB writes that almost a month following the decision of the HR Paddy Ashdown to abolish six Mostar municipalities and establish a single City Administration, <i>“the life in Herzegovina capital is paralysed – City Administration practically did not take over a single function as envisaged; its offices are waiting for new bosses, and ruling SDA and HDZ cannot agree on distribution of functions in city authorities.”</i> SB further writes that the strongest conflict arouses around the position of the Chief of the Urbanism Office. Apparently, Mostar Mayor Hamdija Jahic has just appointed Haris Kovacevic to the position, however author argues that his appointment will probably be strongly opposed [especially since he is a lawyer.] SB also says that Mostar citizens are suffering due to vacuum which will last till appointment of the Administration's departments, who are only persons authorised to sign decisions. It further claims that situation has been used by owners of certain facilities in Old City carrying out illegal destruction of existing and building of the new premises. Apparently, inspectors could not have stopped this as they did not have authority, given these days, to continue with their job. SB also writes that a majority of current departments' chiefs [naming them] have no adequate qualifications to perform their duties.</p>

<p>Competent BiH ministry confirms Madrid terrorist suspect born in BiH</p>	<p>BHTV, FTV, RTRS, Oslobođenje pg. 3, mentioned on the front page 'Terrorist Sanel Sjekirica was born in Mostar', Blic p 4 'Sanel Sjekirica was born in Mostar', SRNA – The BiH Deputy Security Minister, Dragan Mektic, confirmed on Thursday that Sanel Sjekirica, who Spanish authorities suspect of being involved in terrorist activities, was born in Mostar. Further details on the current investigation into the nationality of Sjekirica, his movements and other information requested by the Spanish authorities, Mektic could not report on for operational reasons. The BiH Security Ministry, as he said, was in continuous contact with the Spanish police authorities. Spanish media reported that Sjekirica, together with Amer el Aziz and Rabei Osman Ahmed, was involved in terrorist activities and linked to Al-Qaeda.</p> <p>Vecernji List, front page splash and page 3 'Sanel is on vacation in the mountains near Oviedo', by Robert Soldo – following reports that the Spanish authorities have request an identity check for one Sanel Sjekirica, a BiH citizen, who is apparently connected to recent terrorist attacks in Spain, VL visited Sanel's father Alija, who lives in Mostar and who told the daily that he was on the phone to Sanel's mother, who lives in Oviedo (Spain) and who told him that her son was on vacation in the mountains near Oviedo. Alija says his son is a student in Oviedo, which was verified by the daily. Alija is convinced his son is not a terrorist.</p> <p>Dnevni List, front page splash and page 5 'Parents of Sanel Sjekirica claim: Our son is not a terrorist', by M. M. R. – carries a statement by Sanel's mother, Sejda Sjekirica, who told DL that no Spanish authority has contacted them, denying reports on her son being a terrorist. DL also reports that Sanel is on vacation, and is due to return to Oviedo on Monday.</p> <p>Slobodna Dalmacija, front page splash and page 3 'Sanel Sjekirica belongs to second generation of trained Bosnian mujahiddin', by Zlatko Tulic, Ivica Milesic – reports that the BiH Deputy Minister of Security, Dragan Mektic, confirmed to journalists on Thursday that Sanel Sjekirica was born in Mostar, but could not reveal additional information in the interest of the investigation. SD goes on to say that according to information coming from sources close to the cantonal Ministry of Interior of Central Bosnia Canton, Sanel Sjekirica belongs to the second generation of domestically trained extreme mujahiddin, who were trained for operations such as the one in Madrid. He joined Faculty of Economics in Madrid. Later he moved to Oviedo where he lives today. "<i>He was a flat mate with one of the suspects while he was living in Madrid</i>", Sena Sjekirica stated. "<i>Sanel lost Bosnian passport couple of years ago. It is possible that someone had used it. He reported that he had lost passport and obtained a new one</i>", his mother said.
