

OHR RTRS News Summary, 30 September 2000

News Headlines:

- RS police find 70 kg of marijuana at Deleusa border crossing (on Bileca-Niksic road)
- Dodik and RS Interior Minister Sredoja Novic hold press conference following successful confiscation of cocaine and other drugs
- RS members of BiH House of Representatives and members of RS institutions (not including Radisic, Djokic and Dodik) discuss High Representative's decree on Amendments and Supplements to Law on Travel Documents and request extraordinary session of RS National Assembly to debate the issue
- Djokic states he was not informed about the Banja Luka meeting on time and says he will organise consultations about the issue next week
- BiH politicians create conditions for imposition of solutions with their conformist behaviour – Dodik on Banja Luka meeting
- SDS calls on all RS bodies as well as RS representatives in BiH institutions to formulate stance on High Representative's decree regarding single passport
- DSP does not support decree of High Representative on single passport- DSP General Secretary Igor Radojicic
- DNZ supports High Representative's decree
- State Election Commission (SIK) rejects DOS appeal on election results
- DOS's SIK representative Nebojsa Bakarec states DOS will take complaint against SIK to Yugoslav Constitutional Court
- Putin is ready to send Foreign Minister Ivanov to Yugoslavia for consultations with all sides
