

# OHR RTRS News Summary, 5 October 2000

## News Headlines:

- Dead and injured reported in Belgrade
- Demonstrators enter Yugoslav Parliament building
- Demonstrators enter RTS building; RTS building set on fire
- 1.5 million people gather in Belgrade to demonstrate against Milosevic regime
- After talks with former Yugoslav Army General Momcilo Perisic, Yugoslav Army soldiers withdraw to barracks
- Studio B broadcasting its program live from Belgrade
- Democratic Opposition of Serbia (DOS) representatives tell demonstrators they want peace and not violation in Serbia
- Demonstrators held RTS Director Milorad Komrakov as hostage for certain period of time

- Yugoslav Constitutional Court decision gives Milosevic legal justification to use force – G17PLUS

- Yugoslav Constitutional Court decision dishonest and unclear – Montenegrin Deputy Premier and SDP Montenegro member Dragisa Burzan
- Prior to dispatching Russian parliamentarians to Yugoslavia, Yugoslav Constitutional Court decision must be considered – Duma Foreign Policy Committee President Dmitry Rogozin
- Russian Supreme Defence Council Secretary Sergey Ivanov believes that Yugoslav Constitutional Court decision provided breathing room for talks between Belgrade leadership and opposition

## News Summary:

Milisic comments on Dodik request to Petritsch to bring decision on amendments to RS Privatization Law (00:32)

OHR spokesman Oleg Milisic commented on RS Prime Minister Milorad Dodik's 4 October request addressed to High Representative [Wolfgang Petritsch](#) concerning amendments and supplements to the Law on Privatization. Milisic said that Petritsch supports the purchase of apartments but added it must be done in an undiscriminating and fiscally correct framework. Milisic said the imposition of this law has not been excluded and the law, which is very important for the RS, should be put into effect as soon as possible.
