BHTV on Friday, ONASA – Sarajevo-based BiH Telecom enterprise said on Friday that it cannot accept the notion for the collection of broadcasting subscriptions via telephony bills, as this activity would be a violation of the present legal regulations in the domain, and the signing of such a contract with the Public Broadcasting Service would create a series of legal, economic and technical problems. The BiH Telecom said that the law on protection of consumers indicates that all bills must be mailed separately to consumers, or subscribers in this case. The law also foresees fines for legal entities that fail to comply with the law. "Despite the fact that broadcasting subscriptions are not a service according to this law, BiH Telecom would have to mail special bills for the subscriptions, and the signing of the document would violate the present regulations," the enterprise said in a press release, adding that the public telecommunications service operator license states that termination of services must be limited to service that has not been paid for. "Hence, the request for termination of telephony services in case of failure to pay broadcasting subscriptions cannot be met by BiH Telecom," said the enterprise, adding that this model of collection of broadcasting subscriptions, if accepted by BiH Telecom, would greatly reduce its incomes. "Besides, the necessary software changes, given their complexity, would be too expensive, and any mistakes would result in long-term negative consequences," BiH Telecom said.
