

Pursuant to Article 17 of the Law on Council of Ministers of Bosnia and Herzegovina (“Official Gazette of Bosnia and Herzegovina”, nos. 30/03, 42/03, 81/06, 76/07, 81/07, 94/07 and 24/08), the Council of Ministers of Bosnia and Herzegovina, at its 83<sup>rd</sup> session, held on 9<sup>th</sup> April 2009, enacted the following

**DECISION**  
**ESTABLISHING THE WORKING GROUP FOR PROPERTY INVENTORY**

**Article 1**  
**(Scope of the Decision)**

- (1) This Decision establishes the Working Group tasked to make the inventory of property.
- (2) Property subject to this inventory shall include the property referred to in Article 2 of the Decision on Establishing the Commission for State Property, for the Identification and Distribution of State Property, the Specification of Rights and Obligations of Bosnia and Herzegovina, the Entities and the Brčko District of Bosnia and Herzegovina in the Management of State Property (Official Gazette of BiH”, No. 10/05).

**Article 2**  
**(Composition of the Working Group)**

- (1) The Working Group shall comprise representatives of the following institutions:
  - a) The Ministry of Finance and Treasury of Bosnia and Herzegovina – two representatives;
  - b) The Ministry of Justice of Bosnia and Herzegovina – two representatives;
  - c) The Office of the Attorney General of Bosnia and Herzegovina – two representatives;
  - d) The Government of the Republika Srpska – three representatives;
  - e) The Government of the Federation of Bosnia and Herzegovina – three representatives;
  - f) The Government of Brčko District – one representative.
- (2) Representatives of the institutions referred to in paragraph (1) of this Article shall be appointed by no later than 30 April 2009.
- (3) The General Secretariat of the Council of Ministers shall provide the Working Group with all required technical and administrative support.

**Article 3**  
**(Time limit for completion of the task)**

The Working Group shall complete the task referred to in Article 1 of this Decision by 30 September 2009, but not later than within six (6) months following the entry into force of this Decision.

**Article 4**  
**(Decision-making)**

The Working Group shall take its decisions by consensus.

**Article 5**  
**(Relationship between the property inventory and apportionment)**

The property inventory shall in no way prejudice the matter of property apportionment among Bosnia and Herzegovina, the entities and other levels of government in Bosnia and Herzegovina.

**Article 6**  
**(Entry into force)**

This Decision shall enter into force on the day of its enactment and shall be published in the "Official Gazette of Bosnia and Herzegovina".
