**HOUSE OF PEOPLES OF THE PARLIAMENTARY ASSEMBLY

Pursuant to Article IV/3.b) and d) of the Constitution of Bosnia and Herzegovina and Article 174 of the Rules of Procedure of the House of Peoples of the Parliamentary Assembly of Bosnia and Herzegovina (“Official Gazette of BiH”, Nos. 58/14, 88/15, 96/15 & 53/16), during its continued 16th session held on 17 July 2025, the House of Peoples of the Parliamentary Assembly of Bosnia and Herzegovina adopted the following

**AMENDMENT TO THE RULES OF PROCEDURE OF THE HOUSE OF
PEOPLES OF THE PARLIAMENTARY ASSEMBLY OF BOSNIA AND
HERZEGOVINA**

Article 1

In the Rules of Procedure of the House of Peoples of the Parliamentary Assembly of Bosnia and Herzegovina (“Official Gazette of BiH”, Nos. 58/14, 88/15, 96/15, 53/16 & 71/24), in Article 51, under paragraph (1), in point f), after the words: “reconstruction and”, the word “sustainable” shall be added, and after the words: “of BiH”, the semicolon shall be replaced by a comma and the following wording shall be added: “including the following:”.

Under point f) the following indents shall be added to read:

- “1) implementation of documents contributing to the achievement of sustainable development and the fulfilment of international obligations in the field of sustainable development in Bosnia and Herzegovina;
- 2) planning the financing of development priorities defined in the strategic documents of Bosnia and Herzegovina, which contribute to the achievement of sustainable development in Bosnia and Herzegovina;
- 3) relations with bodies responsible for monitoring the implementation of sustainable development in Bosnia and Herzegovina;
- 4) alignment of the strategic documents of Bosnia and Herzegovina with documents contributing to the achievement of sustainable development in Bosnia and Herzegovina, and the analysis of their implementation;
- 5) implementation of documents related to the achievement of sustainable development and the fulfilment of international obligations in the field of sustainable development in Bosnia and Herzegovina.”

In paragraph (2), after the words: “reconstruction and”, the word: “sustainable” shall be added.

Article 2

This amendment to the Rules of Procedure of the House of Peoples of the Parliamentary Assembly of Bosnia and Herzegovina shall enter into force on the day following the date of its publication in the “Official Gazette of BiH”.
