Pursuant to Article IV.3.b) and d) of the Constitution of Bosnia and Herzegovina, in connection with Article 174 of the Rules of Procedure of the House of Peoples of the Parliamentary Assembly of Bosnia and Herzegovina (Official Gazette of BiH, 58/14, 88/15, 96/15 and 53/16), the House of Peoples of the Parliamentary Assembly of Bosnia and Herzegovina, at its sixth emergency session, held on 10 October 2024, enacted the following

**AMENDMENT TO THE RULES OF PROCEDURE OF THE HOUSE OF
PEOPLES OF THE PARLIAMENTARY ASSEMBLY OF BOSNIA AND
HERZEGOVINA**

**Article 1
(Scope)**

In the Rules of Procedure of the House of Peoples of the Parliamentary Assembly of Bosnia and Herzegovina (Official Gazette of BiH, 58/14, 88/15, 96/15 and 53/16), in Article 53 (Joint Committee for Administrative Affairs), paragraph (1), after point k), the punctuation mark full stop shall be replaced with the punctuation mark semicolon, followed by a new point l) which shall read as follows:

"l) in accordance with the Law, conduct the procedure of selecting seven members of the Committee on Deciding on the Conflict of Interests in the institutions at the level of Bosnia and Herzegovina."

**Article 2
(Entry into Force)**

This Amendment to the Rules of Procedure of the House of Peoples of the Parliamentary Assembly of Bosnia and Herzegovina shall enter into effect on the next day following the day of its publication in the Official Gazette of BiH.
